## INDEPENDENT AUDITORS' REPORT

**NOTE 1 – DESCRIPTION OF THE PLAN**

---

The following description of the 401(k) Plan for Employees of Revere Copper Products, Inc. (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**General**

Revere Copper Products, Inc. (“the Sponsor”, “the Employer”, or “the Company”) established the 401(k) Plan for Salaried Employees of Revere Copper Products, Inc., which covered all salaried employees, on January 1, 1988.

The Sponsor established the 401(k) Plan for Hourly Employees of the Rome Division of Revere Copper Products, Inc., which covered all union employees, on March 1, 1991.

Effective November 1, 2013, all assets held by the 401(k) Plan for Hourly Employees of the Rome Division of Revere Copper Products, Inc. were transferred into the 401(k) Plan for Salaried Employees of Revere Copper Products, Inc. At that time, the 401(k) Plan for Salaried Employees of Revere Copper Products, Inc. was renamed the 401(k) Plan for Employees of Revere Copper Products, Inc. (“the Plan”). The terms in effect specifically for union (“hourly”) employees and the terms in effect specifically for non-union (“salaried”) employees as of the date of transfer remained in effect subsequent to the date of transfer.

During 2022, Revere South, Inc. (RSI) was formed for the manufacture of copper bar products in North Carolina. RSI is a wholly-owned subsidiary of Revere Copper Products, Inc. Production at RSI commenced January 2023. Effective December 27, 2022, the Plan was amended to add Revere South, Inc. as a participating employer.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for the oversight of the Plan. Plan management determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

**Eligibility**

Non-Union Employees

Effective April 1, 2022, eligible non-union employees are automatically enrolled in the Plan following their date of hire. Prior to April 1, 2022, non-union employees were eligible to enroll in the Plan as of the first day of the month immediately following or coincident with completion of one month of service, as defined.

At the time of automatic enrollment, 3% of eligible compensation is deferred into the Plan. The deferral rate for automatically-enrolled participants automatically increases by 1% each year, not to exceed 10%.

Union Employees

Effective April 1, 2022, eligible union employees are automatically enrolled in the Plan following their date of hire. Prior to April 1, 2022, eligible union employees were automatically enrolled in the Plan on the first day of the month immediately following or coincident with completion of one month of service, as defined.

At the time of automatic enrollment, 3% of eligible compensation is deferred into the Plan. The deferral rate for automatically-enrolled participants automatically increases by 1% each year, not to exceed 10%. Due to the transfer of assets from the 401(k) Plan for Hourly Employees of the Rome Division of Revere Copper Products, Inc. and its termination, union employees hired as of November 1, 2013 were automatically-enrolled in the Plan on November 1, 2013.

**Employer Contributions**

Non-Union Employees

Under the Plan, the Sponsor will contribute 50% of each eligible non-union employee's contribution to the Plan, up to a maximum of 6% of compensation.

Union Employees

Under the Plan, the Sponsor will contribute 50% of each eligible union employee's contribution to the Plan, up to 8% of compensation.

Discretionary profit-sharing contributions may be made at the option of the Sponsor to eligible participants and are subject to certain limitations. For the years ended December 31, 2024 and 2023, discretionary employer contributions awarded for the Plan year were \$408,480 and \$351,017, respectively.

**Participant Contributions**

All participants are permitted to make both pre-tax and after-tax (Roth) contributions to the Plan. Prior to June 1, 2013, participants were not permitted to make after-tax Roth contributions to the Plan.

Participants may contribute between 1% and 60% of their compensation, as defined, up to the annual statutory limit. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common/collective trust fund as investment options for participants.

**Participants Accounts**

Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company's profit sharing contributions and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant accounts are invested, as directed by the participant, in one or more of the investment categories offered by Fidelity Management Trust Company.

If a participant's employment changes, for example from union employment to non-union employment, then the payroll category of a participant's account (union or non-union) is changed and the applicable provisions of the Plan will apply.

**Vesting**

Participants' basic contributions, as defined by the Plan, and any investment earnings thereon are immediately vested.

Non-Union

Sponsor contributions for non-union employees and any investment earnings thereon are immediately 100% vested.

Union

Sponsor contributions for union employees and any investment earnings thereon become 100% vested after three years of service.

**Notes Receivable from Participants**

Eligible participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Terms of the notes may not exceed five years, except for the purchase of a primary residence, in which case the term may be for a period of up to ten years. The loan interest rate is set at 1% above the prime rate at the time of issuance. The interest rates remain fixed throughout the duration of the loans. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of service a participant may immediately receive a lump-sum amount equal to the vested value of his or her account balance or if the participant's balance exceeds \$5,000, the participant may elect to defer distribution until a later date as defined by the Plan. Hardship withdrawals from the Plan are permitted and subject to certain limitations imposed by the Internal Revenue Service as specified in the Plan Document. Participants who have attained age 59-1/2 may also be eligible for in-service distributions.

**Forfeitures**

If employees' participation in the Plan is terminated prior to being 100% vested in employer matching and discretionary profit sharing contributions and the actual earnings thereon, then the non-vested portion is forfeited in the year of distribution of the vested balance. Forfeitures are retained in the Plan and may be used to pay administration expenses or to reduce future employer contributions under the Plan. For the years ended December 31, 2024 and 2023, there were no forfeitures used to offset Plan expenses or reduce employer contributions under the Plan. At December 31, 2024 and 2023, forfeitures available for future offset were \$16,458 and \$15,428, respectively.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

---

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefit payments are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. The Company incurred administrative expenses of approximately \$27,000 and \$26,100 for the years ending December 31, 2024 and 2023, respectively. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Reclassifications**

Certain 2023 amounts have been reclassified to conform with the 2024 presentation. These reclassifications had no impact on the total assets, liabilities, net assets available for benefits or changes in net assets available for benefits.

**Subsequent Events**

Management has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Money Market Fund:*** Valued at the net asset value, based on quoted market prices in active markets, of shares held by the Plan at year-end.

***Mutual Funds:*** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

***Common/Collective Trusts:*** Valued at the net asset value, based on the fair values of the underlying investments reported by the trustee of the funds. Fair values for the underlying assets were based on either quoted prices in active markets or observable inputs or quotations from inactive markets.

**NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST  
TRANSACTIONS**

---

Certain Plan investments are shares of mutual funds and common collective trusts managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fidelity Management Trust Company provides certain administrative services to the Plan pursuant to the service agreement between the Company and Fidelity Management Trust Company. Fidelity Management Trust Company receives revenue from mutual fund service providers for services Fidelity Management Trust Company provides to the funds. This revenue is used to offset certain amounts owed to Fidelity Management Trust Company for its administrative services to the Plan.

Revenue sharing credits are recognized as offsets to administrative expenses when applied. If revenue sharing credits exceed the administrative expenses incurred by the Plan during the year, the excess is recorded as other income in the accompanying statements of changes in net assets available for benefits.

During the years ended December 31, 2024 and 2023, the Plan incurred administrative expenses amounting to \$69,355 and \$62,138, respectively. The Plan received revenue sharing credits of \$67,508 and \$52,805 during 2024 and 2023 respectively, that was applied against administrative expenses.

Transactions involving notes receivable from participants also qualify as party-in-interest transactions. As described in Note 2, the Company or the Plan paid certain expenses related to Plan operation and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA and are exempt from the prohibitive transaction rules.

**NOTE 6 – PLAN TERMINATION**

---

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

**NOTE 7 – TAX STATUS**

---

The Internal Revenue Service (IRS) has determined and informed the Sponsor, through a volume submitter plan opinion letter dated June 30, 2020, that the volume submitter plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – RISKS AND UNCERTAINTIES**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
