To the Board of Trustees of the

Consumer Reports Pension Fund

Opinion

We have audited the financial statements of the NewsGuild of New York - Consumer Reports Pension Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (in liquidation) as of December 31, 2024 and 2023, and the changes in its net assets available for benefits (in liquidation) for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits (in liquidation) of the Plan as of December 31, 2024 and 2023, and the statement of net assets available for benefits (in liquidation) for the years then ended, and the related notes to the financial statements.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the NewsGuild of New York - Consumer Reports Pension Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. The supplemental Schedule of Reportable Transactions and Schedules of Administrative Expenses, together referred to as “supplemental information,” are presented for the purpose of additional analysis and are not a required part of the financial statements. The supplemental Schedule of Reportable Transactions is supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Supplemental information is the responsibility of the Plan's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of the NewsGuild of New York - Consumer Reports Pension Fund (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description for a more complete description of the Plans' provisions.

General - The Plan is a noncontributory single employer defined benefit pension plan established under the provisions of an Agreement and Declaration of Trust, between the NewsGuild of New York, Local 3, TNG, AFL-CIO ("Union") and Consumers Union of United States, Inc. ("Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for the oversight of the Plan, including determining the appropriateness of the Plan's investments in coordination with their investment advisers.

Effective June 28, 2016, the Plan changed its name from Newspaper Guild of New York - Consumers Union of United States, Inc. Pension Plan to NewsGuild of New York - Consumer Reports Pension Fund.

Pension Benefits - The Plan provides normal, late, and early retirement, and disability retirement pension benefits. All persons on whose behalf the Employer is contributing into the Plan and who otherwise qualify, as defined in the Plan agreement, are eligible for benefits. Benefits are payable in the form of a life annuity, joint and survivor annuity, certain and life option, and lump sum option. Participants' benefits are vested after five years of credited service.

On May 17, 2013, the Board of Trustees adopted an amendment to the Plan, effective May 31, 2013, providing for the freeze of benefit accruals under the Plan and eligibility for participation in the Plan. Benefit accruals under the Plan were frozen as of May 31, 2013 and will be unaffected by changes in future compensation or continued service with the Employer. No new participants will be admitted to the Plan after May 31, 2013.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The accompanying financial statements are prepared using the liquidation basis of accounting.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investments and Income Recognition - Investments in mutual funds are carried at fair value which generally represents quoted market prices or net asset value of the fund as of the last business day of the year as provided by the custodian. Common collective trusts are valued at their market value on the last business day of the year as established by the trusts. Short-term investments are valued at cost, which approximates fair value.

Purchases and sales are recorded on the trade date basis. Interest and dividends are recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Employer Contributions - Employer contributions are accounted for as exchange transactions. Employer contributions due and not paid at year end are recorded as contributions receivable. The Plan believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Actuarial Present Value of Accrued Vested Benefits - Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service which employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

NOTE 3. FUNDING

The Plan is funded by employer contributions. Annual amounts are developed by the Plan's actuary and approved by the plan sponsor.

NOTE 4. TERMINATION

During the year ended December 31, 2023, the Plan was terminated in accordance with the provisions of applicable federal law, the relevant provisions of the Agreement and Declaration of Trust. Termination shall not permit any part of the Plan assets to be used for or diverted to purposes other than the exclusive benefit of the pensioners, beneficiaries and participants. The net assets of the Plan will be allocated to pay benefits in priorities as prescribed by ERISA and its related regulations.

NOTE 4. TERMINATION (continued)

Effective August 31, 2023, each Participant's vested accrued benefit shall be paid the actuarial equivalent of his or her accrual benefit under an annuity contract purchased by the Plan from an insurance company selected by the Trustees in their sole discretion that provides for the payment or continued payment of such participant's benefits in the distribution form selected by the Participant. Participants in pay status, may elect to receive his or her remaining benefit in the form of a 100% lump sum calculated in accordance with the Plan, except that, in the case of a married Participants, such married Participants may elect (instead of a lump sum) a Standard Retirement Annuity that pays a 50% or 75% survivor annuity to such Participant's surviving Spouse, calculated using the Actuarial Equivalent assumptions.

The Trustees of the Plan notified the Pension Benefit Guaranty Corporation (PBGC) that the Plan had filed Standard Termination. Based on actuarial calculations, the Trustees believe that the existing level of Plan assets is sufficient to maintain the existing level of benefits under the Plan.

NOTE 5. TAX STATUS

The Plan obtained its latest determination letter on November 3, 2015 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 401(a) and was, therefore, exempt from Federal income taxes under the provisions of Section 501(a). The plan has been amended since receiving the determination letter. However, the Plan Trustees and Plan Counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subjected to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

NOTE 6. ACTUARIAL INFORMATION

Actuarial valuations of the Plan were made by a consulting actuary as of January 1, 2023. Information shown in these reports included the following:

As of January 1, 2023, the net investment return discount rate assumption was increased from 4.65% to 5.00% to better reflect current market conditions. The Lump Sum conversion rate assumption was increased from 3.55% to 4.15% to reflect market conditions as of the valuation date. The segment interest rates for Minimum Funding, Lump Sum Conversion and PBGC purposes were updated to comply with appropriate guidance. The Plan Sponsor revoked the election to use the Alternative Method for PBGC variable rate premium purposes. Effective with 2023, the PBGC vested Funding Target is based on the Standard Method. The Lump Sum conversion mortality table was changed from the static 2022 417(e) applicable mortality table to the static 2023 417(e) applicable mortality table.

The above actuarial assumptions were based on the assumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining actuarial results. Pension benefits in excess of the present assets of the Plan are dependent upon contributions received under collective bargaining agreements with the employer and income from investments.

NOTE 6. ACTUARIAL INFORMATION (continued)

The January 1, 2023 actuarial valuation is based on assumptions and methods appropriate for an ongoing plan, however, effective August 31, 2023, the Plan terminated in accordance with the provisions of applicable federal law, the relevant provisions of the Agreement and Declaration of Trust.

Since information on the actuarial present value of accumulated plan benefits as of December 31, 2023 and the changes therein for the year then ended are not included above, these financial statements do not purport to present a complete presentation of the financial status of the Plan as of December 31, 2023, and the changes in the financial status for the year then ended, but a presentation of the net assets available for benefits and the changes therein as of and for the year ended December 31, 2023. The complete financial status is presented as of December 31, 2022.

The Plan's actuary has advised that the minimum funding requirements of ERISA are currently being met as of January 1, 2023.

As of January 1, 2023, the Plan is in neither critical status nor endangered status under the Pension Protection Act of 2006.

NOTE 7. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 7. FAIR VALUE MEASUREMENTS (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at net asset value (NAV). There have been no changes in the methodologies used at December 31, 2023.

Common collective trust: Valued at net asset value (NAV) of units held, without adjustment by the Plan. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

For the year ended December 31, 2023, there were no transfers in or out of Levels 1, 2 or 3.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, sector and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

The actuarial present value of accumulated plan benefits is reported based on certain assumptions pertaining to interest rates, inflation rates and participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 9. CONCENTRATION OF CREDIT RISK

The Plan places its cash with institutions deemed to be creditworthy. The balance is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. Cash balances may at times exceed the insured deposit limits.

The Plan's investment in Schroders Value Long Duration Trust represented 35% of the Plans Net Assets Available for Benefits for the years ended December 31, 2023. The Plan's investment in Schroder Core Bond Fund represented 28% of the Plans Net Assets Available for Benefits for the years ended December 31, 2023.

NOTE 10. RETURN OF EXCESS FUNDING

During the year ended December 31, 2024, the Trustees of the Plan approved the withdrawal of the Plan's investment in the ASB Allegiance Real Estate Fund and the redemption of the Plan's units with a redemption in kind of Units of ASB Allegiance Real Estate Fund, LP, transferring the investment to Consumer Reports, Inc. (the Plan Sponsor). The value of the investment transferred to the Plan Sponsor during the year ended was \$2,411,176.

NOTE 11. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
