**Note 1 - Plan Description**

The following description of Sterling-Rice Group, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering eligible employees of Sterling-Rice Group, Inc. (the "Company") who are age 21 or older. The Plan is not available to interns or other temporary employees whose regularly scheduled service is less than 1,000 hours unless such employee completes a year of service, at which time the employee is no longer excluded from participating in the Plan. The entry date for eligible participants is the date in which eligibility criteria are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The board of directors of Sterling-Rice Group, Inc. administers the Plan. Newport Trust Company served as trustee of the Plan through November 13, 2024. Ascensus, LLC, on behalf of Newport Trust Company, LLC, serves as trustee, effective November 14, 2024, and maintains the Plan's records. Individual accounts are invested in the various investment options at the direction of the participants.

***Contributions***

Participants may make before-tax or after-tax Roth contributions up to the maximum established by the Internal Revenue Service (IRS), which is adjusted annually by the secretary of the Treasury for inflation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Employee contributions to the Plan are made through payroll deductions.

Certain participant contributions in 2024 were paid after the time frame required by the Department of Labor. The Company remitted these contributions during 2024 and remitted certain related lost earnings to the Plan in 2024. The remaining lost earnings were remitted to the Plan in August 2025.

The Company may make annual discretionary contributions. To the extent a profit-sharing contribution is made, a participant's profit-sharing contribution is computed based on his or her percentage of eligible compensation to that of all participants' eligible compensation sharing in such contribution. During the year ended December 31, 2024, all participants received a profit-sharing contribution equal to 2 percent of their eligible compensation.

***Participant Accounts***

Each participant's account is credited or charged with the participant's contributions and an allocation of the Company's contributions, plan earnings or losses, and plan expenses. Allocations are based on plan earnings or losses and account balances, as defined. The benefit to which a participant is entitled is the vested portion of the participant's account.

***Vesting***

Participants are immediately 100 percent vested in their voluntary salary deferral contributions, profit-sharing contributions, rollover contributions, and allocated earnings or losses thereon.

**Note 1 - Plan Description (Continued)**

***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the participants' highest outstanding loan balance during the prior 12-month period, or 50 percent of their vested account balances. The term of the note is generally five years, with a longer repayment term allowed if the note is used in conjunction with the purchase of a primary residence. Notes bear interest at a rate commensurate with local prevailing rates at origination determined by the plan administrator. For notes outstanding as of December 31, 2024, the interest rate is 6.50 percent, with a maturity date of October 2027. Principal and interest are paid ratably through payroll deductions. Participant notes receivable are recorded in the financial statements at amortized cost plus accrued interest and are collateralized by the vested balance in the participant's account.

***Payment of Benefits***

On termination of service, death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested balance in his or her account or a partial withdrawal. Installment distributions are only permitted for required minimum distributions. Participants are allowed in-service distributions after attaining the age of 59½. The Plan also permits for in-plan Roth rollover contributions and in-plan Roth rollover transfers for participants who are employees. The Plan allows for terminated participant account balances of \$5,000 or less to be automatically rolled out of the Plan into an individual retirement account.

The plan administrator must approve any hardship withdrawals. Participants who are granted a hardship withdrawal are allowed only one hardship distribution per year. The IRS has required minimum distributions once a participant reaches age 73 during the previous plan year and is no longer employed by the Company.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

***Related Party and Party-in-interest Transactions***

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

**Note 2 - Summary of Significant Accounting Policies**

***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Risks, Uncertainties, and Concentrations***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Additionally, some investments are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments.

***Valuation of Investments and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

The Company provides, at no cost to the Plan, certain administrative, accounting, and legal services to the Plan and also pays the cost of certain outside services for the Plan.

***Subsequent Events***

The plan administrator has evaluated all subsequent events up through and including September 17, 2025, which is the date the financial statements were available to be issued.

In April 2025, the Plan was amended and restated. As a result of the amendment, nonresident aliens are no longer eligible to participate in the Plan and certain regulatory updates are reflected in the Plan's provisions.

**Note 3 - Certified Information**

Newport Trust Company holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Ascensus LLC, on behalf of Newport Trust Company, LLC (the "Trustee").

**Note 4 - Fair Value Accounting**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Note 4 - Fair Value Accounting (Continued)**

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Inputs to the valuation methodology include quoted prices for similar assets in active markets and inputs that are observable for the asset, either directly or indirectly, for substantially the full term of the financial instrument.

**Level 3**

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
