Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. 1. Plan Description

The following description of Nosler, Inc. 401(k) Salary Reduction Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan was established to provide a retirement savings program for the employees of Nosler, Inc. and ADC, Inc. (the “Company” or “employer”). The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (“ERISA”). The Company is the plan administrator; accordingly, certain members of its management have been appointed to be responsible for overseeing the Plan’s operations including determining the appropriateness of the Plan’s investment offerings and monitoring investment performance. Fidelity Management Trust Company (“Fidelity”) is the Plan’s trustee and recordkeeper.

Eligibility

All employees who have reached the age of 18 and completed two months of service are eligible to participate in the elective deferral portion of the Plan. Upon satisfaction of the respective eligibility requirements for the elective deferral portion of the Plan, participants may enter the Plan on the first day of the next calendar month. Employees who have reached age 18 and completed one year of service are eligible to receive discretionary employer matching contributions. Employees who have reached age 18 and completed one year of service, with a minimum of 1,000 hours, are eligible to receive discretionary employer profit sharing (nonelective) contributions if also employed by the Company as of the last day of the Plan Year. Upon satisfaction of the respective eligibility requirements with respect to employer contributions, participants may enter the Plan on the first day of the next calendar quarter.

Contributions

Each year, participants may contribute a portion of their compensation to the Plan as defined in the plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also permits after-tax elective deferrals (“Roth Elective Deferrals”). Participants may contribute amounts representing distributions from certain other qualified plans. Under the terms of the plan document, the employer is permitted to make matching contributions and may also make discretionary profit sharing (nonelective) contributions to the Plan. For the year ended December 31, 2024, the employer made discretionary matching contributions equal to 50 percent of the first 6 percent of eligible employee contributions. Participants direct the investment of all contributions credited to their accounts into the various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, employer matching and profit sharing (nonelective) contributions, and allocations of plan earnings and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service as defined by the plan document. A participant is 100 percent vested after six years of service with the Company. Participant accounts become fully vested upon the participant’s death or

disability, as defined by the plan document, or upon attaining retirement age, as defined in the plan document, while still employed by the Company.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance reduced by the highest outstanding loan balance in their account during the prior twelve-month period. Participants are permitted to have only two outstanding loans simultaneously. Participant loans are collateralized by the balance in the respective participant's account. Each loan's interest rate is determined by management at the issuance date based on prevailing rates for similar instruments and remains fixed throughout the duration of the note. Interest paid by a participant is credited to the participant's individual account. Principal and interest are paid ratably through monthly payroll deductions with payment terms up to five years for general purpose loans or thirty years if the loan is used to acquire a principal residence.

Payment of Benefits

On termination of service due to death, disability, resignation, discharge, retirement or proven hardship, a participant is eligible to receive payments in the amount equal to the value of the participant's vested interest in his or her account. Hardship withdrawals are only permitted from the employee deferrals portion of participant accounts. Participants with money purchase pension assets may elect to receive a qualified joint and survivor annuity. For all other participants, the normal form of payment under the Plan is a lump sum distribution.

Forfeited Accounts

If a participant terminates employment with the Company before becoming fully vested, the unvested portion of his or her account is forfeited. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,163 and \$5,480, respectively. Forfeitures may be used to pay administrative expenses or to offset future employer contributions. During the year ended December 31, 2024, employer contributions were reduced by \$49,829 from forfeited nonvested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers, trustees, and investment custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a corresponding benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1. Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. Fair values are provided by the trustee for all of the Plan's assets as follows:

- Registered investment companies, including money market accounts and other mutual funds, are valued at the daily closing price as reported by the fund. Registered investment company investments held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Common/collective trust investments are valued by the respective fund's manager as of the close of trading each business day. The net asset value per unit is computed by dividing the total value of the assets of the fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the portfolio and included in the determination of unit values. Unit purchases and redemptions initiated by participants are transacted at the net asset value per unit for each fee class of the fund and are valued at the transaction date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Common/Collective Trust Investments

Investments in common/collective trusts include investments in the Putnam Stable Value Fund. The Putnam Stable Value Fund achieved a weighted average market value yield of 4.38 percent with a weighted average crediting rate of 3.96 percent for the year ended December 31, 2024. The Putnam Stable Value Fund invests in stable value instruments, and in certain other fixed income or money market obligations or in a variety of collective investment vehicles which invest in such obligations. A stable value instrument is a fixed income obligation, the rate of return of which is guaranteed by the issuing insurance company, bank, savings and loan or other financial institution; or a debt instrument or portfolio of debt instruments owned by the Putnam Stable Value Fund combined with a fully benefit responsive contract wrapper issued by an insurance company, bank, savings and loan or other financial institution. Investments in the Putnam Stable Value Fund are subject to various risks including, but not limited to, the credit risk of the issuers of the underlying investment contracts, interest rate risk affecting the crediting rates of contracts, liquidity risk in the event of significant participant withdrawals, and counterparty risk with wrap providers.

Withdrawals for benefit payments are executed as requested on any business day except for exchanges directly to competing investment options. Withdrawals for participant transfers to competing investment options subject to a 90-day restriction. Were the Plan to initiate a full redemption of the collective trust, the investment adviser may reserve the right to temporarily delay withdrawal from the trust under certain conditions.

6. Related Party and Party-In-Interest Transactions

Certain of the Plan's investments are shares of mutual funds managed by affiliates of Fidelity Fiduciary Trust Company. Fidelity serves as the Plan's trustee and recordkeeper. Accordingly, transactions with the Fidelity, or its affiliates, qualify as party-in-interest transactions. Fees incurred by the Plan for certain investment management services are included in net appreciation in fair value of the investment, as they are paid at the investment fund level, rather through direct payments by the Plan. Certain investment advisor fees are paid directly by the Plan. During the year ended December 31, 2024, the Plan made direct payments totaling \$71,009 to the Plan's investment advisor and Fidelity, or its respective affiliates, consisting primarily of investment management, loan origination, and record keeping fees. The Company pays directly certain other fees related to the Plan's operations.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of

ERISA. In the event of plan termination, participants would become 100 percent vested in the employer contributions portion of their accounts.

8. Plan Tax Status

The Plan has adopted a volume submitter agreement as the plan document. The volume submitter agreement obtained its latest opinion letter, dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Delinquent Participant Contributions and Loan Payments

As reported on the supplemental schedule of (II) Schedule H, Line 4a - Schedule of Delinquent Participant Contributions, certain employee contributions and loan payments were not remitted to the Plan within the timeframe specified by the Department of Labor, therefore constituting nonexempt transactions between the Plan and the Company for the years ended December 31, 2024 and 2023. The related lost earnings remittances, required under applicable regulations to correct the 2023 delinquent transactions, were remitted to the Plan during the year ended December 31, 2024. The related lost earnings remittances due under applicable regulations to correct the 2024 delinquent participant contributions and loan payments were pending payment as of December 31, 2024.
