Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Grande Ronde Hospital Employees' Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section —

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the financial statements referred to above related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

Notes to Financial Statements
Years Ended December 31, 2024 and 2023

1. Description of Plan:

The following description of Grande Ronde Hospital Employees' Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all employees of Grande Ronde Hospital, Inc. (the Hospital). The Plan is subject to the provisions of the ERISA.

Eligibility – Each plan year, employees of the Hospital who have reached 21 years of age are eligible to participate in the Plan.

Contributions – Participants make voluntary tax-deferred and Roth contributions to the Plan through payroll deductions of up to the Internal Revenue Service (IRS) maximum contribution. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Hospital then contributes a base amount equal to 2 percent of the participant's compensation for employees with fewer than 10 years of service, increasing to 3 percent after 10 years of service. Additionally, the Hospital will match 100 percent of the participant's salary reduction election up to 3 percent of participant compensation. The match increases to 4 percent of participant compensation for employees with 10 or more years of service and 5 percent for employees with 20 or more years of service.

Investment options – Upon enrollment in the Plan, a participant may direct contributions into any of the funds offered by the Plan. Participants may change their investment options daily.

Participant accounts – Each participant's account is credited with the participant's contributions and allocations of (a) the Hospital's contributions, (b) the Plan's earnings or losses, and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting – Participants are immediately vested in their salary deferral contributions, plus actual earnings thereon. Vesting in the Hospital's nonelective contribution is based on year of service. Participants are 100 percent vested after three years of credited service as defined by a minimum of 1,000 hours worked per year.

Forfeited accounts – Terminated nonvested accounts are held for five years and are forfeited if the terminated employee does not return to employed status within that timeframe. Employee matching contributions forfeited are allocated to other participants of the Plan based on their current compensation at year end compared to the total compensation of all match participants in the Plan. Employer base contributions forfeited reduce employer contributions.

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$130,391 and \$198,943, respectively. During the Plan year ended December 31, 2024, \$199,526 of forfeitures were used to fund employer contributions.

1. Description of Plan (continued):

Benefit payments – Normal retirement under the Plan occurs at age 62. The Plan provides for retirement distributions to persons under age 62 if certain conditions are met as specified in the plan document. Participants, or their beneficiaries, are eligible to receive payment of benefits in the event of the participant's retirement, death, disability, or termination of the Plan. Benefits are distributed according to provisions set forth in the plan document. Participants' nonforfeitable account balances less than \$5,000 shall be distributed in a lump-sum payment. If the vested amount exceeds \$5,000, participants may elect to (1) receive a lump-sum amount equal to the value of their vested interest, (2) leave the money in the Plan until they want to take a lump-sum amount, or (3) rollover to another qualified plan. Distributions may be made at the participant's election prior to termination upon attainment of early retirement age 59.5 or hardship as defined in the plan document.

Plan termination – The plan sponsor may terminate the Plan at any time at its sole discretion. Upon termination, no further contributions will be made to the Plan, and all amounts credited to participant accounts will become 100 percent vested. The plan sponsor will direct the distribution of accounts.

2. Summary of Significant Accounting Policies:

Basis of accounting – The financial statements have been prepared on the accrual basis of accounting in accordance with GAAP.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the plan sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Cash and cash equivalents – Cash and cash equivalents include investments in highly liquid investments with an original maturity of three months or less. Cash and cash equivalents are held in the trust account.

Investment valuation and income recognition – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits – Benefit payments to participants are recorded upon distribution.

Administrative expenses – Certain administrative expenses are paid by the plan sponsor as provided in the plan document.

Subsequent events – The plan sponsor has evaluated subsequent events through September 4, 2025, the date on which the financial statements were available to be issued.

3. Information Certified by the Plan Custodian:

Charles Schwab Bank, the custodian of the Plan, has supplied the plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental Schedule H, Line 4i - schedule of assets (held at end of year) as of December 31, 2024.

4. Fair Value of Investments:

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual funds and money market funds are reported at fair value based on the quoted market price of the fund, which represents the net asset value of the shares held by the Plan at year end.

Changes in fair value levels – The availability of observable market data is monitored to assess the appropriate classifications of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

5. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

The Plan has a concentration of investments in Fidelity 500 Index Fund, PIMCO Total Return Funds Institutional Class Fund, Vanguard Balanced Index Fund, and Vanguard Growth Index Institutional Fund. A change in the value of these funds could cause the value of the Plan's net assets available for benefits to change due to this concentration. In addition, as a result of funds being selected by participants, certain other funds may individually represent a concentration of greater than 10 percent of the Plan's investments at fair value in the statements of net assets available for benefits. Although these individual funds maintain a level of diversification by investing in multiple equity, debt, or other instruments, there may be a concentration of risk because the funds are invested at the direction of a single fund manager. At December 31, 2024 and 2023, Fidelity 500 Index Fund, PIMCO Total Return Funds Institutional Class Fund, Vanguard Balanced Index Fund, and Vanguard Growth Index Institutional Fund each represented greater than 10 percent of the Plan's investments, at fair value.

6. Plan Tax Status:

The Plan is placing reliance on an opinion letter dated March 25, 2016, received from the IRS, indicating that the Plan is qualified under Section 401 of the Internal Revenue Code and is, therefore, not subject to tax under current income tax law. Accordingly, no provisions for income taxes have been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of the liability or (asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related-party and Party-in-interest Transactions:

The Plan's advisory committee consists of employees of the plan sponsor and a member of the plan sponsor's Board of Trustees. There are no transactions between the parties other than contributions to the Plan, if eligible.

Certain plan investments are managed by Charles Schwab Bank. Charles Schwab Bank performs administrative services for the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Charles Schwab Bank amounted to \$17,566 for the year ended December 31, 2024.

The Plan relies on a third-party service provider, Northwest Plan Services, Inc., to process the Plan's investment transactions and to manage individual participant accounts of the Plan.

Northwest Plan Services, Inc., also prepares the IRS Form 5500.

The plan auditor performs the required annual audit of the Plan.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.
