INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Delafield Corporation 401(k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1. DESCRIPTION OF PLAN

The following brief description of the Delafield Corporation 401(k) Profit Sharing Plan & Trust (the “Plan”) is intended to give a general summary of its principal provisions. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a salary deferral plan which was established in 1997 to permit employees to make pre-tax savings contributions to the Plan; thereby providing employees with an opportunity to accumulate funds for their retirement.

Plan administration

Delafield Corporation (the “Employer”) is the plan sponsor and plan administrator. The plan administrator is responsible for carrying out the duties imposed under the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

Employees who have attained age eighteen become eligible for participation upon being employed and can commence contributing to the Plan on the first of the month following three months of employment.

Contributions

Under the terms of the Plan, all eligible employees, as defined in the Plan, may contribute from 0% per pay period to 100% of their annual compensation up to a maximum contribution of \$23,000 for the year ended December 31, 2024, which is subject to annual adjustment. In addition, participants who have attained age fifty before the Plan year close may make an additional contribution of \$7,500 in 2024, which is subject to annual adjustment.

The Plan has elected to include an automatic enrollment feature. The initial automatic deferral amount (3%) shall increase by 1% of compensation per year up to a maximum of 8%.

Each year, the Employer may make matching contributions equal to a discretionary percentage, to be determined by the Company, of the participant’s salary reduction contributions. For the Plan year ended December 31, 2024, the Company made matching contributions of 25% of the first 6% of salary reduction contributions.

In addition, the Company can make a discretionary Employer profit sharing contribution. No discretionary Employer profit sharing contributions were made for the Plan years ended December 31, 2024 and 2023.

NOTE 1. DESCRIPTION OF PLAN (Continued)

Investment options

Upon enrollment in the Plan, a participant may direct employee and Employer contributions as desired, in any of a variety of options held by Principal Trust Company, as chosen by the Employer. Participants may change their investment options daily.

Participant accounts

Each participant's account is credited with the participant's contribution, employee rollovers, Employer discretionary matching and profit-sharing contributions (if applicable), and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their salary deferral contributions and actual earnings. However, vesting of the Employer matching and Employer profit sharing contribution portions of participant accounts, plus actual earnings thereon, is based upon the participant's years of service the Employer as follows:

Any amounts of Employer contribution forfeited by an employee terminating from the Plan before becoming 100% vested are allocated to the individual accounts of qualifying participants.

Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Participant forfeitures

Forfeited accounts can be used to reduce Plan administrative expenses and the remainder to reduce employer contributions. As of December 31, 2024, outstanding forfeitures available totaled \$4,450. Furthermore, for the year ended December 31, 2024 and 2023, \$0 and \$0 was utilized to reduce employer contributions, respectively. See Note 1 - Contributions.

Notes receivable from participants

Participants may borrow a minimum of \$1,000 up to a maximum of 50% of their vested account balance not to exceed \$50,000. Promissory notes must be signed by the participant and are secured by all accounts of the participant. Loans bear interest at a rate reasonable at the time of application and are payable on or before the earlier of the participant's termination or within five years (ten years if the loan is used to acquire a principal residence). Only one loan can be outstanding at any time and only two loans may be granted during a twelve-month period.

Benefit payments

Upon termination of service, participants are entitled to receive their vested account balances. Upon normal retirement age, or in the event of permanent disability or death while employed by the Employer, a participant or a participant's beneficiary is entitled to the total value of the participant's account balance. In-service withdrawals are permitted if certain criteria are met. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the plan administrator will authorize the benefit payment without the participant's consent.

Plan termination

While the Employer has not expressed any intent to do so, the Employer reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, all interests of participants become fully vested, and the assets are distributed to the participants of the Plan in accordance with the provisions of the Plan.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Plan administration

Delafield Corporation is the plan sponsor and plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. Excess contributions payable as of December 31, 2024 and 2023 totaled \$7,802 and \$20,229, respectively.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

NOTE 3. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company dba Principal Trust Company (the trustee of the Plan).

NOTE 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at quoted net asset value ("NAV") of shares held by the Plan at year end. These funds are required to publish their daily net asset value and transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market.

Collective investment trust: The Principal Stable Fund (the “Fund”) is 100% invested in the Morley Stable Value Fund. The Morley Stable Value Fund invests in conventional, synthetic and separate account investment contracts (collectively “contracts”) issued by life insurance companies, banks and other financial institutions. Characteristics of these contracts allow for their principal value to remain stable regardless of the volatility of the financial markets. For liquidity purposes, the Morley Stable Value Fund may have a portion of its assets invested in high quality money market instruments, investment companies and collective investment trusts. The investment in the Morley Stable Value Fund is valued at its NAV per unit (i.e. contract value) of the valuation date. The Fund uses this NAV per unit as a practical expedient and represents the proportionate share of the NAV of the Morley Stable Value Fund. The Fund records investment transactions on a trade date basis. Withdrawals from the Fund for benefit payments are paid to plan participants within thirty-days after written notification has been received. The Fund’s interests in the Morley Stable Value Fund may be redeemed as of any valuation date. The investment in Morley Stable Value Fund is excluded from the fair value hierarchy. As of December 31, 2024, plan management believes the occurrence of an event that would limit the ability of Fund to transact at contract value with its unitholders is not probable.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The trustee is party-in-interest with respect to the Plan. All investments are held with the trustee. Notes receivable from Plan participants and the related interest income are also considered party-in-interest transactions. As described in Note 2, the Plan made direct payments to the third-party administrator totaling \$58,529. The Company pays directly any other fees related to the Plan's operations.

The plan administrator authorized the plan's trustee to establish a Service Provider Payment Agreement ("SPPA"). The SPPA is funded by the trustee's shared revenues from certain investments and is netted against earnings. At the direction of the Employer, these funds may be used to pay reasonable expenses. Shared revenue was \$0 for the year ended December 31, 2024.

NOTE 6. TAX STATUS

The Employer adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (pre-approved plan) which received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the prototype plan is acceptable under section 401 of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter. However, the plan administrator and the plan's advisors believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Administration errors, if any, that are insignificant or operational in nature are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan invests in funds which invest in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

NOTE 9. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.
