We have performed audits of the financial statements of John Henry Foster Company of St. Louis, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTES TO FINANCIAL STATEMENTS
December 31, 2024 And 2023

1. Description Of The Plan

The following brief description of John Henry Foster Company of St. Louis, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan, which is sponsored by John Henry Foster Company of St. Louis, Inc. (the Company), is a defined contribution retirement savings plan covering all full-time, nonunion employees of the Company who are age 18 or older.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may defer up to the annual permissible dollar limit of the Internal Revenue Code (the Code). Participants age 50 or older are eligible to make additional catch-up contributions. Further, participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan also provides for automatic enrollment upon satisfaction of the eligibility requirements. The default deferral rate upon automatic enrollment is 1% of eligible compensation.

The Plan provides for a safe harbor provision nonelective Company contribution of 3% of eligible compensation. The Plan also allows for discretionary profit sharing and matching contributions. No discretionary profit sharing and matching contributions were made for the years ended December 31, 2024 or 2023.

Payment Of Benefits

Distributions may be made after a participant's retirement, termination of employment, death, disability, or the attainment of age 59-1/2. Distributions may be made in a single lump-sum payment, partial withdrawal, or substantial equal installments.

Vesting

Participants are 100% vested in their elective deferrals, Company safe harbor contributions, and Company discretionary profit sharing contributions plus actual earnings thereon. Company discretionary matching contributions are 100% vested after three years of service.

Forfeitures

Forfeited amounts of Company discretionary matching contributions shall be used to pay administrative expenses or reduce future Company discretionary matching contributions. At December 31, 2024 and 2023, there were no forfeited amounts available.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and allocation of Plan earnings. Allocations are based on participant contributions or account balances, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Participants are limited to one outstanding loan at any given time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% ranging from 4.25% to 9.50%. Loan terms are up to five years. Participants who have terminated from the Company are no longer able to borrow from the Plan. The loans are due in installment payments, through payroll withholdings, including principal and interest with maturity dates through November 2029.

Investment Options

Participants may direct contributions into a number of investment options offered by the Plan.

Administrative Expenses

The Plan permits the payment of Plan expenses to be made from the Plan's assets, unless elected to be paid by the Company. Primarily transaction fees and account fees are paid by the Plan. Expenses incurred on the purchase or sale of investments are added to the cost or deducted from proceeds of the respective investment and included in net change in fair value of investments.

2. Significant Accounting Policies

Basis Of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation

The Plan's investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Notes Receivable From Participants

Notes receivable from participants are measured at the unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable are recorded as a distribution based upon the terms of the Plan Document.

Recognition Of Investment Income

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Net change in fair value of investments represents the difference between their aggregate fair value at year end and their values at the beginning of the year, and includes any realized gains and losses in shares that were bought and sold during the year.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Investment Information

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information certified by Fidelity Management Trust Company (Fidelity) and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Fidelity that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31:

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value of investments. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust Fund

Valued at the unit value or NAV of shares held by the Plan at year-end. The NAV, as provided by the trustee of the fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. All of the underlying investments held by the Plan may be redeemed daily. The collective investment trust fund held by the Plan are not required to be reported in the fair value hierarchy. The collective investment trust funds held by the Plan file an annual report on Form 5500 as direct filing entities. The collective investment trust fund have no unfunded capital commitments, no trading restrictions, or advanced notice requirements.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the valuation methodologies used at December 31, 2024 or 2023.

5. Plan Termination

Although the Company has not expressed any intention to do so, it may terminate the Plan at any time. In the event the Plan is terminated, the amounts credited to participants' accounts at such time shall be nonforfeitable. Upon termination, assets of the Plan will be distributed to the participants in accordance with the Plan Document.

6. Income Tax Status

The Plan uses a non-standardized pre-approved plan. The pre-approved sponsor has received an opinion letter dated June 30, 2020 from the Internal Revenue Service (the IRS) which indicates that the pre-approved plan form is in compliance with applicable requirements of the Code. The Company has not received a determination letter with respect to the Plan's qualifications. The Plan has been amended since the opinion letter was issued. However, the Plan Sponsor believes the Plan is being operated in compliance with the applicable requirements of the Code, and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Parties In Interest Transactions

The Plan invests in certain mutual funds managed by Fidelity, the Plan's third party administrator and Trustee. In addition, at December 31, 2024 and 2023, certain participants had outstanding loans. These transactions are considered party in interest transactions allowable under ERISA.

8. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
