**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Barr Management, Ltd. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a contributory, defined contribution plan covering employees of Barr Management, Ltd. and Coral Castle, Inc. (the Company) who have completed twelve months with 1,000 hours of service and are age twenty-one or older. Employees of non-adopting affiliated employers, individuals not reported on the Company's payroll records (excluding partners and other self-employed individuals), union employees and non-resident aliens are not eligible for the Plan. Additionally, employees who became employees of the Company as a result of an asset or stock acquisition, merger, or similar transactions are not eligible for the plan until the expiration of the transition period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan is funded by participants' contributions and matching contributions by the Company. Participants may contribute up to 100% of their annual compensation up to the maximum allowable limits of Code Section 401(k). Each year, the Company has the option to make a discretionary contribution which is not limited to its current or accumulated net profit. The Company did not make a discretionary profit-sharing contribution for the year ended December 31, 2024.

The Company also has the option to make an employer matching contribution based on an annual election. For the plan year ended December 31, 2024, the Company matched 25% of participant deferrals up to the first 13% of total compensation.

Participant Accounts

Each participant's self-directed 401(k) account is credited with the participant's contributions and earnings on the participant's contributions, and is charged with plan expenses. Each participant has separate self-directed 401(k) accounts for employer matching contributions and employer profit-sharing contributions, which consist of the Company's contributions and earnings on the Company's contributions, and which are charged with plan expenses.

Vesting

Participants are immediately vested in their voluntary contributions plus the actual earnings thereon. Vesting in the Company discretionary matching and profit-sharing contributions portions of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Description of Investment Options

At December 31, 2024 and 2023, the Plan's assets were held in trusts administered by Capital Bank and Trust Company and Voya Retirement Insurance Annuity Company, respectively. Participants may elect to have their account contributions invested in one or a combination of investment options provided by the Plan. The investment options consist of various mutual funds and common collective trust funds as selected by the Plan Administrator.

Notes Receivable from Participants

The Plan contains provisions which allow for loans to participants, subject to certain restrictions. The maximum loan amount is the lesser of one half of the vested balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior 12 month period. Up to 50 percent of the vested balance may be used as collateral for the loan. These loans, which have a maximum term of five years, are to be repaid through regular payroll withholdings. The interest rate charged for loans from the Plan is established by the Plan Administrator.

Payment of Benefits and Distributions

On termination of service due to death, disability, retirement, or other reasons, a participant will receive an amount equal to the value of the participant's vested interest in a lump-sum payment or in a series of partial payments. In addition, the Plan provides for in-service withdrawals under certain circumstances.

Administrative Expenses

Certain administrative expenses have been paid by the Company. Administrative expenses paid by the Plan include investment advisory and management fees.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$77 and \$73, respectively. Forfeitures may be used to pay administrative expenses or reduce employer contributions. During the year ended December 31, 2024, forfeitures totaling \$893 were used to reduce employer contributions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Administration

The Plan is administered by the Plan Administrator.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and that also affect revenues and expenses during the reporting period. Actual results could differ from those estimates.

Date of Management's Review

For the current reporting period, subsequent events were evaluated through October 7, 2025, which represents the date the financial statements were available to be issued.

**NOTE 3 - INVESTMENTS**

The financial information relating to the Plan's investments is presented in the accompanying financial statements based on information provided by the custodians. Voya Retirement Insurance Annuity Company served as the custodian of the Plan's investments at December 31, 2023 and for the period January 1, 2024 through November 21, 2024. Capital Bank and Trust Company served as the custodian of the Plan's investments at December 31, 2024 and for the period November 22, 2024 through December 31, 2024. All investments are participant-directed, utilizing the investment options offered by the Plan.

For the year ended December 31, 2024, the custodians also certified as to the completeness and accuracy of \$225,884 of net realized and unrealized appreciation in fair value of investments and \$336,848 in interest and dividend income related to the aforementioned investments, as well as \$26,219 in interest income related to the aforementioned notes receivable from participants.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 5 - FAIR VALUE MEASUREMENTS**

The Fair Value Measurements and Disclosure Topic of the Financial Accounting Standards Board Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3                      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market fund:* Valued by obtaining quoted prices on nationally recognized securities exchanges. □

*Pooled separate accounts:* Valued based on the latest quoted market prices of the underlying securities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 -GROUP ANNUITY CONTRACT**

The Plan had entered into a traditional fully benefit-responsive investment contract (group annuity contract) with Voya Retirement Insurance and Annuity Company (VRIAC). VRIAC maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Subject to certain restrictions, participants could ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. The group annuity contract was a traditional investments contract. The group annuity contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The group annuity contract meet the fully benefit-responsive investment contract criteria and was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VRIAC, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the group annuity contract as of December 31, 2024 and 2023 was \$-0- and \$1,672,713, respectively. The crediting interest rate was based on a formula agreed upon with the issuer, but it may not be less than 1.05 percent. Such interest rates were reviewed on an annual basis for resetting.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the Plan, termination of the recordkeeping agreement, or ninety days written notice provided either by the Plan Administrator or the issuer. Liquidation of the entire contract may cause a one-time adjustment to the aggregate contract value, resulting in a fair value different from the contract value. This total liquidation is a contingent event, which cannot be initiated by the Plan's participants, and can only be initiated by the Plan Administrator upon termination of the Plan or complete termination of the contract. Effective November 21, 2024, the recordkeeping agreement between the Plan and the issuer was terminated resulting in the liquidation of the entire contract. The issuer paid all participant account values to another provider or trustee as directed by the Plan Sponsor.

**NOTE 7 - TAX STATUS**

The pre-approved plan sponsor has obtained an opinion letter dated June 30, 2020 in which the IRS stated that the pre-approved non-standardized plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator timely adopted the restated pre-approved non-standardized plan. The Plan Administrator believes that the Plan is being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8 - EXCESS CONTRIBUTIONS PAYABLE**

The Plan failed certain discrimination testing for the years ended December 31, 2024 and 2023. Excess contributions amounting to \$8,448 and \$7,329 at December 31, 2024 and 2023, respectively, are recorded as a liability in the accompanying statements of net assets available for benefits. Excess contributions of \$8,448 are recorded as a decrease in contributions for the year ended December 31, 2024.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10 - PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments consisted of a group annuity contract and pooled separate accounts managed by Voya Retirement Insurance Annuity Company. Voya served as the Plan's custodian through November 21, 2024; therefore, these transactions qualify as party-in-interest transactions. In addition, certain Plan investments consisted of shares in a money market fund and various mutual funds managed by Capital Bank and Trust Company. Capital Bank and Trust Company served as the Plan's custodian from November 22, 2024 through December 31, 2024; therefore, these transactions also qualify as party-in-interest transactions. Fees paid by the Plan to the custodians are reflected as a reduction in the returns earned on the mutual funds and money market fund.
