Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed the audits of the financial statements of **Resilient Health 403(b) Plan** ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Basis for Opinion on the Financial Statements

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at the year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

(1) Description of the Plan

The following description of the *Resilient Health 403(b) Plan* (the "Plan"), is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is administered by a trustee and an administrator appointed by Resilient Health, Inc. (the "Organization"), the Plan's sponsor.

- A. General** – The Plan is a defined contribution plan covering all employees of the Organization. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the Internal Revenue Code ("IRC"). The Plan was established on October 1, 1992. The Plan has been restated several times since it was established, most recently as of January 1, 2024.
- B. Eligibility** – Employees are eligible to participate in the Plan on their hire date. Employees who have completed one year of service are eligible for employer matching contributions. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee had 1,000 or more hours of service.
- C. Contributions** – Each year, participants may contribute any amount of pretax annual compensation or Roth contributions, up to the limits permitted by law and regulations governing 403(b) plans, as defined in the Plan. Eligible employees are automatically enrolled in the plan with a pre-tax deferral rate of 2%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

The Organization makes a discretionary matching contribution to equal 100% of the first 3% of the participants' eligible compensation contributed each pay period. Employees that defer 3% of eligible compensation will receive an employer match of 3%, employees that defer 2% of eligible compensation will receive an employer match of 2%, and employees that defer 1% of eligible compensation will receive an employer match of 1%.

Effective January 1, 2024, the Plan was amended to exclude bonuses and incentive pay from eligible compensation.

- D. Participant accounts** – Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- E. Vesting** – Participants are immediately vested in their elective, rollover, and discretionary matching contributions plus actual earnings thereon.

- F. Notes receivable from participants** – Participants may borrow against their vested balances up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loans may not be taken from the participant's Roth deferrals. Only one loan may be outstanding at any time. Loans are secured by the vested balance in the participant's account and bear interest at the prime rate plus 1%. The loans must be repaid over a period of five years unless the loan was used to purchase a personal residence upon which the five-year period may be extended at the discretion of the Plan administrator.
- G. Payment of benefits** – Upon termination of service due to death or disability, or upon the attainment of age 59 ½, a participant may receive a lump-sum or installment distributions equal to the value of the participant's account. If the value of a participant's vested benefit is \$5,000 or less, a lump sum payment will be made to the participant. Distributions may be made at the participant's election prior to termination upon attaining age 59 ½ or hardship as defined in the Plan document. For distributions due to hardship, a participant may receive a distribution only from the portion of the employee's elective deferrals.
- H. Termination of the Plan** – Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
- I. Administrative expenses** – All expenses of maintaining the Plan are paid by the Organization. Loan administration fees are charged directly to the participant's account and are included in administrative fees.

(2) Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

Basis of accounting – The accompanying financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

Management's use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of net assets and the reported amounts of additions to and deductions from net assets. Actual results may differ from those estimates.

Investment valuation and income recognition – Investments, with the exception of the investment contract with insurance company discussed in Note 5, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investments in mutual funds are stated at net asset value ("NAV"), which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions. Investment contracts with insurance company are investments in a fully benefit responsive fixed income guaranteed option and are required to be reported at contract value rather than fair value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

(2) Significant accounting policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant's loan to be in default, the participant balance is reduced and a benefit payment is recorded.

Risks and uncertainties – The Plan provides for various investment options. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Benefits paid to participants – Benefits paid to participants are recorded in the period in which they are paid.

Subsequent events – Plan management has evaluated subsequent events through October 7, 2025, which is the date the financial statements of the Plan were available to be issued.

(3) Fair value measurements

The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In instances where the determination of the fair value measurement is based on inputs from different levels of the fair value hierarchy, the level in the fair value hierarchy within which the entire fair value measurement falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Mutual funds - valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Investment contract with insurance company

The Plan has a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company reported at contract value. Principal Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in the investment valuation disclosure, because the investment contract is fully benefit-responsive, contract value is the relevant measure for the portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Principal Life Insurance Company, represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following; (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The investment contract does not allow Principal Life Insurance Company to terminate the agreement prior to the scheduled maturity date.

(6) Income tax status

The Plan has adopted a prototype plan and received an opinion letter from the IRS dated March 31, 2017, stating that the prototype plan was designed in accordance with applicable sections of the IRC. Management has not obtained an individual determination letter for the Plan. The prototype plan has been amended since receipt of the opinion letter. Management and the Plan administrator believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust remains tax-exempt at December 31, 2024. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

(7) Related party and party-in-interest transactions

Principal Trust Company, the custodian of the Plan, manages the Plan's investments and processes participant data and account information; therefore, these transactions qualify as party-in-interest transactions. There were \$51,769 of distribution/loan processing fees and recordkeeping fees paid by the Plan to Principal Trust Company for the year ended December 31, 2024.
