Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Country Meadows 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Note 1 - Description of Plan

The following description of the Country Meadows 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General

The Plan is a defined contribution plan covering all full-time and part-time employees of:

- Country Meadows Associates LP;
- Country Meadows Associates II LP;
- Country Meadows of Allentown, LLC;
- Country Meadows of Frederick Associates LLLP;
- Country Meadows of Hershey Associates, LLC;
- Country Meadows of Northampton Associates LP;
- Country Meadows of West Shore, LLC;
- Country Meadows of York, LLC;
- Country Meadows of South Hills, LLC (through May 2024);
- Country Meadows of Leader Heights, LLC;
- Country Meadows of Wyomissing, LLC;
- George M. Leader Family Corporation; and,
- Leader Family Hospice, LLC DBA Lifesong Hospice and Palliative Care (collectively, the Companies).

Nonresident aliens and leased employees are not eligible to participate in the Plan. To be eligible to make salary deferrals, employees must complete 60 days of service and be age 21 or older. To be eligible to receive employer contributions, employees must complete one year of service with at least 1,000 hours and be age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In March 2024, the plan sponsor executed an agreement to sell the assets of Country Meadows of South Hills, LLC. The sale was closed in May 2024.

Note 1 - Description of Plan (continued)

Contributions

Participants may make pre-tax and Roth contributions up to the maximum amount allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. Effective January 1, 2024, the Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants will have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. Automatically enrolled participants' deferral rates will increase automatically by 1% at the beginning of each plan year until the deferral rate equals 6% or the participant elects a different deferral rate.

The Companies may make a discretionary matching contribution. During the years ended December 31, 2024 and 2023, the Companies matched 50% of a participant's contribution, up to a maximum contribution of 3% of eligible wages, for eligible employees who were employed by the Companies at the Plan year-end. The Companies may also make an employer non-elective discretionary profit sharing contribution. The Companies did not make any profit-sharing contributions during the years ended December 31, 2024 and 2023. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Companies' matching contributions, as well as allocations of (a) the Companies' profit-sharing contributions, (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 100% vested after four years of credited service, based on the following vesting schedule:

Regardless of the number of years of service, a participant's account balance becomes fully vested when a participant retires, becomes permanently disabled, or dies.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account (as described in the plan agreement).

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$21,271 and \$22,912, respectively. These accounts will be used to reduce the employer contribution. During the years ended December 31, 2024 and 2023, there were \$2,753 and \$23,626 worth of forfeited nonvested accounts used to reduce the employer contribution receivable to be paid in 2025 and 2024, respectively.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the distribution of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3 - Information Certified and Provided by Voya Retirement Insurance and Annuity Company

Certain information in the accompanying financial statements and ERISA-required supplemental schedules related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the custodian of the Plan.

Note 4 - Fair Value Measurements

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Pooled separate accounts are valued at the net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments held by the funds less its liabilities.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Note 5 - Fully Benefit-Responsive Investment Contract (continued)

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The contract issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- A. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
- B. Premature termination of the contracts.
- C. Plan termination or merger.
- D. Changes to the Plan's prohibition on competing investment options.
- E. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the contract issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- A. An uncured violation of the Plan's investment guidelines.
- B. A breach of material obligation under the contract.
- C. A material misrepresentation.
- D. A material amendment to the agreements without the consent of the contract issuer.

Note 6 - Tax Status

The Companies have adopted a pre-approved plan document that was sponsored by Ascensus LLC. The pre-approved document has received an opinion letter from the IRS, dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and; therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Note 6 - Tax Status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the employer contribution portion of their account.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 - Related Party Transactions and Party-In-Interest Transactions

The Plan invests in pooled separate accounts and a guaranteed investment contract managed by Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is the custodian of the Plan and; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Voya Retirement Insurance and Annuity Company were immaterial.

Note 10 - Reconciliation of Financial Statements to the Form 5500

The Plan invests in various pooled separate accounts that do not file a Form 5500 as a Direct Filing Entity. Accordingly, on the Form 5500 filed by the Plan, the percentage of the interest in the underlying assets of the pooled separate accounts must be reported in the appropriate categories on the asset and liability statement of the Form 5500 for the Plan.

Note 11 - Prohibited Transactions

During 2024, the plan sponsor inadvertently failed to deposit \$101,866 of participant deferrals within the required time frame as stated by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The plan sponsor intends to reimburse the Plan for lost interest, file Form 5330, and pay the applicable excise tax in 2025. The excise tax payments will be made from the plan sponsor's assets and not from assets of the Plan.

During 2023, the plan sponsor inadvertently failed to deposit \$276,165 of participant deferrals within the required time frame as stated by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The plan sponsor intends to reimburse the Plan for lost interest, file Form 5330, and pay the applicable excise tax in 2025. The excise tax payments will be made from the plan sponsor's assets and not from assets of the Plan.

Note 12 - Subsequent Events

Plan management has evaluated subsequent events through October 7, 2025. This date is the date the financial statements were available to be issued. No material events subsequent to December 31, 2024 were noted.
