## INDEPENDENT AUDITOR'S REPORT

To the Plan Trustee of  
Retail Technology Group, Inc. 401(k) Profit Sharing Plan Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Retail Technology Group, Inc. 401(k) Profit Sharing Plan Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Retail Technology Group, Inc. 401(k) Profit Sharing Plan Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

1. DESCRIPTION OF THE PLAN

The following description of Retail Technology Group, Inc. 401(k) Profit Sharing Plan Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan sponsored by Retail Technology Group, Inc. (the "Company" or "Plan Administrator") under the provisions of Section 401(a) of the Internal Revenue Code (the "IRC"), which includes a qualified deferral arrangement as described in Section 401(k) of the IRC for the benefit of eligible employees of Retail Technology Group, Inc. and AURES Technologies, Inc. Each employee becomes eligible after completing six months of service and attaining age 21. Employees enter the plan on the first day of the quarter following meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0.

The Company is responsible for oversight of the Plan and determining the appropriateness of the Plan's investment offerings and monitoring investment performance. The Company acts as the Plan Administrator. As of October 2023, American Life Insurance Company became the custodian and administrator of the Plan. Prior to that time, John Hancock Life Insurance Company ("John Hancock") was the Plan's custodian and Benefit Plan Plus LLC was the Plan's third-party administrator.

Contributions

Each year, participants may contribute up to 100% of their annual compensation, as defined in the Plan, not to exceed certain dollar limits established by the IRC. Participants may elect to make roth contributions to the Plan on an after-tax basis. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. If a participant has attained age 50 before the end of the Plan year, he or she is eligible to make catch-up contributions. Participants direct the investment of their contributions into the various investment options offered by the Plan.

The Company makes a safe harbor contribution in the amount of 100% of each participant's deferrals up to 3% of eligible compensation, plus 50% of each participant's deferrals between 3% and 5% of eligible compensation. This Company contribution is invested at the direction of the participants. In addition, a discretionary profit-sharing amount may be contributed at the option of the Company. There were no discretionary profit-sharing contributions in 2024 or 2023. Contributions are subject to certain limitations.

Participant accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings. The allocation of earnings is determined by the earnings of the participant's investment selection based on each participant's account balance, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferral and roth contributions, rollover contributions, and Company safe harbor matching contributions plus actual earnings thereon. Participants are vested in Company discretionary profit-sharing contributions based on years of service. Participants become 20% vested after two years and earn an additional 20% for each year thereafter. Participants become fully vested after six years of credited service.

Notes receivable from participants

Participants are restricted to one outstanding loan at any given time. The amount of participants' loans may not be less than \$1,000 and may not exceed the lesser of 50% of the vested interest in their account or \$50,000. The \$50,000 limit is subject to reduction by the amount of certain previously outstanding loans. For loans outstanding at December 31, 2024, the prevailing interest rates were between 5.25% and 10.00% with maturities through August 2029. Principal and interest are paid ratably through bi-weekly payroll deductions. Loans must be repaid within a period not to exceed five years from the date the loan was issued.

Payment of benefits

For distributions other than death (termination, disability, after age 59½, attainment of normal retirement age, and hardship), participants may request a distribution, which will be paid in a lump sum.

Forfeited accounts

Non-vested benefits of terminated participants are forfeited on the date the participant receives complete distribution of vested benefits. Forfeitures are used to reduce future employer contributions or administrative expenses. At December 31, 2024 and 2023, the Company had no forfeited non-vested accounts available to reduce future employer contributions or administrative expenses of the Plan.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from the Plan's financial statements. Investment related expenses are included in appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (other than fully-benefit responsive investments). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefit payments are recorded when paid.

Subsequent events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements are available to be issued.

Contributions and receivables

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Company, which is the pay date. The Company's matching contributions and discretionary non-elective contributions, if any, are recorded in the year they are earned and to coincide with the year in which the Company records the contributions in its general ledger. The Plan records receivables for all contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year. Rollovers are recognized when received by the Trustee.

3. CERTIFICATION BY CUSTODIANS

For the years ended December 31, 2024 and 2023, the Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from John Hancock (for the period January 1, 2023 through October 15, 2023) and One America (for the period October 15, 2023 through December 31, 2024) that all the investment and notes receivable from participants information provided by the custodians is complete and accurate. Information included in the accompanying financial statements as to investments, investment income, interest on notes receivable from participants, and all information in the supplemental schedule is presented in reliance solely upon the certifications.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in the inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: The Plan's pooled separate accounts are valued using the readily determinable fair value ("RDFV"). The RDFV is based on the value of the underlying assets owned by the fund, which consist of mutual funds. The pooled separate accounts held by the Plan publish their RDFV daily and transact at that price.

5. FIXED INTEREST ACCOUNT WITH AMERICAN UNITED LIFE INSURANCE COMPANY

The Plan offers the AUL Stable Value Fund ("Stable Value Fund"), a fully benefit-responsive investment contract as an investment option for the Plan's participants. This contract is included in the statements at contract value, as reported by AUL.

American United Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract value approximates fair value for this investment as of December 31, 2024 and December 31, 2023. The contract value of the investment contract for 2024 and 2023 was \$47,749 and \$52,637 respectively. The plan administrator is not aware of reserves against contract value for credit risk of the contract issuers or otherwise. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, which may not be less than zero. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan's trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring.

The fixed annuity contracts in the Stable Value Fund are guaranteed against loss of principal, less all withdrawals, including charges and adjustments. The guarantee is based on AUL's ability to meet its financial obligations from the general assets of AUL. Interest is credited daily at an interest rate that will not be less than the guaranteed account minimum interest rate, as defined in the contract. The interest crediting rate is declared on an annual basis. The average accumulating crediting interest rate was 1.70% and 1.31% as of December 31, 2024 and 2023 respectively.

6. TAX STATUS

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under IRC Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PARTY-IN-INTEREST TRANSACTIONS

For the Plan year ended December 31, 2024, certain Plan investments held were pooled separate accounts managed by One America. One America is the custodian as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment fees are reflected in net appreciation in fair value of investments.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
