## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Access Systems 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Access Systems 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

**NOTE 1 — PLAN DESCRIPTION**

The following brief description of the Access Systems 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan that covers substantially all employees of Access Technologies, Inc. (dba Access Systems) (the Company) who are age 18 or older, excluding collectively bargained employees, non-resident aliens, and interns. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Administration**

The Company is the Plan Administrator. The Company had contracted with American Trust Retirement (ATC) to hold the Plan's assets, execute investment transactions, perform allocations of contributions and investment earnings, make benefit payments, and perform recordkeeping services for the Plan. As of August 1, 2024, Principal Trust Company (Principal) was engaged as the new recordkeeper and custodian of the Plan.

**Contributions**

Participants may contribute up to 100% of annual compensation, as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company may make discretionary matching contributions to the Plan. For the years ended December 31, 2024 and 2023, the Company contributed 100% of the first 3% of compensation that a participant contributed to the Plan. Contributions are subject to Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of discretionary contributions and Plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account balances into various investment options offered by the Plan, and may make changes daily.

**Vesting**

Participants are vested immediately in their contributions plus earnings thereon. Participants become vested in Company contributions plus earnings thereon after three years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Outstanding loans are limited to 2 per participant at any given time, are secured by the balance in the participant's account, and bear a reasonable fixed interest rate, as determined by the loan administrator. The loans are secured by the balance in the participant accounts and carry interest rates ranging from 5.25% to 10.50%, with terms ranging from 12 to 180 months, and are due through February 2032. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to retirement, death, disability or separation from service, a participant may elect to receive benefits in a single lump-sum or in periodic payments over time if the participant's vested account balance is greater than \$5,000. If the total vested amount which a participant is entitled to receive upon termination is less than \$5,000, the vested balance will be distributed in accordance with the Plan agreement. A participant may also withdraw a portion of his or her vested Plan benefit upon attaining age 59 1/2 while still employed by the Company. In addition, hardship distributions are permitted if certain criteria are met.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$2,900 and \$12,300, respectively. These accounts will be used to reduce future Company contributions and to pay Plan expenses. During the years ended December 31, 2024 and 2023, forfeited accounts reduced Plan expenses allocated to participants by approximately \$33,800 and \$27,500, respectively. During the year ended December 31, 2024, forfeited amounts reduced Company contributions to the Plan by approximately \$10,100. During the year ended December 31, 2023, no forfeited amounts were used to reduce Company contributions to the Plan.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 2 — SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is reported on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributes the excess contributions to the applicable participants prior to March 15 of the following year.

**Payment of Benefits**

Benefits are recorded when paid.

**Contributions**

Contributions from the Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Plan include administrative, recordkeeping, and Plan audit fees. Expenses that are paid by the Company are excluded from these financial statements. Certain investment-related expenses are included within net appreciation in fair value of investments.

**NOTE 3 — INFORMATION CERTIFIED BY PRINCIPAL AND ATC**

The following is a summary of the investment information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared or derived from information provided by Principal and ATC, respectively, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Principal and ATC, respectively, that information provided to the Plan Administrator by Principal and ATC, relating to the following investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and supplemental schedule relating to the following investments.

Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued based on quoted prices of identical assets in active markets.
- *Common collective trusts*: Valued based upon quoted redemption values, also known as net asset values, determined by Principal using available market information and appropriate valuation methods, and represent the value at which the Plan (or the participant) could initiate a transaction with Principal. There are no imposed redemption restrictions on participants, and values are determined daily.

**NOTE 5 — TAX STATUS**

The Plan was created from a prototype developed by AT Retirement Services LLC. AT Retirement Services LLC received an opinion letter from the IRS dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, no such positions exist.

**NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS**

As of December 31, 2024 and 2023, Plan assets include various investments managed by Principal and ATC, respectively, which qualify as party-in-interest transactions. Fees paid to Principal and its affiliates were \$24,559 for the year ended December 31, 2024. Fees paid to ATC and its affiliates were \$22,646 and \$51,841 for the years ended December 31, 2024 and 2023, respectively. Fees paid to the independent accountant of the plan for audit fees were \$10,000 and \$8,000 for the years ended December 31, 2024 and 2023, respectively. The Plan also contains participant loans. These transactions are exempt and are not prohibited by ERISA.
