Dear Sir or Madam,

I am writing regarding the Form 5500 filing for the plan year ending 2024. I recently became aware that the Form 5500 was not filed as required. My understanding was that our payroll and benefits service provider, ADP, would handle the preparation and submission of this filing, as they have for the last 14 years. Unfortunately, it appears that this filing was not completed for the year in question.

I only found out when I received the above-mentioned notice (CP216F) from you. As soon as I learned of this, I contacted ADP to inquire why they had not filed the return nor had sent me **any communication** informing me that this **last** return needed to be handled different than the process that I was accustomed to for the last 14 years. Furthermore, no credentials were even provided to be able to complete the filing. These actions were out of my control and certainly not out of negligence on my part.

As you know our company was established in 1997, regretfully I inform you that in 2023 I lost my husband, Eladio M. Paez, who was the President, CEO and the sole business development and customer contact person of the business, as I handled invoicing and payroll. I struggled since March of 2023 until 2024 to try to maintain it open but unfortunately mid-year I found myself having the only two active employees transfer their 401K to the banks of their choosing and officially closing the business on November 30th 2024.

I am currently coordinating with ADP to ensure they provide me with the necessary credentials to ensure Form 5500 is prepared and submitted as soon as possible.

This was an unintentional oversight, and I respectfully request that you take this into consideration in reviewing any potential penalties and fees. I remain committed to complying fully with all filing requirements to your satisfaction and will be eternally grateful for your consideration and assistance in this matter. I thank you in advance for your understanding.
