Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of ABC California Health Trust Welfare Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan's benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in plan's benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and plan's benefit obligations of ABC California Health Trust Welfare Benefit Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and plan's benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ABC California Health Trust Welfare Benefit Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about ABC California Health Trust Welfare Benefit Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. NOTE 1 DESCRIPTION OF PLAN

The following description of ABC California Health Trust Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a multiple employer trust fund established by Associated Builders and Contractors of San Diego, Inc. under section 501(c)(9) of the Internal Revenue Code which provides group health benefits for all eligible participants and their beneficiaries. FuturePlan is the Plan administrator and is responsible for carrying out the administrative duties of the Plan and aiding in the compliance with ERISA. The participating employers are comprised of licensed contractors who are members of ABC San Diego or ABC Los Angeles – Ventura. Contributions are paid by participating employers to the trust fund for the exclusive purpose of creating and administering an employee welfare benefit plan. The Plan is not collectively bargained and it does not apply to employees covered by collective bargaining agreements. The Plan went into effect March 29, 1990. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Hourly employees at member firms are eligible for benefits the first day of the second month following a month in which they accumulated at least 130 hours. Coverage continues on a month-to-month basis as long as the participating employee is credited with the 130 hours each month. In addition, if an employee works more than the 130 hours each month, the excess will be held in a reserve account called accumulated eligibility credits for a total of up to 390 hours (maximum hour bank total). The accumulated eligibility credits may be carried forward up to a maximum of three months. This "dollar bank" reserve is available for employees to use in the months in which the employee has not worked sufficient hours to qualify for coverage.

An hourly indentured apprentice is eligible for benefits on the first day of the second month following completion of 260 hours of work. Upon eligibility, coverage continues on a month-to-month basis if the participating employee is credited with a minimum of 130 hours each month. If the participating employee works more than 130 hours in a month, the excess will be held in a reserve account called accumulated eligibility credits for a total of up to 390 hours (maximum hour bank total). The accumulated eligibility credits may be carried forward up to a maximum of three months. This "dollar bank" reserve is available for employees to use in the months in which the employee has not worked sufficient hours to qualify for coverage.

In June of each year, the hourly rates used to convert each employees' accumulated eligibility credits from hours to the equivalent dollar amount is adjusted. When this occurs, the dollar balance is used to recalculate the new hour equivalent. This may cause an employee to exceed the 390 maximum hour bank at which point the excess hours will be grandfathered into their accumulated eligibility credit balance. No additional credits will be accumulated until the excess has been used and the hour bank balance drops below 390 hours.

Benefits

The Plan provides health benefits including medical, dental, vision, life, and related benefits. All benefits are fully insured. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions

Employers within the trust make monthly contributions for their participating employees covered under the Plan. This includes “member firm” salary and hourly employees, as well as indentured apprentices. Each year, the Board of Trustees determines and sets the contribution amounts needed to fund the premiums and Plan administrative expenses. Member firm salaried employee contributions for any particular month correspond to the provided coverage for that same month. As such, there is neither a dollar bank nor any other obligation for the trust to provide coverage beyond the month that the premium is paid.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires the Plan’s management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Concentration of Credit Risk

The Plan maintains its cash in bank deposit accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. The Plan believes it is not exposed to any significant credit risk on cash.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Contributions Receivable

Contributions due but not paid prior to year-end are recorded as contributions receivable. Contributions are due from employers as specified in the participation agreement. In general, contributions are due on or before the 15th day of the month following the month in which the hours are worked. Contributions that are not submitted in accordance with the participation agreement are deemed delinquent and are analyzed individually for collectability. The estimate for expected credit losses considers historical loss experience, current economic conditions, and forward-looking information, including factors such as payment history, employer financial condition, and labor trends. As of December 31, 2024, the allowance for credit losses was insignificant and there was no material impact on the Plan.

Payment of Benefits

Insurance premiums paid for health benefits are recorded in the accompanying statements of changes in net assets available for benefits for the respective period benefits are covered for the participants.

Administrative Expenses

All administrative expenses may be paid out of the Plan unless paid by ABC California Chapter. During the years ended December 31, 2024 and 2023, the Plan paid for substantially all administrative expenses, which consisted of administration fees, professional fees, and other miscellaneous expenses.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Accumulated Eligibility Credits (Dollar Bank)

Certain hourly employees meeting eligibility requirements are entitled to coverage in future periods. Employer contributions received in excess of Plan insurance premiums and other expenses are held for investment to pay premiums for all eligible participants during their coverage periods. The estimate of the accumulated eligibility credits is based upon the number of eligible participants, participant hours reported by employers, and hourly rates determined by the Board of Trustees.

Subsequent Events

Subsequent events have been evaluated through September 10, 2025, the date on which the financial statements were available to be issued.

NOTE 5 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 5 FAIR VALUE OF INVESTMENTS (CONTINUED)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Interest-Bearing Cash: Valued at cost, which approximates fair value.

Money Market and Mutual Funds: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

NOTE 6 TAX STATUS AND INCOME TAXES

Tax Status

The Plan meets the requirements for qualification under Section 501(c)(9) of the Internal Revenue Code (IRC) and under Section 23701(i) of the California Revenue and Taxation Code and therefore, is exempt from most taxes. The Internal Revenue Service has determined and informed the Plan by a letter dated September 21, 1990 that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has also received a determination letter dated October 17, 2000 from the state of California Franchise Tax Board. Although the Plan has been amended since receiving the determination letters, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and state laws.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Income Taxes

As a result of the Plan's funding policy, from time to time the trust may be subject to unrelated business income tax (UBIT) and deferred income taxes due to the overfunded status. The trust accounts for income taxes according to the asset and liability method. Under this method, deferred income tax assets and liabilities are determined based on the estimated future tax consequences attributable to temporary differences between the financial statement carrying amounts of existing assets and liabilities and their respective tax bases. Deferred income tax assets and liabilities are measured using the enacted tax rate in effect for the years in which the temporary differences are expected to be recovered or settled. Temporary differences arise from differences in reporting the amounts for financial statement purposes and income tax purposes and, accordingly, a deferred income tax liability of \$626,787 and \$503,741 has been recorded at December 31, 2024 and 2023, respectively, on the cumulative unrealized gains on investments in the trust.

The amount subject to current taxation is based on excess investment income. Changes in the Plan's income taxes payable for unrelated business income tax are as follows:

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the trustees retain the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan, subject to the provisions of ERISA. The trustees and participating employers do not promise the continuation of any benefits nor do they promise any benefits at or during retirement. Benefits may also be terminated by the participating employer's failure to make contributions or by the termination or expiration of the participating employer's agreement adopting the Plan.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

The Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

NOTE 9 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

The estimate for accumulated eligibility credits is based on certain assumptions pertaining to trends and inflation rates. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
