Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Horton Holding, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2024, is presented for purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1. Plan Description

The following description of Horton Holding, Inc. Retirement Savings Plan (the Plan) provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering certain employees of Horton Holding, Inc. (the Company). An employee is eligible to enter the Plan as of their hire date. An employee is eligible to receive employer matching contributions each payroll period if he or she is employed in recognized employment, as defined. An employee is eligible to receive employer discretionary contributions, if any, if he or she has been employed by the principal sponsor or one of its affiliated employers of the Plan, is actively employed on the first day of the quarter following one year of eligibility service and is employed in recognized employment, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company serves as the Plan Administrator.

Contributions: Participants may elect to contribute, on a pretax or post tax basis, up to 100% of eligible compensation, as defined, subject to the maximum permitted by the Internal Revenue Service (IRS). All newly hired employees are automatically enrolled in the Plan at a 4% deferral rate, unless otherwise elected. The Plan includes an automatic escalation provision whereby the default withholding rate for automatically enrolled participants is increased 1% annually up to a maximum 12% unless otherwise elected by the participant. The Company makes matching contributions equal to 100% of participant contributions up to 4% of eligible participant compensation. The Company may also elect to make additional discretionary contributions as determined by the Company's Board of Directors. No discretionary contributions were granted in 2024. Contributions are invested based on each individual participant's investment elections. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participants' eligible compensation, account balances or specified transactions as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of a participant's account is on a graded scale based on years of continuous service. A participant is 100% vested after three years of credited service. A participant is also fully vested in their entire account upon the earliest occurrence of death or disability during the term of employment, attainment of age 60, or Plan termination.

Investment options: Upon enrollment in the Plan, a participant may direct contributions into various investment options. Each option varies in type of investment, rate of return and investment risk. Participants may change their contribution election and investment option elections on a daily basis.

Notes receivable from participants: Participants are permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the vested balance. The repayment period is not to exceed 60 months, unless it is for a principal residence, in which case the term can be for a reasonable period of time, as determined by the Plan Administrator. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 2%. Interest rates ranged from 4.25% to 10.50% at December 31, 2024. Principal and interest are paid ratably through after-tax payroll deductions over the terms of the notes, which expire through April 2032.

Note 1. Plan Description (Continued)

Benefits paid to participants: Upon retirement at age 60 or older, death, disability or Plan termination, participants may elect to roll over their balance to another qualified plan or individual retirement account (IRA) or receive the value of the vested interest in their accounts in the form of a lump-sum distribution or periodic payments for a specific number of years not longer than their life expectancy or the life expectancy of their beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution or roll over the balance to another qualified plan or IRA. If a terminated participant's vested account balance does not and has not exceeded \$7,000 at any time, the balance will be distributed to the participant in a single lump-sum payment. Additionally, the Plan allows in-service withdrawals after attainment of age 59½ and, in the case of financial hardship, is subject to restrictions as defined by the Plan.

Forfeited accounts: Forfeited nonvested accounts are used to partially fund the Company's contributions to the Plan or to pay administrative expenses. There were approximately \$200 and \$10,000 of forfeited nonvested accounts at December 31, 2024 and 2023, respectively. In 2024, Company contributions were partially funded by approximately \$96,000 from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Contributions: Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors, trustee and other third parties. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Notes receivable from participants are classified as an investment for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Benefits paid to participants: Benefits are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The remaining administrative costs are paid by the Plan. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities have occurred since year-end and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, that was prepared by or derived from information provided by Principal Trust Company, the trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee, that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Investments in registered investment companies are valued at quoted prices for identical investments in active markets for shares held.

Common/collective trusts: The common/collective trusts are valued at net asset value (NAV) of shares or units held by the Plan based on the quoted market value of underlying assets. The NAV, as provided by the trustee, is used as a practical expedient for estimating fair value. The practical expedient is not used when it is determined to be probable that the trusts will sell their investments for amounts different than the reported NAV.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At the Plan level, redemptions will be made within a 12-month period following written notice. Participants generally may redeem their investment at any time, and the redemption is made within six days of notice.

Note 5. Related-Party and Party-in-Interest Transactions

Certain Plan assets are invested in shares of registered investment companies and common/collective trusts managed by Principal Trust Company, the trustee. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are recorded as administrative expenses.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7. Tax Status

Effective October 1, 2023, the Plan has adopted the Principal Life Insurance Company Non-Standardized Pre-Approved Profit Sharing Plan. The IRS has issued an opinion letter stating that the pre-approved plan is acceptable under section 401 of the IRC. The pre-approved plan has been amended since receiving the opinion letter; however, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
