INDEPENDENT AUDITORS' REPORT

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Crisis Prevention Institute, Inc. Retirement Plan Group Trust ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits do not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Crisis Prevention Institute, Inc. Retirement Plan Group Trust ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through June 21, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Crisis Prevention Institute, Inc. is the plan administrator, sponsor and employer. CBIZ Retirement & Investment Solutions is the third party administrator that maintains plan documents and performs various compliance tests. They are also the plan's investment advisor. Voya Institutional Trust Company is the trustee that holds the plan's mutual funds. Voya Retirement Insurance and Annuity Company holds custody of the plan's guaranteed investment contract and is the recordkeeper that maintains participant investment accounts and records. The two related entities are collectively referred to as "Voya".

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Earnings on investments bought, sold and held during the years is reflected in the statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

Money market fund and mutual funds - Valued at the daily quoted market prices as reported by the funds. The funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

Investments at contract value - The plan has a fully benefit-responsive guaranteed investment contract through an annuity contract issued by Voya. Voya maintains the contributions in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a guaranteed minimum interest rate ("GMIR") for the life of the contract. The contract also provides two declared interest rates; a current rate, determined at least monthly, and a guaranteed minimum floor rate, determined at least annually. The guaranteed minimum floor rate may change after a defined period, but it will never be lower than the GMIR that applies for the life of the contract.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal of all or a portion of the investment at contract value at any time. However, Voya may limit participant transfers, which are made at contract value, from this investment to other investments within the plan. The transfer limit, if imposed, varies but will never be less than 10% of the balance of the investment as of the date of the transfer, reduced for any transfers during the same year.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. The plan sponsor can request a lump sum distribution with a market value adjustment or an installment payout, at contract value, over a period of years. The contract will continue in full force until all assets have been distributed or no further payments are due.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with the issuer. As of the date the financial statements were available to be issued, the plan administrator is not aware of any events that may limit the ability of the plan to transact at contract value with the contract issuer or limit the ability of the plan to transact at contract value with the participants.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan documents for more complete information.

General - The plan was established on January 1, 1985 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent amendments.

Eligibility - Employees are eligible once they have completed one month of service and have reached age eighteen. An employee can enter the plan on the first day of the month immediately following the employee meeting the eligibility requirements.

Contributions - Contributions are recorded in the year in which eligible compensation is paid. Contributions to the plan can be made as follows:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. Upon meeting eligibility requirements, new participants are automatically enrolled in the plan and have 4% of their compensation withheld as elective deferral contributions. These participant deferral percentages automatically increase 1% each year until they reach a maximum of 8%. Such participants have the option to increase, decrease or stop the deferral at any time by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Employer safe harbor matching contributions are made equal to 100% on the first 4% contributed by the employee and 50% on the next 4% contributed by the employee. These contributions are funded coinciding with each payroll.
- d. Employer matching and nonelective contributions may be made at the employer's discretion. An employee must have worked at least 1,000 hours during the plan year and be employed as of the last day of the year to be eligible to receive these contributions. No such contributions were made in 2024 or 2023.

Participant accounts - Each participant's account is credited with the participant's elective deferral contributions, rollover contributions, and an allocation of the employer's contributions. Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Participants are allowed to transfer funds between the various investment options and change their deferral percentage on a daily basis.

Vesting - Participants are fully vested at all times in their employee deferral and rollover contributions and related earnings. Upon disability or attainment of early retirement age (defined as 60 with five completed years of service) or normal retirement age (defined as 65) while employed, participants become 100% vested in all contributions.

For employer safe harbor matching contributions, participants vest according to the following vesting schedule.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of early or normal retirement age while employed. Distributions are made in the form of a single lump sum payment. In addition, hardship withdrawals are permitted under the plan. In-service withdrawals can commence upon attaining the age of 59½.

Administrative fees - Certain administrative fees of the plan are paid by the employer. Certain other administrative fees are paid by the plan using plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution and loan fees and nonparticipant directed charges for service, administrative and advisory fees. Nonparticipant directed charges are allocated to the participants on an account value basis.

Forfeitures - Forfeitures may be used to pay administrative fees of the plan or to reduce employer contributions. Forfeitures used to reduce employer contributions were \$31,000 and \$54,000 in 2024 and 2023. Unapplied forfeitures were \$42,000 and \$6,000 as of December 31, 2024 and 2023.

Notes receivable from participants - Participants may obtain a loan from their accounts with approval of the plan administrator. Each participant may generally only have one loan outstanding at any time. The minimum loan amount is \$1,000 and the total outstanding loan cannot exceed the lesser of 50% of the participant's vested account balance or \$50,000. The repayment term generally cannot exceed five years unless used to purchase a primary residence. As of December 31, 2024, loans outstanding had various repayment schedules through September 2031 with interest rates ranging from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

3. PARTY-IN-INTEREST TRANSACTIONS

Voya holds custody of plan investment assets and executes investment transactions, as such, any transactions between the plan and Voya qualify as party-in-interest transactions. In addition, Voya receives revenue from mutual fund service providers for services Voya provides to the funds. This revenue is considered indirect compensation and is used to offset certain amounts that would otherwise be owed by the plan to Voya for its administrative services to the plan.

Notes receivable from participants would also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in all employer contributions and related earnings.

5. INCOME TAX STATUS

The plan adopted a CBIZ pre-approved profit sharing plan that received a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements for the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. The plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) if the plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for uncertain tax positions taken and determined that the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

6. INFORMATION CERTIFIED BY VOYA

Management has obtained certifications from the Voya entities referred to in Note 1, qualified institutions under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the fair values of such as of December 31, 2024 and 2023;
- b. Guaranteed investment contract held and the contract value of such as of December 31, 2024 and 2023;
- c. Dividend and interest income from investments and net appreciation (depreciation) in fair value of investments during 2024 and 2023; and
- d. Contributions to, withdrawals from, purchases, sales and inter-fund transfers between accounts during 2024 and 2023.
