Opinion

NOTE A. DESCRIPTION OF PLAN

The following description of the Aztec Well Servicing Company and Related Companies Medical Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions. Copies may be obtained from the plan sponsor.

1) *General*

Established on August 1, 2007 and subject to the Employee Retirement Income Security Act of 1974 (ERISA), the plan provides health and other benefits to all employees and covered dependents of Aztec Well Servicing Co., Inc., and its wholly owned subsidiaries, Triple S Trucking Company, Totah Rental and Equipment Company, and Roadrunner Fuels, Inc. (collectively, the sponsor). The plan also covers employees of related companies; Basin Disposal, Inc., and Basin Occupational and Urgent Care, LLC.

2) *Benefits*

Employees become eligible beginning the first day of the first calendar month after the employee has completed a consecutive two-month period. Employees are automatically enrolled into the plan. The plan provides fully-insured health benefits (medical, hospital, surgical, major medical, prescription drug, and wellness) to all eligible employees and their covered dependents. The plan also makes available dental, life insurance coverage, prepaid legal, and employee assistance benefits. Benefit expenses are recorded as paid by the plan administrator, adjusted to accrual using a calculation of claims incurred but not reported.

Prior to August 2022, the plan offered self-insured health and dental coverage which was transferred to a fully insured plan. There were no changes to life and legal benefits.

The plan also provides health benefits to participants during periods of unemployment, under the COBRA regulations, providing they pay the calculated total cost of coverage and meet certain other requirements.

Health claims of active participants and eligible dependents are processed by the Plan Administrator, Blue Cross Blue Shield of New Mexico (BCBS). The responsibility for premiums paid to providers is retained by the plan. The plan contains a coordination of benefits provision preventing duplication of benefits, including those provided under Medicare and the Medicare Prescription Drug, Improvement, and Modernization Act of 2003.

3) *Contributions*

For health and dental coverage, the plan sponsor contributes the employer portion of the premiums as billed by the Plan Administrator, Blue Cross Blue Shield of New Mexico (BCBS). Employees currently contribute a minimum of \$355 per month to participate in the medical plan. Employees may also choose to contribute additional amounts to obtain better medical coverage, buy dental, legal, or life insurance, or to extend coverage to eligible dependents. The costs of post-employment benefits (COBRA) coverage are paid by the covered participant.

4) *Administrative expenses*

Administrative expenses incurred by the plan are routinely paid by the plan.

5) *Stop loss coverage*

Prior to August 2022, when the plan was self-insured, the plan had entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). The final stop-loss settlement report issued in October 2023 indicated that no further reimbursements would be due to the plan as a result of the termination.

Total stop loss reimbursements were \$0 for the years ending December 31, 2024 and 2023, respectively.

6) *Plan modification or termination*

The plan sponsor has the right under the plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the plan subject to the provisions set forth in ERISA. The plan sponsor has discussed the potential termination of the plan in the future, however, no formal decision has been made, and no official plan of termination has been established as of the date of this report. In the event of a plan termination, the plan sponsor would be responsible for the satisfaction of any plan liabilities.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1) *Basis of accounting*

The financial statements of the plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain amounts and disclosures. Actual results could differ from those estimates.

Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 presentation.

2) *Fixed assets*

During 2009, plan trustees created a fitness facility including exercise equipment for use by its participants. Depreciation of these assets is calculated using straight-line methods over estimated useful lives. Accumulated depreciation was \$357,729 in 2024 and \$354,609 in 2023.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

3) *Benefit obligations*

In response to the self-insured plan termination on July 31, 2022, the plan had agreed to a 12-month runout period ending July 31, 2023. This meant that claims incurred prior to the termination date of July 31, 2022 would not be evaluated for payment if the claim is presented subsequent to July 31, 2023. The plan was liable for medical and dental claims incurred of \$0 for the years ending December 31, 2024 and 2023. The plan will not be liable for any further medical or dental claims incurred during the self-insured plan coverage period.

4) *Timing of contributions into the plan and premiums paid to service providers*

Premiums for health, dental, life insurance, and prepaid legal are funded through payroll deductions from employee wages. These deductions are typically withheld one month in advance of the premiums due date to the respective insurance providers. As a result, at the end of the period, there are timing differences between when the payroll deductions were collected from employees and when the corresponding premiums are remitted to the insurance providers.

All receivables and payables related to these transactions have been appropriately recorded in the accompanying financial statements. Amounts withheld but not yet remitted to the providers totaled \$0 at December 31, 2024 and 2023, while amounts collected in advance for future coverage periods are reflected in contributions receivable.

5) *Subsequent events*

The plan is required to recognize the effect of all material subsequent events which provide additional evidence about conditions that existed at the financial statement date, December 31, 2024. The plan has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued. Effective August 1, 2025, the plan transitioned its health insurance coverage from Blue Cross Blue Shield of New Mexico to Presbyterian Health Plan, Inc. This change was made to better align with the plan sponsor's cost management goals and to enhance the benefits offered to employees. No further subsequent events requiring disclosure were noted.

NOTE C. INCOME TAX STATUS

The Internal Revenue Service has determined and informed plan management by a letter dated June 4, 2008, that the plan and related trust were designed in accordance with applicable section 501(c)(9) of the Internal Revenue Code (IRC). The trust has been amended since receiving the determination letter. However, the plan's administrator and the plan's tax counsel believe that the trust is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the plan's financial statements. In addition, the plan administrator believes the plan is no longer subject to income tax examinations for years prior to 2021.

NOTE D. RELATED PARTY TRANSACTIONS

The plan accrued fees totaling \$54,852 and \$79,130 due to the plan sponsor during 2024 and 2023, respectively, to reimburse administrative expenses. As of December 31, 2023, the plan had recorded a liability of \$66,150 related to these fees and was included in accounts payable. As of December 31, 2024, the plan had moved all amounts due to the plan sponsor into the related party note payable shown on the accompanying financial statements.

The related party note payable as shown on the accompanying financials statements is due to Aztec Well Servicing Company, the plan sponsor, at 0% interest, due in December 2027. The balance totaled \$2,437,170 and \$2,267,792 as of December 31, 2024 and 2023, respectively.

In November 2008, a licensing agreement was signed between the plan and the plan sponsor for the use of a building owned by the plan sponsor for use as an exercise facility. The sponsor will retain title to the building and the underlying real estate. The plan is responsible for remodeling the building, if applicable, and retains ownership of the improvements. The exercise facility was placed in service in June 2009. Basin Occupational and Urgent Care, LLC (BOUC) took over management of the facility during 2010 and pays for any improvements or maintenance. The facility is open to substantially all sponsor employees. The plan sponsor paid BOUC \$173,180 and \$168,000 to operate the facility during the years ending December 31, 2024 and 2023. No fees are charged to the plan.

NOTE F. RISKS AND UNCERTAINTIES

The present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE G. CONCENTRATIONS OF CREDIT RISK

The plan had \$0 of uninsured deposits in financial institutions as of December 31, 2024 and 2023 under the FDIC's general deposit insurance rules. These amounts are uninsured and uncollateralized and exposed to custodial credit risk.

NOTE H. CONTINUED LOSSES

The plan sponsor has suffered recurring losses from operations resulting in a decrease in employees and plan participation, which in turn reduced employee contributions and has resulted in a negative equity position for the plan. In light of the changes to the VEBA during 2022, and the related decrease in fees to be received, management of the plan sponsor has not yet developed a plan for the repayment or forgiveness of the obligations of the plan.

SUMMARY ANNUAL REPORT

This is a summary of the annual report of the Aztec Well Servicing Company and Related Companies Medical Plan Trust Fund, EIN 74-6559303 for January 1, 2024 through December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan's medical, pharmaceutical, and dental benefits were fully insured during 2024. The plan has an administrative contract with Blue Cross/Blue Shield of NM to pay medical and pharmaceutical claims and with Delta Dental to pay dental claims incurred under the terms of the plan.

The plan provides life insurance benefits that are fully insured under a contract with Fort Dearborn Life Insurance Company, prepaid legal services under a contract with Titus & Murphy Prepaid Legal, and employee assistance benefits under a contract with Blue Cross/Blue Shield of NM Behavioral Health Unit.

Total premiums and administrative fees paid by the plan to service providers were \$1,706,932.

Basic Financial Statement

The value of the plan assets, after subtracting liabilities of the plan, was \$(2,318,213) as of December 31, 2024, compared to \$(2,172,977) as of January 1, 2024. During 2024, the plan experienced a decrease in its net assets of \$145,236. This decrease includes unrealized appreciation and depreciation in the value of the plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During 2024, the plan had total income of \$1,658,660, which were all sponsor and participant contributions. Plan expenses were \$1,803,896. These expenses included \$15,660 in benefits paid on behalf of participants and beneficiaries, \$1,654,666 in health and dental insurance premiums, \$34,725 in life insurance premiums, and \$98,845 in total plan administration expenses. Administration expenses include administrative fees, premiums, depreciation, and professional fees.
