## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### NOTE 1: DESCRIPTION OF PLAN

The following description of the West Yost & Associates Profit Sharing 401(k) Plan (the "Plan") provides only summarized general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan, established January 1, 1990, is a qualified defined contribution plan covering all eligible employees of West Yost & Associates, Inc. (the "Plan Sponsor"), who have attained the age of twenty-one (21). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). A committee appointed by the Board of Directors of the Plan Sponsor acts as the Plan Committee. Principal Trust Company serves as the Plan trustee.

The Plan was amended effective January 1, 2024 to incorporate past amendments and comply with tax and regulatory requirements.

#### **Plan Year**

The Plan year begins January 1<sup>st</sup> and ends December 31<sup>st</sup>.

#### **Contributions**

The Plan allows for the following types of contributions:

- **Employee Salary Deferral 401(k) Contributions**  
The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Internal Revenue Code (the "Code"). Employees may voluntarily contribute from 1% to 100% of their eligible wages, subject to various nondiscrimination tests and limitations prescribed by the Code. Employees are automatically enrolled into the Plan upon meeting eligibility requirements. The automatic contribution rate is 6% and increases by 1% on January 1 of each year up to 10%. Employees may affirmatively opt out of automatic enrollment and/or automatic escalation and/or voluntarily contribute a different percentage of their wages. Employees are also eligible to make after-tax elective salary deferral contributions.
- **Employer Discretionary Matching Contributions**  
The Plan Sponsor may make discretionary matching contributions in an amount determined by the Plan Sponsor. During 2024, the Plan Sponsor made discretionary matching contributions in an amount equal to 100% of participant elective deferrals that were over 1% but were not over 6% of participants' compensation.
- **Employer Discretionary Contributions**  
The Plan Sponsor may make a discretionary profit sharing contribution in an amount determined by the Plan Sponsor. Participants must complete 1,000 hours of service during the Plan year and be employed with the Plan Sponsor on the last day of the Plan year to be eligible to receive a profit sharing contribution. The Plan Sponsor elected not to make a profit sharing contribution to the Plan for the year ended December 31, 2024.
- **Employee Rollover Contributions from Another Qualified Plan**  
Participants may make rollover contributions from another qualified plan.

*NOTE 1:* **DESCRIPTION OF PLAN (Continued)**

**Participant Accounts and Allocations**

The Plan provides various investment fund options and allows participants to direct their investments. Participant accounts are credited with the participant's contributions and an allocation of Plan Sponsor contributions, earnings and losses and plan expenses, as defined by the Plan document. Investment earnings and losses are allocated to participants' accounts based on the earnings and losses of the investments selected. The benefit to which a participant is entitled is limited to the vested interest in the participant's individual account.

**Forfeitures**

Forfeitures may be used to pay for plan expenses or to reduce employer contributions. Forfeitures of \$61,773 were used to reduce employer contributions funded during the year ended December 31, 2024. The balance in the forfeiture account totaled \$0 and \$61,068 at December 31, 2024 and 2023, respectively.

**Vesting**

Participants are always 100% vested in their salary deferral and rollover contributions. Employer discretionary contributions and gains/losses credited thereon, vest as follows:

Less than 1 year of credited service	0%
After 1 year of credited service	20%
After 2 years of credited service	40%
After 3 years of credited service	60%
After 4 years of credited service	80%
After 5 years of credited service	100%

For vesting purposes, a year of service is defined as a calendar year during which an employee completes at least 1,000 hours of service.

Additionally, a participant's interest in their respective account becomes 100% vested when the participant (a) attains normal retirement age while employed by the Plan Sponsor, (b) becomes disabled while employed by the Plan Sponsor, or (c) dies while employed by the Plan Sponsor.

**Retirement**

Normal retirement under the Plan is age sixty-two (62).

**Payment of Benefits**

Payment of benefits may be made at the following times under the Plan: 1) normal retirement, 2) termination of employment of the participant, 3) termination of the Plan, 4) upon demonstration of financial hardship, 5) in-service withdrawals after attaining the age of 59 ½, or 6) death or disability of the participant. Participants with vested account balances of \$5,000 or less will receive a lump-sum payment. Participants with vested account balances greater than \$5,000 may elect to leave their account in the Plan, receive a lump-sum payment, or receive installment payments over a period of time not to exceed the participants assumed life expectancy.

**Administrative Expenses**

Administrative expenses are paid by the Plan and the Plan Sponsor. Expenses related to specific participant transactions are charged to the respective participant's account.

*NOTE 1:* **DESCRIPTION OF PLAN (Continued)**

**Notes Receivable from Participants**

The Plan allows participants to borrow from their accounts. Participants may borrow an amount equal to 50% of the participants' vested account balance up to a maximum of \$50,000. Borrowings bear interest at rates established by the Plan's administrator and are due within five years unless the loan is taken for the purchase of a primary residence, which may permit longer repayment terms. A participant may only have one outstanding loan at any given time. Principal and interest is paid ratably through bi-weekly payroll deductions.

*NOTE 2:* **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are maintained on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (U.S. GAAP).

**Investment Valuation and Income Recognition**

The Plans investments are reported at fair value and contract value. Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in net appreciation in fair value of investments. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year. Changes in the unit values of investments are reflected in each participant's individual account. Investments are valued daily.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principle balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits**

Benefits to participants are recorded when paid.

**Income Taxes**

The Plan has adopted a prototype plan which obtained a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan is acceptable under Section 401 of the Code. That Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Income Taxes (Continued)**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has determined that as of December 31, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine examinations by taxing authorities; however there are currently no examinations for any tax periods in progress.

**Estimates and Assumptions**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**NOTE 3: INFORMATION CERTIFIED BY THE TRUSTEE**

**NOTE 4: FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) ASC 820 provides a framework for measuring fair value. That framework provides a three-tier hierarchy that prioritizes the inputs to valuation techniques used for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, model-based valuation techniques for which all significant assumptions are observable in the market, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and have a readily determinable fair value.

*Common collective trust funds and Pooled separate accounts:* Invest mainly in mutual funds, primarily target date funds. The majority of the underlying assets have Level 1 quoted pricing inputs and observable Level 2 pricing inputs, including quoted prices for similar assets in active markets.

*Stable value collective trust fund:* Valued at the NAV of units of a bank collective trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The NAV is published daily by the trustee. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly business manner.

**NOTE 5: GUARANTEED INVESTMENT CONTRACT**

Plan investments include an investment in a fully benefit-responsive investment contract with Principal Life Insurance Company (Principal Life). Principal Life maintains participant contributions to the fund in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

**NOTE 5: GUARANTEED INVESTMENT CONTRACT (Continued)**

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. As of December 31, 2024 and 2023, the contract value of the fully benefit responsive investment contract was \$0 and \$1,164,602, respectively. Participants may ordinarily direct the withdrawals or transfer all, or a portion of, their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Interest is credited to the fixed account at an annual effective yield that is at least equal to the minimum guaranteed interest rate in the investment contract.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spinoffs, divestitures, layoffs, corporate relocation, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring. The guaranteed investment contract permits the insurance company to terminate the agreement prior to the scheduled maturity date after five completed contract years.

**NOTE 6: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE 7: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 8: RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments include a guaranteed investment contract issued and managed by an affiliate of the trustee. Plan assets also include notes receivable from participants. Administrative expenses are paid to the trustee for certain investment advisory services, recordkeeping and trustee fees. Indirect compensation for investment management services are recorded in appreciation (depreciation) in the fair value of investments. These transactions and investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

*NOTE 9:*    **SUBSEQUENT EVENTS**

Plan management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 8, 2025, the date the financial statements were available to be issued, and Plan management has determined that no subsequent events have occurred that should be disclosed.
