Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of VWR Advanced Instruments Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Responsibilities of Management for the Financial Statements for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

2024 Supplemental Schedule Required by ERISA

The supplemental schedules of Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. Their report dated October 15, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 - Description of Plan

The following description of VWR Advanced Instruments Profit Sharing Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan document for a more complete description.

General

The Plan was established on June 1, 1989 as a defined contribution plan covering all eligible employees of VWR Advanced Instruments, LLC (the Company or Sponsor). Effective January 1, 2011, the Plan was amended to bring the Plan in compliance with the qualification requirements of 2011 Puerto Rico Internal Revenue Code (PR Code). Subsequent to this date, certain additional amendments have been made, as follows:

- Effective September 20, 2017, the Plan Document was amended to include financial need by reason of Hurricane María as an acceptable reason for in-service withdrawals, as well as lump sum distributions to terminated participants and/or their beneficiaries as provided for in Administrative Determination No. 17-29 issued on November 15, 2017 by the Puerto Rico Treasury Department.
- Effective November 15, 2017, the Plan Document was amended to modify the definitions of the terms "compensation" and "pay".
- Effective February 20, 2020, the Plan Document was amended to establish the rules and procedures applicable to the Plan upon declared disasters in Puerto Rico to which participants may withdraw savings from their account to cover eligible expenses and losses pursuant to applicable law and Puerto Rico Treasury Department guidance.
- On March 10, 2021, the Benefits and Retirement Plan Committee approved changes to the Plan to allow participants affected by FEMA-declared disasters, up to February 2021, to take temporary in-service distributions up to \$100,000 or loans not to exceed 100% or \$50,000 (not applicable to Coronavirus COVID-19).
- On September 27, 2022, Administrative Determination No. 22-08 was issued by the Puerto Rico Treasury Department allowing financial hardship withdrawals by reason of Hurricane Fiona, as provided in Section 1081.01 (b)(1)(D) and 1081.02 (d)(1)(l) of the Puerto Rico Internal Revenue Code of 2011.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General – (continued)

There were 114 and 105 participants with account balances in the Plan as of December 31, 2024 and 2023, respectively.

Effective June 2021, the Plan changed service providers from Wells Fargo Bank, N.A. (Wells Fargo), the former custodian of the Plan, to Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), the current custodian of the Plan.

Eligibility

To be eligible to participate in the Plan, an employee must complete 30 calendar days of employment and be a resident of Puerto Rico.

Contributions

Each year, participants may contribute up to \$15,000 of pretax annual compensation, as established by Act No. 1 of January 31, 2011 of the PR Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$1,500.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). Participants direct all or a portion of the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, money market accounts, and collective trust funds as investment options for participants.

Effective January 1, 2011, new eligible employees are subject to an automatic enrollment feature. These employees are automatically enrolled to contribute 4% of their eligible compensation, unless the employee has affirmatively elected a different contribution level or not to contribute to the Plan.

The Sponsor matches 100% of the first 4% of eligible compensation that a participant contributes to the Plan. Additional performance-based contributions may be made, if the Sponsor meets certain financial goals for a year, as determined by the Sponsor's sole and absolute discretion.

Participants' Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions and the Sponsor's matching contributions, as well as, allocations of the Sponsor's profit sharing and additional amounts, if any, the Plan's earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant's earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary and Sponsor's contributions.

Notes Receivable from Participants

Participants may apply for a loan of up to \$50,000 or 50% of their vested account balance, whichever is less. The minimum amount of each loan is \$1,000. Loan terms are up to five (5) years, are secured by the balance in the participant's account, and bear a fixed rate of interest set at one percentage point higher than the prime rate when the loan is made. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, all outstanding loans bore interest rates from 4.25% to 9.50% and maturities through April 2029.

Payment of Benefits

Upon retirement, termination of service, disability, or death, a participant (or participant's beneficiaries in the event of death) may receive the value of the participant's vested interest in his or her account in either a lump-sum amount, or in annual periodic installments over a period not to exceed ten (10) years or, if less, the joint life expectancy of the participant and his or her designated beneficiary. In-service withdrawals will be allowed in the case of attainment of age 59 ½ or in the case of financial hardship, subject to certain rules as described in the plan document.

Forfeited Accounts

Forfeitures of performance-based, and/or matching contributions will be used to pay Plan's administrative expenses or to reduce performance-based, and/or matching contributions. At December 31, 2024 and 2023, there were no forfeited non-vested accounts.

Note 2 - Summary of Significant Accounting Policies

Basis of accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis of presentation

The Plan's fiscal year ends on December 31st of each year. All references to years in these notes to the financial statements represent calendar years then ended unless otherwise noted.

The Plan has evaluated subsequent events through September __, 2025, the date the financial statements were available to be issued.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's investments, other than investments in collective trust funds, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability, in an orderly transaction between market participants at the measurement date.

Collective trust funds are stated at fair value using the net asset value (NAV) per unit in each fund. The NAV is based on the fair value of the underlying investments owned, minus its liabilities, divided by the number of shares outstanding. See Note (5) for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of benefits

Benefit payments to participants are recorded upon distribution.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments, presented in the accompanying statement of changes in net assets available for benefits.

Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 3 - Information Certified by the Custodian of the Plan

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the investments and notes receivable from participants information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information

obtained by the Plan administrator and certified as complete and accurate by Principal, qualified institution, and in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Principal, the custodian of the Plan, held the Plan's investment assets and executed investment transactions as of December 31, 2024 and 2023 and for the year from January 1, 2024 to December 31, 2024.

Information obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal:

- Investments (at fair value and net asset value), and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024, as follows:
 - Net appreciation in fair value of investments in the amount of \$734,531
 - Interest and dividend income in the amount of \$240,114
 - Interest income on notes receivable from participants in the amount of \$18,398
- The information for all investments and the participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024 as shown in the ERISA-required supplemental schedule.

Note 4 - Collective Trust Fund

The Plan participates in a Common Collective Investment Fund, through its investment in Great Gray Trust Euro Pacific Growth, MFS Investment Management – MFS Mid Cap Growth Fund Class CT, and Reliance Trust Company – Reliance Trust New York Anchor Account – Series 1 collective trust funds sponsored by the Custodian. The Custodian maintains the contributions in a separate trust, which is credited with participant contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expense. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment.

Note 5 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Note 5 - Fair Value Measurements – (continued)

The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the assets or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued using the NAV practical expedient per unit in each fund. The NAV practical expedient is based on the value of the underlying investments owned by each trust, minus its liabilities, divided by the number of shares outstanding. The investments provide daily redemptions by the Plan with no advance notice requirements, and have redemption prices that are determined by the fund's NAV practical expedient per unit as of the redemption date.

Note 5 - Fair Value Measurements – (continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024 and 2023, there was no transfer in or out of levels 1, 2, or 3.

Note 6 - Party-in-Interest Transactions

During 2024 and 2023, certain Plan investments included common collective trusts managed by affiliates of Principal. Principal also provides recordkeeping and custodial services for which the Plan, these transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

The Plan allows participants to borrow from their fund accounts and, therefore, these loans qualify as party-in-interest transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8 - Administrative Expenses

The trustee, custodian and the recordkeeper of the plan receive an administrative fee for the services performed under the Plan agreement. The fee of administering the Trust and the Plan shall be payable by the Plan, unless paid for by the Sponsor. Administrative fees paid by the Plan Sponsor during the year ended December 31, 2024 amounted to \$11,059.

Note 9 - Tax Status

The Plan has received its latest determination letter from the Puerto Rico Treasury Department (PRTD) date February 15, 2019, stating that the Plan is qualified under Section 1081 of the PR Code, and therefore, the related trust is exempt from taxation. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the PR Code.

Management has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements.

Note 10 - Excess Contributions Payable

The Plan passed the Average Deferral Percentage (ADP) test for the year ended December 31, 2024. For the year ended December 31, 2023, the Plan did not pass the ADP test. As a result, excess participant contributions amounting to \$5,845 were recorded as a liability in the accompanying statement of net assets available for benefits as of December 31, 2023. These excess contributions were reimbursed to the applicable Plan participants during June 2024.

Note 11 - Subsequent Events

The Plan has evaluated subsequent events through September __, 2025, the date the financial statements were available to be issued. As of this date, no events have occurred subsequent to the statement of net assets available for benefits date and to the date these financial statements were available to be issued, that would require additional adjustment to, or disclosure in, the financial statements.
