**1. Summary of significant accounting policies**

The following is a summary of the significant accounting policies followed by Kahala Brands 401(k) Plan (the Plan) which is sponsored by Kahala Brands Inc. (the Company). The policies conform with accounting principles generally accepted in the United States of America, which require management to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

**a. Investments**

Mutual funds are stated at fair value based on the quoted market prices. Purchases and sales of securities are recorded on a trade-date basis and interest income is recorded on an accrual basis. Most investment options have management fees that reduce the overall return on assets. Net appreciation (depreciation) is inclusive of those fees.

A self-directed brokerage account option is also available to allow participants to select investment options not specifically offered by the Plan. Self-directed brokerage accounts include investments in cash and cash equivalents and common stocks. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded.

**b. Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**c. Investment and administrative expenses**

Investment expenses are paid directly by the Plan, and some administrative expenses are paid by the Company. However, the Company retains the right to discontinue paying expenses, in which case the expenses will be paid by the Plan.

**d. Income taxes**

The Plan is utilizing a non-standardized pre-approved document sponsored by FMR LLC. The document sponsor received a favorable determination letter dated June 30, 2020 from the Internal Revenue Service, which states that the Plan qualifies under the applicable provisions of the Internal Revenue Code.

The Plan has been amended since adopting the document, however the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. As such, the Company is not required to obtain a tax determination letter specific to this Plan. Therefore, no provision for income taxes has been included in the Plan's financial statements. However, the Plan is subject to examination; generally for a period of three years from filing its Form 5500.

**d. Income taxes, continued**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**e. Concentrations of risk**

The Plan provides for various investment fund options, which in turn invest in any combination of mutual funds and other investments. Investments are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the changes in net assets available for benefits.

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**a. General**

The Plan, established October 1, 1992, is a defined contribution 401(k) plan covering employees who are age twenty-one or older. Effective January 1, 2024, the Plan was amended to change eligibility to completion of six months of service with Plan entry on the first of the month following completion of eligibility. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

**b. Contributions**

Each participant may make salary deferral and Roth contributions of up to 100% of his/her annual compensation, not to exceed the annual deferral limit set by the Internal Revenue Code. Catch-up contributions are permitted for participants age 50 and older. The Plan also allows participants to make rollover contributions.

The Company made a safe harbor matching contribution equal to 100% of each participant's salary deferral contribution up to the first 3% of the participant's eligible compensation and 50% of each participant's salary deferral contribution up to the next 2% of the participant's eligible compensation. The Company contributed safe harbor matching contributions of \$747,305 in 2024 and \$726,397 in 2023, net of forfeitures.

The Company may also make a discretionary contribution to all eligible participants. The exact percentage or amount is determined annually by the Company. For the plan years ended December 31, 2024 and 2023, the Company did not make discretionary contributions to the Plan.

**c. Vesting**

Each participant is immediately vested in his/her salary deferral, catch-up, rollover contributions, Company safe harbor matching contributions, and any earnings or losses on those contributions. The remainder of a participant's account balance is vested based on years of service. Participants vest at 20% after two years of service, and the percentage increases by 20% annually until the participant is fully vested after six years of service.

Forfeitures may be used to pay Plan expenses or reduce the employer's contributions. The balance of the forfeiture account as of December 31, 2024 and 2023 was \$392 and \$221, respectively. For plan year ended December 31, 2023, forfeitures of \$3,224 were used to reduce employer contributions.

**d. Participant accounts**

Each participant's account is credited with the participant's salary deferral, catch-up, and rollover contributions, Company matching and discretionary contributions, and Plan earnings/losses. Plan earnings/losses are allocated based on account balances, as defined in the Plan document.

Each participant directs the investment of his/her account into various investment options offered by the Plan through Fidelity Management Trust Company.

**e. Payment of benefits**

Each participant is entitled to Plan benefits equal to 100% of his/her vested account balance. Benefits begin upon the earliest of retirement age, termination of employment, total and permanent disability or death of the participant. Benefits are paid in a lump-sum or partial payments as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable. The Plan permits hardship and in-service distributions under certain circumstances.

**f. Loans**

The Plan permits participants to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates of 4.25% to 9.50%, which is commensurate with the prevailing interest rate charged on similar loans. Principal and interest are paid ratably through payroll deductions.

**g. Plan termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant will become fully vested in his/her account.

**3. Information certified by the Custodian (unaudited)**

At December 31, 2024 and 2023, the Plan's assets were held by Fidelity Management Trust Company (the Custodian). **4. Fully benefit-responsive contract**

The Plan entered into a benefit-responsive investment contract with Fidelity Management Trust Company (Fidelity). Fidelity maintains the contributions in general accounts. The stable value fund issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the stable value fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the stable value fund. Contract value, as reported to the Plan by Fidelity, represents contributions made under the contract, plus earnings, less participant withdrawals and applicable expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events that are not in the ordinary course of fund operations may limit the ability of the Plan to transact at contract value with the issuer. The Plan administrator does not believe that the occurrence of any events, which would limit the Plan's ability to transact at contract value with participants, is probable.

**5. Fair value measurements**

Financial Accounting Standards Board Accounting Standards Codification 820, Fair Value Measurements (FASB ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include 1) quoted prices for similar assets or liabilities in active markets, 2) quoted prices for identical or similar assets or liabilities in inactive markets, 3) inputs other than quoted prices that are observable for the asset or liability, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: valued at the net asset value (NAV) based on quoted market prices in an active market of shares held by the Plan at year end

Self-directed brokerage accounts: Accounts primarily consist of common stock and cash equivalents that are valued on the basis of readily determinable market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**7. Party-in-Interest transactions**

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Certain Plan investments are shares of mutual funds managed by the Custodian. The Plan issues loans to participants, which are secured by the balance in the participant's account. Such transactions are party-in-interest and related party transactions for which a statutory exemption exists.

**8. Subsequent Events**

Management reviewed the financial statements for subsequent events through September 24, 2025, the date the financial statements were available to be issued.

Effective February 1, 2025, Wetzel's Pretzels, LLC 401(k) Profit Sharing Plan and Trust was merged into the Kahala Brands 401(k) Plan and Wetzel's Pretzels, LLC was added to the Plan as a participating employer.
