### Opinion

We have audited the accompanying financial statements of Operative Plasterers' and Cement Masons' International Association, Local No 394 Defined Contribution Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

**NOTE A – DESCRIPTION OF PLAN**

The following description of the Operative Plasterers' and Cement Masons' International Association, Local Union No. 394 Defined Contribution Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Plan was adopted January 1, 1987 under an agreement between Arizona Building Contractors, Building Chapter, Associated General Contractors (Association) and Operative Plasterers' and Cement Masons' International Association, Local Union No. 394 (Labor Union). The Plan is one of two Plans covered by the related Trust Agreement. The other Plan is a Defined Benefit Plan, which was "frozen" as of December 31, 1986. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration of the Plan is the responsibility of the Board of Trustees (Trustees) and is governed by a joint board consisting of equal representation from the Associations and the Labor Unions.

**Contributions** – The Plan is funded by contributions from employers who are engaged in the construction industry in Arizona and who are signatory to the collective bargaining agreement(s). These contributions are based on a specific amount for each hour worked by covered employees.

**Participant accounts** – Each participant's account is credited with the contributions made on behalf of the participant, plus investment earnings (loss), determined as of the preceding valuation date prior to the payment date, minus the participant's share of administrative expenses of the Plan.

**Vesting** – Participants are immediately vested in their contributions and income thereon. However, if the participant's individual account is less than \$100 on the preceding valuation date, the participant's individual account and the contributions made to the account shall be forfeited and used to defray operating expenses of the Plan. Benefits are payable upon termination of employment, retirement, disability or death. Upon death, the participant's accumulated share will be paid to the surviving spouse or designated beneficiaries.

**Payments of benefits** – Retirement, disability and death benefits are the sum of the benefits that can be provided from the participant's accumulated share. The participant's account balance will be paid as follows: (1) all accounts with a balance of less than \$5,000 will be paid in a lump-sum, (2) account balances over \$5,000 are entitled to be paid by any of the following methods, upon election by the participant in writing: (a) an annuity contract which provides for income payable over a period of years certain or for the lifetime of the participant or spouse in the event of the participant's death; (b) a lump-sum payment; (c) a combination of forms (a) and (b) above, using whatever proportion of the participant's share that the participant may elect. If a participant retires at any time after the age of 55 or becomes disabled at any age, the participant will, upon application, be eligible to receive payment of his accumulated share.

**Forfeited accounts** – If the sum of a participant's account on the last preceding valuation date does not total \$100, then the participant's account is forfeited.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following are the significant accounting policies followed by the Plan.

**Basis of accounting** – The accompanying financial statements are prepared on the accrual basis of accounting. Under this method of accounting, additions and deductions to net asset available for benefits are identified with specific periods of time and are recorded as earned and incurred, respectively, without regard to the date of receipt or payment.

The Plan maintains its financial records using the modified cash method of accounting, under which additions and deductions to net assets available for benefits are recognized when measurable and available to finance expenditures of the current period. Expenditures are generally recorded when the liability is paid. Adjustments are prepared at each year end to adjust the financial records to the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities; and changes therein, disclosure of contingent assets and liabilities; and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions** – Contributions are recorded during each year based upon hours reported by employers. Employers' contributions receivable is based upon actual contributions received subsequent to December 31, for hours worked prior to December 31; therefore, there is no allowance for uncollectible receivables. No provision has been made for subsequent receipt of additional delinquent monies covering hours worked during December or prior months, as the financial effect is expected to be immaterial. Employer contributions are due by the 15<sup>th</sup> of the month following the month in which the hours were worked. Amounts not paid by then are deemed delinquent.

**Payment of benefits** – Benefit payments to participants are recorded upon distribution.

**Administrative expenses** – Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. The Plan shares certain administrative expenses with a related pension plan. In computing these allocated costs, various factors were considered, including the net assets of each plan in relation to the other plan (see Note G).

**Subsequent events** – The Plan's management has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

**NOTE C – PRIORITIES UPON PLAN TERMINATION**

Although there has not been any expressed intent to do so, in the event of termination of the Plan, each participant shall have a non-forfeitable right in the assets then remaining. After the payment of all operating expenses and benefits previously approved, the remaining assets will be distributed to the participants. Each participant will receive that portion of the total remaining assets in the same ratio as his account bears to the aggregate amount of all participants' accounts. No part of the assets shall be returned to any employer or inure to the benefit of any employer or union.

**NOTE D – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2    Inputs to the valuation methodology include
  - Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other meansIf the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3    Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Cash and equivalents* – Valued at the closing price reported on the active market on which the individual securities are traded.
- *Exchange traded funds* – Valued at the closing price reported on the active market on which the individual securities are traded.

During the year ended December 31, 2014, the Plan sold all holdings of the Fundamental Limited Partnership (FLP) account. However, a portion of the redemption amount was withheld in an illiquid side pocket consisting of a percentage ownership in one security FLP holds and a limited partnership interest in a hedge fund. FLP's auditor concluded that the security and hedge fund be deemed worthless in 2014, on both a book and tax basis, as a result of corporate events that transpired in December 2014. However, in February 2015 a buyer of those assets gave "kicker" shares and warrants to old investors. The value of the Plan's capital balance increased in February 2015 to \$58,465 to reflect the value of those kicker shares and warrants. The final value of the side pocket will be returned to the Plan when the securities become liquid and can be sold. As of December 31, 2024 and 2023, the trustees have determined the fair value of these obligations to be worthless.

**NOTE E – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The Plan's checking account and trust account for investments are presently with one bank.

**NOTE F – TAX STATUS**

The Plan obtained its latest determination letter on September 14, 2012, in which the Internal Revenue Service states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

The Plan pays fees for several arrangements with service providers. These transactions are considered exempt party in interest transactions under ERISA.

The Plan shares certain operating expenses with the Operative Plasterers' and Cement Masons' International Association, Local No 394 Pension Trust Fund. Each plan pays its own pro-rata share of operating expenses.
