NOTES TO FINANCIAL STATEMENTS

## 1. Plan Description

The following description of Propeller 401(k) Profit Sharing Plan Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan's most recent restatement was effective October 5, 2020.

### General

The Plan is a defined contribution plan. The Plan covers all employees of Propeller (the Employer) who are at least 21 years old, excluding union employees and non-resident aliens with no earned United States source income. There is no service requirement for employee contributions or Employer matching. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

### Contributions

Eligible participants may elect annually to contribute, on a pre-tax basis or post-tax (Roth) basis designated as Roth elective deferrals, up to 92 percent of their annual compensation, limited to amounts provided by the Internal Revenue Code (IRC). Individuals who attain age 50 by the end of the Plan year are eligible to make additional "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations.

In accordance with Plan provisions, the Employer will make a nondiscretionary matching contribution equal to 50 percent of a participant's elective deferrals up to 6 percent, with a maximum contribution of 3 percent of a participant's eligible compensation. The Plan also allows the Employer to make a discretionary nonelective contribution each year for participants with one year and 1,000 hours of service. There were no discretionary nonelective Employer contributions for the years ended December 31, 2024 and 2023.

Upon enrollment in the Plan, a participant may direct contributions in any investment option provided by the Plan. Descriptions of the individual investment options are available from the Plan Administrator. Participants may change investment options at any time.

### Participant Accounts

Each participant account is credited with the participant's and Employer's contributions and an allocation of the Plan earnings and expenses. Participant account balances are updated daily based on account activity and price changes of the investment fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

### Forfeited Accounts

The non-vested portion of a participant's account shall be forfeited if a participant is terminated. These amounts may be used to pay Plan expenses or reduce Employer contributions. During the years ended December 31, 2024 and 2023, \$132,351 and \$96,314, respectively, was forfeited from participant accounts. During the years ended December 31, 2024 and 2023, forfeitures of \$181,296 and \$59,730, respectively were used to pay Plan expenses and reduce Employer contributions, net of earnings. As of December 31, 2024 and 2023, there were unused forfeitures of \$96,728 and \$140,590, respectively.

**1. Plan Description, continued**

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are 100 percent vested in nondiscretionary Employer matching contributions, plus earnings thereon after completing three years of vesting service (based on the elapsed time method) according to the following schedule:

**Payment of Benefits**

Upon retirement, death, disability, or termination, participants (or their beneficiaries) may elect to receive part or all of the vested interest in their accounts in a lump-sum payment. Hardship withdrawals of a participant's deferral contributions balance in the event of immediate and heavy financial need are also allowed as described in the Plan document. In addition, participants may elect to receive withdrawals, at any time, of part or all of the interest in their accounts related to prior rollover accounts. In-service withdrawals are allowed at age 59½, to qualified reservists, or upon disability from all accounts that are fully vested.

**Notes Receivable from Participants**

Participants may borrow a minimum of \$1,000 from their fund accounts or up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Only one loan may be outstanding at any point in time. The loans are secured by the balance in the participant's account and will bear a reasonable rate of interest. Principal and interest will be repaid ratably through monthly payroll deductions over a reasonable period of time, not to exceed five years. Loans for the purchase of a primary residence can be repaid over a period equal to the lesser of 10 years or the repayment period. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

## 2. Summary of Significant Accounting Policies

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 7 for additional information on fair value measurements.

Purchases or sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Expenses of maintaining the Plan are generally paid by the Employer and are therefore excluded from these financial statements. Certain custodial and recordkeeping fees or other related professional fees may be paid from Plan assets. Investment related expenses are included in net change in fair value of investments.

**Recent Accounting Standard Adopted**

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. There are no financial assets held by the Plan as of December 31, 2024 and 2023 that are subject to ASC 326. The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

**3. Investment Information Certified by the Trustee**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Fidelity Management Trust Company, acting as trustee for the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate as of and for the years ended December 31:

**4. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants will become fully vested in their accounts.

**5. Income Tax Status**

The Plan was restated on October 5, 2020 to adopt a Non-Standardized Pre-Approved Profit Sharing Plan with CODA. FMR, LLC, the sponsor of the prototype plan, has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 that the Plan document satisfies IRC Section 401.

**5. Income Tax Status**, continued

The Plan has been amended and restated since receiving the opinion letter. However, Plan management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**6. Party-in-Interest Transactions**

Certain Plan investments are units of registered investment companies managed by Fidelity Investments Institutional, an affiliate of Fidelity Management Trust Company, the trustee of the Plan for the years ended December 31, 2024 and 2023. Fees paid to Fidelity Investments Institutional for administration and recordkeeping from Plan assets for the years ended December 31, 2024 and 2023 totaled \$22,943 and \$23,350, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**7. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**7. Fair Value Measurements**, continued

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Cash equivalents:* Valued at contract value of shares held, which approximates fair value.

*Registered investment companies:* The Plan's investments are units of mutual funds valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered to have a readily determinable fair value.

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

**9. Nonexempt Transactions**

During the years ended December 31, 2024 and 2023, participant contributions and participant loan payments totaling \$-0- and \$990 were not remitted to the Plan within the appropriate time period by the Employer. These transactions constitute prohibited transactions as defined by ERISA. 2023 late remittances were identified and corrected during the plan year ended December 31, 2023, including the calculation and funding of lost earnings. \$625 in late remittances from the plan year ended December 31, 2022 were corrected in January 2024 therefore continue to be reported as late for the year ended December 31, 2024.

**10. Subsequent Events**

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
