***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Winterthur Employee Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1: DESCRIPTION OF PLAN**

The following description of the Winterthur Employee Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan covering eligible employees of The Henry Francis du Pont Winterthur Museum (the “Organization”), an Internal Revenue Code (“IRC”) Section 501(c)(3) organization. The Plan was originally effective January 1, 2006 and most recently restated January 1, 2023. The Plan is intended to meet the requirements of Section 403(b) of the IRC and is structured to comply with the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The custodian and third-party administrator of the Plan is Principal Trust Company.

**Eligibility** - All common-law employees performing services for the Organization are eligible to defer into the Plan immediately. For purposes of the employer-matching contribution, an eligible employee may begin receiving the employer contribution after attaining 21 years of age and after completing one year of service. Entry into the Plan is immediately after meeting such requirements.

**Contributions** - Each year, participants may contribute up to 80% of pre-tax and after-tax Roth annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Eligible participants may also be able to contribute a special Section 403(b) catch-up contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The percentage is increased by 1% each year until it reaches 6% unless otherwise elected by the participant (automatic escalation). The Organization contributes a matching contribution of 50% of elective deferrals up to 3% of compensation. Each year, the Organization may also contribute a profit-sharing contribution of 5% of annual compensation. Contributions are subject to certain IRS limitations.

**Participant’s Accounts** - Each participant’s account is credited with the participant’s contributions and Organization matching contributions, as well as allocations of the Organization’s profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**NOTE 1: DESCRIPTION OF PLAN - CONTINUED**

***Vesting*** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service. The vesting schedule increases 20% each year after two years of service up to six years of service when participants become fully vested in the employer contribution.

***Payment of Benefits*** - On termination of service due to death, disability, or retirement (age 65), or separation of service, a participant may elect to receive his or her benefit in any one of the following optional forms of retirement benefit: (i) a lump sum; (ii) partial payments; or (iii) installment payments. A participant may elect to receive a single sum distribution of the account balance at any time after termination of employment for transfer to a qualified plan of another employer or to an individual retirement account. If a married participant requests a distribution, his or her spouse must consent to any form of distribution from the Plan that is in a form other than a qualified joint and survivor annuity. In-service withdrawals are also permitted for participants who have reached age 59½.

If a terminated participant's account balance does not exceed \$5,000, then a distribution will automatically be paid in a direct rollover to an individual retirement plan designed by the plan administrator without the participant's consent and shall provide written notice to the participant informing the participant that he or she has the option to transfer such amount into another individual retirement plan of his or her own choice.

As required under Section 401(a)(9) of the IRC, a participant, who is not a 5% owner, must begin receiving required minimum distributions from the Plan by April 1 of the calendar year following the later of (i) the calendar year following the year in which the participant reaches age 73, or (ii) the calendar year in which the participant retires.

***Forfeitures*** - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,079 and \$1,219, respectively. These accounts will be used to reduce future employer contributions or pay administrative expenses. During 2024, \$75,218 of forfeitures were used to reduce the employer contribution.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting*** - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution attributable to fully-benefit responsive contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

*Use of Estimates* - The preparation of financial statements, in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* - Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Organization determines the Plan's valuation policies utilizing information provided by the investment advisors, recordkeeper, and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Contributions* - Contributions from Plan participants and the matching contributions from the Organization are recorded in the year in which the employee contributions are withheld from compensation.

*Payment of Benefits* - Benefits are recorded when paid.

*Administrative Expenses* - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

*Subsequent Events* - The Organization's policy is to evaluate events and transactions subsequent to its year end for potential recognition in the financial statements or disclosure in the notes to the financial statements. The Organization has evaluated events and transactions through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

**NOTE 3: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under the Financial Accounting Standards Board's Accounting Standards Codification (FASB ASC) 820, *Fair Value Measurements*, as described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liabilities; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used as of December 31, 2024 and 2023.

***Registered Investment Companies (Mutual Funds)*** - Valued as the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 within the fair value hierarchy.

**NOTE 5: GUARANTEED ANNUITY CONTRACT**

The Plan holds a traditional fully benefit-responsive investment guaranteed annuity contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Because the guaranteed interest contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest contract. The guaranteed interest contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported by Principal, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Principal Fixed Income Guaranteed Option held by the Plan is a group annuity contract that is backed solely by the claims-paying ability of Principal Life Insurance Company. The crediting rate is the rate declared in the applicable vintage schedule for the period for that vintage, unless the rate would be less than the guaranteed rate, in which case it would be the guaranteed rate. The method for calculating the interest crediting rate is determined by solving for the rate that, when used to accrue interest, will result in a value of the sum of certain expected values. Under the terms of the existing contract, the crediting rates currently reset on a semiannual basis and will never be less than the guaranteed minimum interest rate ranging between 1% and 3%. The Plan may transact according to the terms defined in the contract at any time. In general, payments made in accordance with the contract will be made in full, three business days after date of payment or transfer has been requested.

In the event market conditions are such that it is determined that it will not allow for an orderly transfer or sale of financial investments, up to an additional 30 business days may be required to make such payments or transfers. A surrender charge of five percent will be assessed on all transfers by the Organization in excess of 10% of the Organization's accumulated transfer percentage as of the date of transfer.

**NOTE 5: GUARANTEED ANNUITY CONTRACT - CONTINUED**

The key difference between a synthetic investment contract and a traditional investment contract is that the Plan owns the underlying assets of the synthetic investment contract. A synthetic investment contract includes a wrapper contract, which is an agreement for the wrap issuer, such as a bank or insurance company, to make payments to the Plan in certain circumstances. The wrapper contract typically includes certain conditions and limitations in the underlying assets owned by the Plan. With traditional investment contracts, the Plan owns only the contract itself. Synthetic and traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

Market value events may limit the ability of the funds to transact at a contract value with the issuer. Market value events are events or conditions that occur which are outside of the normal operation of the funds and lead to any disbursements which have or will have a material adverse effect on the operations of the funds and a financial effect on the investment contract or wrap issuer's interest hereunder.

Such events may include, but are not limited to: fund administration amended or changed, merger or consolidation of investors, group terminations or layoffs, implementation of an early retirement program, termination or partial termination of the funds, failure to meet certain tax qualifications, participant communication that is designed to influence participants not to invest in the funds, transfers to competing options without meeting the equity provisions of the fund, and plan sponsor withdrawals without the appropriate notice to the funds and/or issuer.

In the normal course of business, such events or conditions would not limit the ability of the fund to transact at contract value with the participants in the fund. The fund is managed to maintain a certain amount of liquidity to provide for the day-to-day liquidity needs of participants as well as the occasional market value event. The Organization does not believe that any events which would limit the fund's ability to transact at contract value with participants are probable.

**NOTE 6: RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Organization has not considered normal plan operations such as participant and employer contributions or benefits paid to participants as party-in-interest transactions that require separate disclosure. Certain plan investments are shares and units of registered investment companies (mutual funds) managed by Principal. Fees paid during the year for certain professional services rendered by parties in interest include service fees paid by the Plan for investment advisory services. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

**NOTE 7: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Organization may determine.

**NOTE 8: TAX STATUS**

The Organization has adopted the underlying Principal Financial Group 403(b) Volume Submitter Plan that has received an advisory letter in which the IRS dated March 31, 2017, stating that the form of the volume submitter plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory letter, the Organization believes that the Plan is designed, and is being currently operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or the IRS. The Organization has analyzed the positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan's federal Form 5500 is subject to examination by the IRS and DOL, generally for the three years after it is filed.

**NOTE 9: RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**NOTE 10: COMMITMENTS AND CONTINGENCIES**

In the normal course of business, there may be various commitments and contingencies outstanding, which are not reflected in these financial statements. In the opinion of the Organization, the outcome of such events, if any, would not have a material effect on the Plan's financial position or operations.
