## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the  
Allpak Container, LLC Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Allpak Container, LLC Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 (in liquidation), and the related statement of changes in net assets available for benefits for the year then ended (in liquidation), and the statement of net assets available for benefits as of December 31, 2023 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Allpak Container, LLC Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Allpak Container, LLC Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of the Allpak Container, LLC Retirement Savings Plan approved a plan of liquidation in 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 - ORGANIZATION AND DESCRIPTION OF THE PLAN**

The provisions of the Allpak Container, LLC Retirement Savings Plan (the Plan) were effective March 31, 1969. The Plan has been amended and restated to comply with current legislation. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

During 2024, Allpak Container, LLC (the Company) authorized the Plan to terminate and merge into the GWPG 401(k) Retirement Plan (GWPG Plan) effective January 1, 2025 (see Notes 2 and 6).

**General**

Prior to termination, the Plan was a defined contribution plan covering substantially all employees of the Company. Employees were eligible to participate in the Plan if they were 18 years of age or older and had completed three months of service. Employees eligible were allowed to begin participation in the Plan on the first day of the month following the date the eligibility requirements were met. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Contributions**

Prior to termination, the plan provided for automatic enrollment of participants. Newly eligible participants were enrolled in the Plan at a salary reduction rate of 3%. Participants could elect to contribute up to 90% of their pre-tax or Roth after-tax eligible compensation, as defined in the Plan document and within statutory limits. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could elect to change or stop the payroll deductions at any time. Participants could also contribute amounts representing distributions from other qualified plans.

The Company matched 100% of the first 2% of compensation that a participant contributed to the Plan plus 50% of the amount of the employee's deferrals between 2% and 4%, up to a maximum \$2,000 per Plan year. Participant and matching contributions were paid to the Plan after each pay period and placed in participant directed investments.

The Company could also make discretionary profit sharing contributions. No profit sharing contribution was authorized in 2024.

## **NOTE 1 - ORGANIZATION AND DESCRIPTION OF THE PLAN (continued)**

### **Participant Accounts**

Individual participant accounts are maintained by the Plan's record keeper. Each account is credited or charged with the participant's contribution, the Company's matching contribution, the Company's profit sharing contribution, if any, allocations of investment income and losses on the individual account balances, and administrative expenses. Loan and distribution fees are deducted from the respective participants' accounts. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investment Options**

Participants direct employee and employer contributions among various mutual funds and a collective trust fund.

### **Vesting**

Participants were immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company matching and profit sharing contributions plus actual earnings thereon was based on years of credited service, as defined in the Plan document, with 50% vesting after two years of service, 75% vesting after three years of service, and 100% vesting after four years of service. Upon normal retirement (65), death, or disability, participants became fully vested in all benefits.

### **Notes Receivable from Participants**

Prior to termination, participants were allowed to borrow from their accounts a minimum of \$1,000, up to the lesser of \$50,000 or 50% of their vested account balance. Terms of the notes receivable could not exceed five years, except for the purchase of a primary residence. The notes receivable from participants are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan Administrator at the time of issuance. Notes receivable from participants outstanding at December 31, 2024 bear interest ranging from 4.25% to 10.5%. Principal and interest were paid ratably through payroll deductions.

### **Payment of Benefits**

Benefits may be distributed upon retirement, death, disability, or other termination of employment. Benefits equal to the value of the participant's vested account may be paid in a lump-sum. Upon attainment of age 59  $\frac{1}{2}$ , participants may request a distribution of their vested account balance prior to retirement.

### **Forfeited Accounts**

Prior to December 31, 2024, upon termination, participants' non-vested account balances were forfeited. Forfeitures could be used to restore participant accounts of rehired employees, pay administrative expenses, or reduce employer contributions. Forfeited non-vested accounts totaled approximately \$38,000 and \$29,000 at December 31, 2024 and 2023, respectively. During 2024, approximately \$12,000 of forfeitures were used to reduce employer contributions.

## **NOTE 1 - ORGANIZATION AND DESCRIPTION OF THE PLAN (continued)**

### **Subsequent Events**

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

## **NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

The following are significant accounting policies used by the Plan:

### **Plan Termination and Basis of Accounting**

The Company had the right under the Plan to terminate the Plan subject to the provisions of ERISA. During 2024, the governing body of the Plan authorized the termination and directed the trustee to merge the Plan with the GWPG 401(k) Retirement Plan on January 1, 2025. In accordance with generally accepted accounting principles in the United States of America (GAAP), the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. The liquidation basis of accounting requires assets be valued at their net realizable values, which approximate fair value of investments. The Plan had no liabilities and there were no liquidation expenses other than distribution processing charges.

The Plan previously presented its statement of net assets available for benefits at December 31, 2023, using the accrual basis of accounting in accordance with GAAP.

### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at net realizable value at December 31, 2024, which approximates fair value. Investments are reported at fair value at December 31, 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (continued)

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus accrued but unpaid interest, if any. Related fees were recorded as administrative expenses and are expensed when they were incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceased to make loan repayments and the Plan Administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

### Payment of Benefits

Benefits were recorded when paid.

### Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees for individual transactions such as distributions and loans were deducted from the respective participant's account. Investment related expenses were included in net appreciation or depreciation in fair value of investments.

## NOTE 3 - FAIR VALUE MEASUREMENTS

GAAP (ongoing and liquidation basis of accounting) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Exchange traded funds** – Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

### NOTE 3 - FAIR VALUE MEASUREMENTS (continued)

**Collective trust fund** – Valued at the NAV of units of a collective trust. The NAV, as provided by the investment trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

### NOTE 4 - CERTIFIED INVESTMENTS

Certain information related to investments that is disclosed in the accompanying financial statements and ERISA-required supplemental schedule on page 14, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by AdvisorTrust, Inc. (AdvisorTrust), the custodian of the Plan.

### NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

AdvisorTrust is the custodian of the Plan and uses Matrix Trust Company as sub-custodian to process certain transactions. Therefore, transactions with these entities and their affiliates qualify as party-in-interest transactions. Fees are paid by the Plan to these parties for administrative services.

### NOTE 6 – PLAN MERGER AND TRANSFER OF ASSETS TO ANOTHER PLAN

Effective January 1, 2025, the Plan was merged with the GWPG Plan (see Note 1). Assets of \$7,666,736 were transferred to the GWPG Plan and employees who previously participated in the Plan began participating and making contributions to the GWPG Plan.

### NOTE 7 - TAX STATUS

The Plan operated under provisions of a Pre-Approved Plan which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the Pre-Approved Plan, as then designed, was acceptable under the applicable sections of the Internal Revenue Code (IRC) for use by the employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan was qualified and the related trust was tax-exempt.

**NOTE 7 - TAX STATUS (continued)**

GAAP (ongoing and liquidation basis of accounting) requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan allowed participants to invest in investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with the investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
