Note 1 - Plan Description

The following description of Solaray LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Solaray LLC (the "Company") and participating employers (collectively, the "Employer") except for leased and collective bargaining employees and nonresident aliens with no U.S. source of income. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Nonexcluded employees who have reached 18 years of age are eligible to participate in the Plan. Participants are automatically enrolled in the Plan on the first day of the month after satisfying eligibility requirements.

Administration

The Company is the sponsor of the Plan. The 401(k) administrative committee, as appointed by the Company's board of directors, is the plan administrator and has responsibility for the administration of the Plan. Lincoln Financial Group Trust Company, Inc. (the "Trustee") functions as the trustee of the Plan and maintains the Plan's records. Individual accounts are invested in the various investment options at the direction of the participants.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Eligible employees are automatically enrolled in the Plan with a 2 percent deferral rate. Deferral rates are automatically increased in January of each plan year by 1 percent up to a maximum of 6 percent. Eligible employees who do not wish to participate in the Plan may affirmatively elect to opt out, or they may elect a different deferral percentage.

The Plan provides for discretionary employer matching contributions of 50 percent of the participant's contribution not to exceed 4 percent of the employee's deferred compensation. Employer matching contributions are based on deferrals made each payroll period. Discretionary employer matching contributions were \$833,045, net of forfeitures applied, for the year ended December 31, 2024.

Additional amounts may be contributed by the Company under the Plan's nonelective provisions at the discretion of the Company's board of directors. Allocations of employer nonelective contributions are based on the proportion of each participant's compensation to the total of all eligible participants' compensation. There were no employer nonelective contributions for the year ended December 31, 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations of the Internal Revenue Code (the "Code").

Participant Accounts

Each participant's account is credited with the participant's contributions, employer matching contribution, and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Prior to January 1, 2020, participants could borrow from their vested accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000, reduced by the excess of the participant's highest outstanding loan balance during the preceding 12-month period over the participant's outstanding loan balance as of the date such loan was made, or 50 percent of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at 6.0 percent, which was based on prime rate plus 1 percent on the date of origination. Participants could have only two loans outstanding at any given time. Terms range from 1 to 5 years or up to 30 years for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions. Effective January 1, 2020, notes receivable from participants are no longer permitted from the Plan, and, as such, new loans are not allowed; however, existing loans are permitted to continue to be repaid according to the loan terms.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. The Company's contributions, if any, vest according to the following schedule:

Participants automatically become 100 percent vested upon normal retirement (attainment of age 65), disability, or death. Participants who terminate for any other reason are entitled to the vested amount of their accounts.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. Additionally, participants may take in-service distributions upon reaching age 59½. For termination of service for other reasons, automatic distributions are required for balances of less than \$5,000. Automatic distributions above \$1,000 made without the participant's consent are rolled into an individual retirement account designated by the Trustee.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Participants who were automatically enrolled in the Plan have the option to withdraw their deferrals without penalty within 30 days of their automatic enrollment date.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$59,827 and \$18,118, respectively. For the year ended December 31, 2024, forfeitures in the amount of approximately \$25,945 were used to pay for plan administrative expenses. The Plan used approximately \$27,480 for the year ended December 31, 2024 to reduce employer contributions.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by the Trustee or its affiliates. Therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

The fully benefit-responsive unallocated contract is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative Expenses

The Plan allows certain administrative expenses to be paid from plan assets. Investment expenses netted against investment income represent amounts associated with the net expense ratios of the investments in the Plan's fund lineup.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 22, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Lincoln Financial Group Trust Company, Inc. holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Note 5 - Investment Contract

The Plan has a benefit-responsive investment contract with Lincoln National Life Insurance Company (Lincoln Life). Lincoln Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 1.70 percent. When establishing interest crediting rates for this product, Lincoln Life considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

In addition, certain events allow Lincoln Life to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (i) an uncured violation of the Plan's investment guidelines, (ii) a breach of material obligation under the contract, (iii) a material misrepresentation, or (iv) a material amendment to the agreements without consent of the issuer.

Note 6 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
