## Independent Auditor's Report

To the Plan Administrator and Participants  
The Greenbrier Companies 401(k) Retirement Savings Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of The Greenbrier Companies 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

The following description of The Greenbrier Companies 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan established September 1, 1984 covering the majority of employees of The Greenbrier Companies, Inc. and its subsidiaries (“Greenbrier” or the “Company”) who have completed 3 months of service. Empower Trust Company, LLC is the custodian of the Plan. The Plan sponsor and Plan Administrator is the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

In May 2023, the Company sold its Gunderson Marine barge building operations. As a result of this divestiture, approximately \$28 million in net Plan assets (representing the balances of the impacted employees) were transferred out of the Plan in August 2023.

In August 2023, the Company sold its ownership interest in the Southwest Steel Castings Company. As a result of this divestiture, employees were given the opportunity to remain in the Plan or request a distribution. Approximately \$3 million in net Plan assets were distributed from the Plan in November 2023.

b. Eligibility

Employees who are 18 years or older are eligible to participate in the Plan upon completion of 3 months of service. Eligible employees exclude (1) union employees unless their contract specifically provides for coverage in the Plan, (2) non-resident aliens, (3) residents of Puerto Rico, (4) part-time, temporary, or seasonal employees unless regularly scheduled service for the Plan year is at least 1,000 hours, and (5) interns.

c. Contributions

Participants may contribute up to 100% of their eligible compensation as a Pre-tax or Roth deferral, as defined in the Plan document, subject to certain limitations under the Internal Revenue Code (“IRC”). Participants who are 50 years of age or older during the Plan year may also make catch-up contributions as allowed by the IRC. The Plan includes an automatic deferral provision whereby employees are automatically enrolled in the Plan at a deferral rate of 4% unless otherwise elected and increased by 1% per year up to a maximum of 8% of compensation. Participants may also contribute amounts representing distributions from other qualified plans.

The Company contributes a safe-harbor matching contribution equal to 100% of the first 4% deferred by participants. The Company may also make additional matching and non-elective contributions to the Plan at the discretion of the Company’s board of directors, subject to the limits of the IRC. No additional matching and non-elective contributions were made during 2024 or 2023.

d. Participant Accounts

Individual accounts are valued daily and maintained for each Plan participant. Each participant's account is credited with the participant's contributions and withdrawals, as applicable, and allocations of (a) Greenbrier's contributions and (b) investment income or loss. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct investment of their account balances into investment options offered under the Plan.

e. Vesting

Participants are fully vested at all times in the portion of their accounts attributable to their own contributions, safe harbor matching contributions and earnings thereon. Vesting in the Greenbrier discretionary additional matching and non-elective contribution portion of their accounts plus actual earnings thereon is based on years of credited service. Participants vest in the additional matching and non-elective contributions 50% after one year of service and are fully vested after two years of service.

f. Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 not to exceed 50% of the participant's account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Loan terms may not exceed 5 years unless the purpose of the loan is for the purchase of a primary residence in which case it may not exceed 10 years. The interest rate on notes receivable from participants as of December 31, 2024 ranged from 3.25% to 9.50% and the loans mature through 2034.

g. Payment of Benefits

On termination of service, death, or attainment of age 59½ a participant or a beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested account balance, a partial distribution subject to a minimum of \$1,000 or substantially equal installments, depending on the circumstances.

Terminated participants with an account balance of less than \$5,000 but greater than \$1,000 are distributed in the form of a direct rollover to an individual retirement account designated by the Plan Administrator. Account balances less than \$1,000 may be distributed in a single lump-sum cash payment to the participant or beneficiary.

h. Hardship Withdrawals

Upon certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single sum, a portion of their elective deferrals as a result of an immediate and heavy financial need. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence or to prevent eviction or foreclosure from the participant's principal residence.

**2. Summary of Significant Accounting Policies**

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

b. Use of Estimates

The preparation of the financial statements in conformity with GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the gains and losses on investments bought and sold during the year as well as the change in the unrealized appreciation or depreciation on those investments from one period to the next.

d. Notes Receivable from Participants

Participant loans are classified as notes receivable from participants, which are segregated from Plan investments and measured at their unpaid principal balance plus any accrued but unpaid interest. Notes receivable from participants are fully secured by the participants' vested accounts and as such, the Plan did not establish any allowance for credit losses. Unpaid loan balances remain in a participant's account until a distributable event occurs.

e. Payment of Benefits

Benefits are recorded when paid.

f. Administrative Expenses

The Plan's expenses are paid by Greenbrier, at its discretion, or the Plan as provided by the Plan document. Certain recordkeeping fees are charged to the Plan. For the years ended December 31, 2024 and 2023, direct expenses paid by the Plan were approximately \$41,000 and \$40,000 respectively.

g. Forfeitures

At December 31, 2024 and 2023, unallocated forfeited nonvested accounts totaled approximately \$442,000 and \$182,000, respectively. Forfeitures may be used to reduce employer contributions or to pay administrative expenses. During 2024 and 2023, respectively, \$6,233 and \$3,000 of forfeitures were utilized to reduce employer contributions and pay administrative expenses.

### 3. **Investments**

Plan investments are held by Empower Trust Company, LLC and participants can direct their accounts among various mutual funds, a common collective trust, a separate account, and a money market fund.

The Putnam Stable Value Fund (the "Putnam SVF") is a common collective trust investing primarily in guaranteed investment contracts, security-backed investments and short-term investments. The Putnam SVF also invests in wrap contracts. A wrap contract is an agreement by another party, such as a bank or insurance company, to make payments to a portfolio in certain circumstances. Wrap contracts are designed to allow a stable value portfolio to maintain a constant net asset value ("NAV") and to protect a portfolio in extreme circumstances. The SVF is reported at fair value which is based on the NAV of the underlying investments. Certain events could cause the Putnam SVF not to transact at contract value including targeted layoffs made by the Plan sponsor, bankruptcy of the Plan sponsor

resulting in employee job loss, reorganizations, spin-offs, and the termination of the Plan. Due to the size of the SVF and the specific percentage allowances negotiated by the SVF, it is highly unlikely that any event would occur that would limit the SVF's ability to transact at contract value with each issuer under these events.

Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment in the Putnam SVF at contract value which approximates fair value. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals and administrative expenses. Earnings from the stable value options is included in interest and dividend income on the accompanying statements of changes in net assets available for benefits.

#### **4. Fair Value Measurements**

FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, establishes a framework for fair value measurement, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

As of December 31, 2024, the Plan's investments are measured using leveling in accordance with ASC 820. Following is a description of the valuation methodologies used for the Plan's investment assets measured at fair value.

*Separate account:* The Plan's interest in the pooled separate accounts are valued at the NAV of each investment's underlying investments based on information reported by the investment advisor using the daily reported NAV of the investment at year-end. The NAV is used as a practical expedient to estimate fair value. Participant transactions can occur daily.

*Common collective trust:* Valued at the fair value of the underlying investments which consist primarily of publicly traded common stock or level 2 investments and are reported at the NAV of units held by

the Plan at year end. The NAV is used as a practical expedient to estimate fair value. Participant transactions can occur daily.

*Mutual funds and money market account:* Valued at fair value based on quoted market prices at year end.

## 5. Risks and Uncertainties

The Plan offers various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the risk associated with certain investments, it is reasonably possible that changes in values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the financial statements.

## 6. Information Certified by the Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the

Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements and supplemental schedules was provided and certified by Empower Trust Company, LLC, the custodian of the Plan, as of December 31, 2024 and 2023 as complete and accurate:

- Investments, at fair value
- Notes receivable from participants
- Investment income
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

## **7. Related-Party Transactions**

The Plan's investments include pooled separate accounts offered by Empower Trust Company, LLC, the custodian of the Plan. The SVF is managed by Putnam Investments, an affiliate of Empower Trust Company, LLC. Additionally, certain investment fees are paid by the custodian and are reflected in the investment income (loss) for the year. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

The Plan sponsor, Greenbrier, is a party-in-interest to the Plan; however, there were no transactions with the Plan sponsor other than the funding of contributions to the Plan and payment of certain administrative expenses of the Plan, which are exempt transactions.

## **8. Income Tax Status**

The Plan was restated effective October 1, 2022, and further restated effective January 1, 2025, using the Empower Retirement, LLC Non-Standardized Defined Contribution Pre-Approved Plan document which received a favorable opinion letter dated November 14, 2022. Management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, management believes that the Plan is qualified, and the related trust is tax exempt as of and for the years ended December 31, 2024 and 2023.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **9. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminates, participants would become 100% vested in all their accounts.
