Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan

The following brief description of the Datacor, Inc. 401(K) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

General

The Plan is a defined contribution plan covering substantially all employees of Datacor Holdings, Inc. and Subsidiaries (the "Company" and "Plan Administrator"). The Plan became effective January 1, 1984 and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and the Internal Revenue Code ("IRC").

Eligibility

Substantially all employees who have reached 18 years of age, have completed 30 days of service, are not classified as independent contractors of the Company, are not considered interns that are schedule to work less than 1,000 hours, and are not covered by a collective bargaining agreement are eligible to participate in the Plan. Eligible employees may enter the Plan on the date when the eligibility requirements are met as defined by the Plan.

Contributions

Participants may contribute up to 100% percent of their eligible compensation to the Plan, as defined by the Plan, subject to the annual limitation established by the IRC. The Plan contains an automatic deferral provision whereby eligible participants are automatically enrolled at 6% of their eligible compensation, unless a participant elects otherwise. The Plan also allows for an annual automatic deferral increase of 1% up to a maximum percentage of 12%. Participants may rollover amounts representing distributions from other qualified plans into the Plan.

The Company, at its discretion, may annually contribute a percentage of each participant's pre-tax annual base compensation. For 2024, the Company contributed \$1,751,945. Contributions are subject to a compensation ceiling and annual limitations prescribed by the IRC.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution and the allocation of Plan earnings; each participant account is charged an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Certain expenses and administrative costs incurred in connection with the general administration of the Plan are paid out of Plan assets.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer contributions are subject to a graded vesting schedule and are fully vested after six years of service.

Forfeited Accounts

If a participant terminates employment before becoming fully vested in their account balance, the forfeited portion of the account balance is used to reduce future Employer contributions to the Plan. Forfeited amounts that were used to reduce employer contributions to the Plan during 2024 totaled approximately \$60,000. At December 31, 2024 and 2023, there was approximately \$124,000 and \$97,000, respectively, of forfeited nonvested account totals in the Plan. This account is used to reduce future employer contributions.

Payment of Benefits

On termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Certain mandatory distribution provisions may apply for smaller account balances of terminated employees.

Notes Receivable from Participants

Participants are permitted to borrow up to 50 percent of their vested account balance with a minimum of \$1,000 up to a maximum loan amount of \$50,000. Only one note may be outstanding at any given time. The terms require principal and interest payments. Notes generally have a term of not more than five years. The interest rate on notes shall be determined by the Plan Administrator based on terms as described in the Plan document. At December 31, 2024 and 2023, the notes bear interest from 4.25% to 10.50%. Notes receivable from participants are valued at their unpaid principal balance plus accrued interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Accounting Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with US GAAP. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates and the difference could be material.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end using quoted market prices. The investments in common collective trust funds and pooled separate accounts are stated at net asset value (NAV) based upon the fair market value of the underlying assets. The NAV, as provided by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the "Trustee"), is used as a practical expedient to estimate fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held during the year, are presented in the net depreciation in fair value of investments.

Payment of Benefits

Benefit payments are recorded when paid.

Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses

Administrative expenses, including audit, trust and recordkeeping fees, can be charged to the Plan. Investment transaction and per use fees, such as loan costs and withdrawal costs, are paid by the participant through their account in the Plan.

Fair Value of Financial Instruments

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Company at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Securing Strong Retirement Act

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2020 CARES Act. Most of the provisions of SECURE 2.0 become effective in 2024 and beyond. The provisions did not have a significant impact to the Plan during 2024.

Subsequent Events

The Plan has evaluated subsequent events for recording or disclosure in the financial statements through the date which the financial statements were available to be issued.

Note 3 - Certification of Investment Information

The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(c), pursuant to 29 CFR Section 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed its independent auditors not to perform, and they did not perform, any auditing procedures with respect to the following information certified by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the Trustee) except for comparing the information with the related information included in the financial statements and supplemental schedule.

The Trustee certified all investments and the notes receivable from participants at December 31, 2024 and 2023. The Trustee certified the net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended December 31, 2024.

Note 5 - Tax Status

The Plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, Plan management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. The Plan's investments are exposed to various risk factors, such as interest rates, market conditions and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risk factors in the near term could materially affect the amounts reported in the financial statements.

Note 7 - Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their Employer contributions and the Plan assets will be distributed according to the provisions of the Plan documents.

Note 8 – Plan Merger

During the year ended December 31, 2023, the Company acquired Applied Flow Technology LLC. In connection with the acquisition, the net assets of the Applied Flow Technology Corporation 401(k) Plan, totaling \$1,508,549, were merged into the Plan in January 2024.

Note 9 – Related Party Transactions

Certain Plan investments are shares of common/collective trust funds and pooled separate accounts managed by the Trustee; therefore, these are party-in-interest transactions. Fees paid by the Plan for investment management and administrative services amounted to approximately \$141,000 for the year ended December 31, 2024.
