INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
Murchison & Cumming LLP 401(k) Profit Sharing Plan

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Murchison & Cumming LLP 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Murchison & Cumming LLP 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.



### NOTE A - DESCRIPTION OF THE PLAN

The following description of the Murchison & Cumming LLP 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### 1. General

Effective January 1, 1990, Murchison & Cumming LLP (the “Employer”) adopted the Murchison & Cumming LLP 401(k) Profit Sharing Plan. The Plan is a contributory profit sharing plan which was established for the benefit of all employees of the Employer and meets all requirements for profit sharing plan qualification under Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### 2. Eligibility

An employee is eligible for participation in the Plan on the first day of the month following the completion of one month of service and the attainment of age 20.5. Employees covered under a collective bargaining agreement, non-resident aliens, seasonal, temporary and leased employees are excluded from participation in the Plan.

#### 3. Contributions

Participants may elect to contribute on a tax-deferred basis and/or make Roth contributions, up to the maximum deferral amount set by Section 402(g)(1) of the IRC. Additional “catch-up” contributions may be made beginning in the plan year in which a participant will be at least age 50 by the end of the plan year.

The Employer makes matching contributions equal to 50% of a participant’s deferrals up to 4% of compensation. In addition, the Employer may make discretionary non-elective contributions to the Plan, in accordance with the terms of the plan document, participants are eligible for discretionary non-elective contributions upon completion of 500 hours of service. No discretionary Employer non-elective contributions were made for the year ended December 31, 2024.

#### 4. Investment Options

Upon enrollment in the Plan, a participant may direct participant and Employer contributions, as desired, in any of a variety of investment programs offered by Capital Bank and Trust Company, The Lincoln National Life Insurance Company, and Talcott Resolution, as approved by the Employer. Participants may also elect to invest in self-directed brokerage accounts, as approved by the Employer. Participants may change their investment options daily. Self-directed brokerage accounts were held by Fidelity Investments and RBC Wealth Management as of December 31, 2024 and 2023.

**5. Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer's contributions, and allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**6. Forfeitures**

Forfeitures of terminated participants' nonvested accounts may be used to pay administrative expenses of the Plan. Any remaining forfeitures are applied against future Employer contributions at the Employer's discretion. Available forfeitures at December 31, 2024 and 2023 were \$130,966 and \$66,249, respectively.

**7. Benefit Payments**

Upon termination of employment, a participant will be entitled to an amount equal to the value of his or her vested account balance. When a participant attains normal retirement, incurs permanent disability, or dies while employed, the participant or their beneficiaries are entitled to 100% of the participant's account balance. On termination of service due to death, disability, retirement or due to other reasons, a participant with an account valued at less than \$1,000 must receive the benefit payment in a lump-sum distribution. For accounts exceeding \$1,000, the participant may elect a lump sum distribution or a distribution in the form of an annuity. In-service and hardship distributions are permitted if certain criteria are met.

**8. Vesting**

Participant contributions, Employer matching contributions, and Employer qualified non-elective contributions and actual earnings thereon are fully vested at all times. However, vesting of the Employer non-elective contribution portions of participant accounts, plus actual earnings thereon, is based upon the participant's years of service with the Employer as follows:

##### 9. Notes Receivable from Participants

The Plan permits participants to borrow from their account up to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding balance of loans from the Plan during the one-year period ending on the day prior to the date the new loan is issued. Loans are secured by the balance in the participant's account. Participants are limited to two outstanding loans at any time. Loans must be repaid within five years and loans for the purchase of a principal residence may be repaid over a reasonable period of time, as determined by the loan policy in effect at the date of loan issuance. All loans bear interest at prime plus .5%.

##### 10. Plan Termination

Although it has not expressed such intent, the Employer reserves the right, at any time, to terminate the Plan, subject to the provisions of ERISA. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. The assets of the Plan would be distributed to the participants in accordance with the provisions of the Plan.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### 1. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

##### 2. Plan Administration

The Employer is the plan sponsor and the plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

##### 3. Payment of Benefits

Benefits are recorded when paid.

##### 4. Administrative Expenses

Certain expenses charged by the custodians in performance of their duties are paid from the assets of the Plan. Investment related expenses are included in the net appreciation/depreciation in fair value of investments. Substantially all other out-of-pocket administrative expenses of the Plan are paid by the Employer. Expenses paid by the Employer are excluded from these financial statements.

##### 5. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### 6. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### 7. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### 8. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### NOTE C - INFORMATION CERTIFIED BY CERTAIN CUSTODIANS

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA with respect to certain custodians. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by The Lincoln National Life Insurance Company (Lincoln) and Capital Bank and Trust Company (CBT), certain custodians of the Plan, as complete and accurate, except for comparing such information certified by these custodians to information included in the Plan's financial statements and supplemental schedules.

Total investments held and certified by Lincoln and CBT in the accompanying Statements of Net Assets Available for Benefits were \$34,705,419 and \$37,874,477 as of December 31, 2024 and 2023, respectively. Net investment income certified by these custodians in the accompanying Statement of Changes in Net Assets Available for Benefits was \$5,180,888 for the year ended December 31, 2024.

#### NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interest-bearing cash:* Valued at cost plus interest.

*Mutual funds:* Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

*Self-directed brokerage accounts:* Accounts primarily consist of cash, mutual funds and common stocks that are valued on the basis of readily determinable market prices.

*Individual annuity contracts:* Valued at the total accumulation unit value of all subaccounts held by the contract. The total accumulation unit value represents net asset value and is used as a practical expedient to estimate fair value. The accumulated unit value is established at the inception of the subaccount and is adjusted each valuation period based on fund performance, fund expenses and contract charges. Mortality, expense risk, administrative and rider charges are applied to the contracts. Surrender charges may range from 0% to 6% of withdrawals, depending on the length of time the payments were invested in the contract. Individual annuity contracts seek to provide a monthly payout based on a variable interest rate and offer multiple options for payout, including an income stream for life.

*Common collective trust fund:* The net asset value is determined daily based on net assets at contract value. Sales and redemptions of participant units are transacted at such net asset value. The common collective trust fund is a stable value fund that primarily holds traditional guaranteed investment contracts (GICs) and synthetic GICs. Trusts participating in the stable value fund are subject to restrictions on withdrawals from the stable value fund. The stable value fund's primary investment objective is to seek a reasonable level of income together with stability of principal.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The custodians are parties-in-interest with respect to the Plan. All investments are held with the custodians. Therefore, these transactions qualify as party-in-interest transactions. Notes receivable from plan participants and the related interest income are also considered party-in-interest transactions.

#### **NOTE F - TAX STATUS**

The Employer adopted a non-standardized pre-approved profit sharing plan with a money purchase and a cash or deferred arrangement (non-standardized plan) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the non-standardized plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Administration errors, if any, which are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

During the year, the Plan identified certain distributions that were processed without obtaining the required spousal consent related to the Qualified Joint and Survivor Annuity (QJSA) provisions under ERISA and the Internal Revenue Code. Plan management is in the process of evaluating the matter and intends to take corrective action, which may include notifying affected participants and/or spouses and obtaining the necessary spousal consents, or implementing another correction method in consultation with an ERISA advisor. Management does not believe this matter will have a material effect on the accompanying financial statements.

#### **NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

#### **NOTE H - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through August 20, 2025, the date the financial statements were available to be issued.
