NOTE 1 - DESCRIPTION OF PLAN

The following description of the Land O' Frost, Inc. Voluntary Employees' Beneficiary Association Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The plan was formed November 1, 1983. The Plan covers all full-time employees of Land O' Frost, Inc. and their dependents. The Plan was established solely to provide health, accident, life or similar welfare benefits for eligible employees and their dependents. The plan has been amended to comply with the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA), Employee Retirement Income Security Act of 1974 (ERISA) and the Health Insurance Portability and Accountability Act of 1996 (HIPAA), and subsequent tax reform acts.

Contributions

Land O' Frost, Inc. (Plan Sponsor) contributes to the Plan an amount necessary to provide the benefits under the Plan. Participants and their dependents shall contribute to the Plan such amounts as may be required under the Plan and in accordance with a uniform, non-discriminatory procedure established by the Employer. Employer contributions for the years ended December 31, 2024 and 2023 were \$12,113,463 and \$12,783,785, respectively. Employee contributions are based on a fixed weekly charge based on the number of dependents the employee elects to receive coverage. The Plan has purchased insurance, which limits its liability for health claims to \$125,000 per individual per year or occurrence. The insurance contract has a one-year term which begins on September 1 and has been renewed at September 1, 2024.

Expenses after the first \$2,000 are covered by the plan at 80% if approved. After the first \$2,500 of claims that are paid by the participant, approved expenses are covered 100% by the plan.

For non-union participants with families the HSA plan includes a \$1,000 account balance to be used first. The family's deductible is a collective \$4,000 and the \$1,000 account balance can apply towards the deductible so long as the costs are approved (in network) Expenses after the first \$4,000 are covered by the plan at 80%, if approved. After the first \$5,000 of claims are paid by the participant, approved expenses are covered 100% by the plan.

Union employee participants can only utilize the Health Reimbursement Account (HRA) option and do not receive the \$500 account balance.

For single, union members, participants the deductible is \$250, with an annual out-of-pocket maximum of \$1,250. Expenses, after the first \$1,250 expenses, are covered at 85% by the plan.

For union members with family coverage, the deductible is \$500, with an annual out-of-pocket maximum of \$1,250 for each covered individual. Expenses, after the first \$1,250 expense per individual, are covered at 85% by the plan.

HUB International Midwest, Ltd. provides advisory services to the Plan, and therefore qualifies as a party-in-interest. Fees paid to HUB International Midwest, Ltd. by the Plan totaled \$91,494 and \$89,106 for the years ended December 31, 2024 and 2023, respectively.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

The Plan's claims processing and participant administration services are provided by Aetna. The scope of services provided qualifies Aetna as a party-in-interest. Fees paid to Aetna by the Plan for the years ended December 31, 2024 and 2023 were \$304,083 and \$311,450, respectively.

HUB International Midwest, Ltd. provides advisory services to the Plan, and therefore qualifies as a party-in-interest. Fees paid to HUB International Midwest, Ltd. by the Plan totaled \$91,494 and \$89,106 for the years ended December 31, 2024 and 2023, respectively.

Certain employees of the Company provide administrative and trustee services for the Plan and are not reimbursed for their services from the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan.

Swartz, Retson & Co., P.C., by virtue of its role as auditor of the Plan's financial statements, qualifies as a party-in-interest. Audit fee expense was \$15,425 and \$14,000 for the years ended December 31, 2024 and 2023, respectively.

NOTE 6 - UNCERTAIN TAX POSITIONS

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The plan administrator has analyzed tax positions taken by the plan and has concluded that, as of December 31, 2023, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements.
