Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1. DESCRIPTION OF PLAN

The following description of Kagome Inc. (Company) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan was established on November 30, 2005, with an initial transfer of assets into the Plan from a plan of the professional employer organization that the employees participated in prior to this plan being established.

General

The Plan is a defined contribution plan covering all full-time employees of the Company who have 60 days of service and have attained the age of twenty-one. Employees are automatically enrolled in the Plan on the first day of the month after having met the service and eligibility requirements. Participants are auto enrolled at a 3% annual salary deferral, auto-escalating 1% per year to 8%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's investment committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

The participants may contribute up to the maximum allowed by law of pretax annual compensation, as defined in the Plan. The Plan also allows participants to elect to designate all or a portion of their contribution as a "Roth contribution". Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts distributed from other qualified retirement plans as allowed by law which are identified as "Rollover contributions." Participants direct their contributions and employer contributions into various investment options offered by the Plan.

The Company makes a non-discretionary matching contribution equal to 25% of the employees' pre-tax 401k contribution into the Plan, limited to 12% of eligible compensation, excluding catch-up and rollover contributions, which is determined and matched each pay period. The Company may make discretionary matching contributions and annual discretionary profit-sharing contributions in an amount as determined by the Company. The Company elected not to make any discretionary matching or profit-sharing contributions for 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching and discretionary matching and profit-sharing contributions and earnings based on the investments chosen less allocation of Plan expenses. Plan expenses are allocated based on participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their contributions and rollover contributions plus actual earnings thereon. Vesting in the Company's contribution is based on years of continuous service. A participant is 20% vested after two years of credited service and 100% vested after six years of credited service.

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participants Notes fund. These loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Interest rates are 5.25% to 10.50% on the loans. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's account or elect to leave the amount in the Plan. For termination of service due to other reasons, a participant will receive the value of the vested interest in the plan as a lump-sum distribution.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$50,482 and \$23,353, respectively, which will be used to offset future employer contributions and Plan expenses. During 2024, Plan expenses paid from forfeited non-vested accounts was \$24,091.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan trustees determine the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan and are included on these financial statements. Fees related to the administration of the Plan are charged directly to the participants account and are included in contract administrator fees and other fees. Investment related expenses including broker fees are included in net appreciation of fair value of investments.

NOTE 4. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements* (“ASC 820”), is the framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs

Principal collective investment trusts and pooled separate accounts:

The Plan had \$14,521,838 and \$11,761,523 as of December 31, 2024 and 2023, respectively in units held in collective investment trusts and pooled separate accounts through sub-accounts of an insurance company. The custodian, Principal Trust Company, has certified the amounts held in the collective investment trusts and pooled separate accounts to be complete and accurate.

The schedule of assets held for investment presented as supplementary information is a complete list of all assets held, certified by the custodian and valued at fair market value. The underlying securities are mutual fund(s) held by Principal in either pooled separate accounts or collective investment trusts to meet investment objectives of the Principal investment choice are listed on national securities exchanges and valued on the basis of year-end closing prices, less liabilities, divided by the number of shares outstanding. The fair value trading price is an internal quoted price supplied by Principal that is available to current or prospective investors through accessing their accounts or public publishing, thus these funds are considered to have a readily determinable fair value and are subject to the fair market value reporting under GAAP.

It is possible that the redemption rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in market conditions, liquidity requirements, and the economic environment may significantly affect the net asset value of the collective investment trusts and pooled separate accounts and consequently, the fair value of the Plan's investments.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE 5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (PLIC). PLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by PLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$365,190 and \$370,480, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1.60%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with PLIC. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The unallocated contract has no unfunded commitment as of December 31, 2024 and 2023, there is no required redemption notice period, and the redemption frequency is immediate.

NOTE 6. TAX STATUS

The Plan adopted the Principal Financial Group Prototype for Savings Plan, which was amended and restated effective January 1, 2023. The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, complied with the applicable requirements of the Internal Revenue Code. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal and California taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested in the employer contributions.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE 9. RELATED PARTY, PARTY IN INTEREST AND PROHIBITED TRANSACTIONS

Delaware Charter Guarantee and Trust Company dba Principal Trust Company is the custodian and trustee and, accordingly, transactions with Delaware Charter Guarantee and Trust Company dba Principal Trust Company qualify as exempt party-in-interest transactions according to applicable regulations. A portion of the Plan's investments are in mutual funds, collective trusts and a guaranteed investment contract, sponsored by Principal Life Insurance Company or Principal Trust Company and received direct or indirect compensation for investment management services and asset management or other services where the required reporting of the indirect compensation was done, so it does not have a dollar amount but is reported on Schedule C of Form 5500 as determined by formula.

In addition, Principal Life Insurance Company received \$6,637 for commissions which reduced plan earnings, which was paid out to Principal and the Plan investment advisors. Principal, as the contract administrator, received \$103,214 of direct compensation which is reported as contract administrator fees. Principal also reported \$21,493 of eligible indirect compensation for other services, which decreased net appreciation for the year.

The late deposit of certain employee deferrals and loan repayments results in a prohibited transaction. In 2023, deposits totaling \$120,080 were remitted late, as disclosed in the supplemental schedule of delinquent participant contributions. Late deposits of \$10,479 and \$345 from 2022 and 2021, respectively, are also included in the supplemental schedule of delinquent participant contributions. Lost earnings for the 2023 delinquent participant contributions and loan repayments were deposited into participants' accounts in 2024. Lost earnings for the 2022 and 2021 delinquent participant contributions and loan repayments has not been corrected as of the report date.
