Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Pacific Medical, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statements of change in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024, and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

The following description of the Pacific Medical, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and summary Plan description for a more complete description of the Plan’s provisions.

General

The Plan was established January 1, 1996, to provide benefits for employees and the employees’ beneficiaries of Pacific Medical, Inc. and its wholly-owned subsidiary Top Shelf Orthopedics (collectively the “Plan Sponsor”). The Plan is a defined contribution plan covering employees who have attained the age of twenty-one and completed three months of service where they worked at least one hour. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. Newport Trust Company serves as the Plan Trustee. Effective June 23, 2023, Plan assets were transferred from Newport Trust Company to Ascensus Trust Company, the Plan’s sub-custodian.

Plan Year

The Plan year begins January 1st and ends December 31st.

Contributions

The Plan allows for the following types of contributions:

- **Employee Salary Deferral 401(k) Contributions**
The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Internal Revenue Code (the “Code”). Eligible employees are automatically enrolled at a deferral rate of 5% on the first day of the month following the date eligibility requirements are met and participants contributing less than 5% will be automatically increased by 1% on the first day of each plan year up to 10%. Employees may opt-out of automatic enrollment and the automatic increase.
- **Employee Roth Elective Salary Deferral Contributions**
Participants may make after-tax Roth elective salary deferral contributions.
- **Qualified Non-Elective Employer Profit Sharing Contributions**
The Plan Sponsor may make a qualified non-elective profit sharing contribution to the Plan in order to correct a failed ADP and/or ACP Test. If made, the contribution is allocated pro rata to all non-highly compensated employees.
- **Employee Rollover Contributions**
Participants may make rollover contributions from another qualified plan.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Participant Accounts and Allocations

Each participant's account is credited with the participant's contributions, rollover contributions, an allocation of Plan earnings and losses, and certain Plan expenses, as defined by the Plan document. The yield (interest, dividends, and net realized and unrealized gains and losses) on investments is allocated to each participant's account based on each participant's pro rata share of the total investments in the particular fund. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's vested account.

Vesting

Participants are always 100% vested in their salary deferral contributions and investment gains and losses credited thereon. Participants are 100% vested in non-elective employer profit sharing contributions upon entering the Plan.

Forfeitures

Forfeitures resulting from incorrect contributions may be returned to the Plan Sponsor. No forfeitures were returned during the years ending December 31, 2024, or 2023. Forfeitures amounting to \$88 and \$52 were available as of December 31, 2024, and 2023, respectively.

Retirement

Normal retirement under the Plan is age sixty-five.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest charged at a commercially reasonable rate as determined by the Plan's administrator. Principal and interest is paid ratably through monthly payroll deductions and loan periods range from one to five years, except for loans made for the purchase of a primary residence, which may permit a longer repayment term.

Payment of Benefits

Participants may begin receiving benefits in the year following attainment of age 59½. On termination of service due to death, disability, or normal retirement, a participant may elect to receive a lump-sum amount, partial withdrawals, or installments over a period of time not to exceed the participant's or beneficiary's assumed life expectancies. Participants qualifying under "hardship" rules may elect to receive all or a portion of their vested account balance prior to termination or retirement.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments in mutual funds and money market accounts are stated at fair market value based on quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Substantially all of the administrative expenses were paid by the Plan for the years ending December 31, 2024, and 2023. Expenses related to specific participant transactions are charged to the respective participant's account.

Income Taxes

The Plan adopted a non-standardized prototype plan which received a favorable opinion letter on June 30, 2020, from the Internal Revenue Service as to the prototype plan's tax-exempt status. The Plan has not applied for its own determination letter. The Plan has been amended since receiving the opinion letter. The plan administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Estimates and Assumptions

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 3: INFORMATION CERTIFIED BY THE TRUSTEE

NOTE 5: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. Participants are fully vested.

NOTE 6: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) ASC 820 provides a framework for measuring fair value. That framework provides a three-tier hierarchy that prioritizes the inputs to valuation techniques used for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, model-based valuation techniques for which all significant assumptions are observable in the market, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market account: Underlying short-term investments with quoted prices in active markets to preserve the value of the investment at \$1.00 per share.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8: PARTY-IN-INTEREST TRANSACTIONS

Fees paid by the Plan for trust, recordkeeping and, advisory services amounted to \$97,583 and \$88,182 for the years ended December 31, 2024, and 2023, respectively. Notes receivable from participants are considered party-in-interest transactions. Such transactions are permitted under the provisions of the Plan and are exempt from prohibition of party-in-interest transactions under ERISA.

NOTE 9: SUBSEQUENT EVENTS

Plan management has evaluated events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Management has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued and has determined that no subsequent events have occurred that should be disclosed.
