## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors of  
New Jersey Bankers Association Employee Benefits Trust:

### Opinion

We have audited the financial statements of New Jersey Bankers Association Employee Benefits Trust (the "Company"), which comprise the statements of financial position as of June 30, 2024 and 2023, and the related statements of activities and changes in net assets, and cash flows for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Company as of June 30, 2024 and 2023, and the changes in its net assets and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Company and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

#### 1. ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### **Business**

New Jersey Bankers Association Employee Benefits Trust ("EBT" or the "Company") acts as the recipient for all insurance premiums paid in connection with the various group insurance contracts for employees of participating New Jersey Bankers Association ("Association") members. Until such time as premiums are remitted to the respective insurance carriers, they may be invested and income may be earned for EBT.

In addition, EBT receives service charges from members of the trust with respect to the various types of insurance coverage provided. The majority of these fees are passed onto Bankers Cooperative Group, Inc. ("BCG") as administrative fees as BCG provides licensed insurance agency services and administrative services for EBT. BCG also receives commissions from the insurance companies that write the various coverages for the customers of BCG.

EBT also provides assistance to participating employer members in complying with the Consolidated Omnibus Budget Reconciliation Act by providing continuous coverage for eligible participants. Premiums are received from the participants and disbursed to the respective insurance carriers.

##### **Basis of Accounting and Presentation**

The accompanying financial statements are presented on the accrual basis of accounting, and in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). As such, net assets are reported within two net asset classifications: without donor restrictions and with donor restrictions. Descriptions of the two net asset categories are as follows:

**Net assets without donor restrictions:** Net assets available for use in general operations and not subject to donor restrictions. Assets restricted solely through the actions of the Board of Directors are referred to as Board-designated net assets and are also reported as net assets without donor restrictions. As of June 30, 2024 and 2023, there were no Board-designated net assets.

**Net assets with donor restrictions:** Contributions restricted by donors are reported as increases in net assets without donor restrictions if the restrictions expire (that is, when a stipulated time restriction ends and/or a purpose restriction is accomplished) in the reporting period in which the revenue is recognized. All other donor-restricted contributions are reported as increases in net assets with donor restrictions, depending on the nature of the restrictions. When a restriction expires, net assets with donor restrictions are reclassified to net assets without donor restrictions and reported in the statements of activities and changes in net assets as net assets released from restrictions. Assets donated with explicit restrictions regarding their use and contributions of cash that must be used to acquire property and equipment are reported as contributions with donor restrictions. Absent donor stipulations regarding how long those donated assets must be maintained, the Company reports the expiration of donor restrictions when the donated or acquired assets are placed in service. As of June 30, 2024 and 2023, there were no net assets with donor restrictions.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues, expenses, gains, losses, and other changes in net assets during the reporting period. Actual results could differ from those estimates.

**Concentration of Risk**

The Company maintains its cash, cash equivalents, and certificates of deposit at multiple financial institutions. The balances are insured by the Federal Deposit Insurance Corporation (“FDIC”) up to specified limits by each institution. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Company’s financial condition, results of operations, and cash flows.

**Revenue Recognition**

*Revenue Accounted for as Contracts with Customers*

Revenue is recognized when the Company satisfies a performance obligation by transferring a promised good to, or performing a service for, a customer. The amount of revenue recognized reflects the consideration the Company expects to receive in exchange for satisfying distinct performance obligations. If a performance obligation does not meet the criteria to be considered distinct, the Company combines it with other performance obligations until a distinct bundle of goods or services exists. Fees or amounts received in advance of satisfying contractual performance obligations are reflected as deferred revenue in the balance sheet. Revenue is recognized either over time or at the point in time that contractual obligations are met. Specifically, for the various types of contracts, the Company recognizes revenue as follows:

- Service charges are received by EBT from the participants in the group insurance contracts of the trust and are recognized in the period in which services related to the insurance contracts are performed and the income is earned. Service charges are derived from insurance premiums paid in connection with various group insurance contracts, which are reported net of payments to those respective insurance carriers.

Revenue from all other sources is recognized when earned.

**Cash and Cash Equivalents**

For purposes of reporting cash flows, the Company considers all highly liquid debt instruments purchased with a maturity of three months or less, except bank certificates of deposit, to be cash equivalents.

**Restricted Cash**

The dental rate stabilization fund is categorized as restricted cash on the statement of financial position, as it is a function of the Company’s group dental insurance plan through Delta Dental of New Jersey that limits the Company’s ability to utilize those deposits for general operations. The dental plan through Delta Dental of New Jersey is a fully insured participating contract which allows for the Company to retain underwriting profits when dental claims run favorable to dental premium. The primary function of the dental stabilization fund is to use underwriting profits from favorable claim years to “buy down” renewal rate increases in claim years where the claims experience is less favorable and would be cause for a premium rate increase.

**Certificates of Deposit**

Bank certificates of deposit are carried at cost plus accrued interest and considered to be temporary investments, not cash equivalents. The carrying amount of certificates of deposit approximates fair value due to the relatively short-term maturity of these financial instruments. At June 30, 2024 and 2023, the Company has \$53,396 and \$53,222 in certificates of deposit, all of which mature within one year.

**Premiums Receivable from Participating Members**

Accounts receivable consist primarily of uncollateralized, noninterest-bearing amounts due within normal payment terms for service charged from members of the trust with respect to the various types of insurance coverage provided. Accounts receivable are written off against the allowance for doubtful accounts when all reasonable collection efforts have been exhausted. For the years ended June 30, 2024 and 2023, the Company recorded bad debt expense of \$511 and \$0, respectively, and had recorded an allowance for uncollectable account of \$1,463 in both years. At July 1, 2024 and 2023, the balance of premiums receivable from participating members was \$105,861 and \$238,639, respectively.

**Functional Allocation of Expenses**

The costs of program and supporting services activities have been summarized on a functional basis in the statements of activities and changes in net assets. The statements of activities and changes in net assets present the natural classification detail of expenses by function. Accordingly, certain costs have been directly charged to either the programs or supporting services benefited.

**Income Taxes**

The Internal Revenue Service issued its determination letter on July 1, 1952, which stated that EBT meets the requirement of Section 501(c)(9) of the Internal Revenue Code, as amended, and, therefore, is exempt from federal income taxes. EBT is not subject to New Jersey income taxation. Pursuant to N.J.S.A. 54A:2-1, New Jersey's Gross Income Tax ("GIT") Act imposes a tax on certain tax payors that may include trusts. The EBT does not meet the definition of trust and, therefore, is not subject to New Jersey's GIT Act.

**Liquidity and Availability of Resources**

As of June 30, 2024 and 2023, financial assets and liquidity resources available within one year for general expenditure, such as operating expenses and fulfillment of liabilities, were as follows:

**2. RELATED-PARTY TRANSACTIONS**

As discussed in Note 1, Bankers Cooperative Group, Inc. is a licensed insurance broker responsible for the negotiation of all of the group insurance contracts for EBT and performs all administrative functions for the trust. All service charges collected from participating employer members by EBT are remitted to BCG as administrative fees for performance of these services. These administrative fees totaled \$118,579 and \$136,039 for the years ended June 30, 2024 and 2023, respectively. Amounts due from BCG were \$305,803 and \$79,951 as of June 30, 2024 and 2023, respectively. Amounts due from BCG in both years include \$79,951 for dividends EBT paid on behalf of BCG during the year ended June 30, 2023. During the year ended June 30, 2024, the amounts due from BCG include \$225,852 for amounts BCG collected from customers on EBT's behalf that were not transferred to EBT before year end.

**3. SUBSEQUENT EVENTS**

EBT's management has evaluated subsequent events through May 6, 2025, the date the financial statements were available to be issued. Based upon this evaluation, the Company has determined that there are no subsequent events that have occurred which require adjustment to or disclosure in the financial statements.
