### Notes to Financial Statements

December 31, 2024

#### **(1) Description of Plan**

The following description of the Dependable Cleaners, Inc. (the “employer”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan was adopted on January 1, 1995, by Dependable Cleaners, Inc., the Plan sponsor, as a 401(k) Retirement Plan for the exclusive benefit of eligible employees. It includes a cash or deferred arrangement (CODA) as described in Section 401(k) of the Internal Revenue Code. The Plan is subject to the provisions of Section 404(c) of the Employee Retirement Income Security Act (ERISA) of 1974. The employer added a Roth feature to the Plan in 2014. In 2021, the Plan formally adopted provisions related to coronavirus-related distributions, loans, and required minimum distributions based on guidance by the Internal Revenue Service.

Plan Eligibility – All employees are eligible to participate in the Plan after they attain the age of 21 and have completed six months of employment. Effective for 2019, there is no minimum work requirement. Entry dates into the Plan are the first day of each calendar quarter.

Employee Contributions – Employee contributions to the Plan are made each payroll period as elected by the participants. Employees may contribute a percentage of their pretax annual compensation or a specific dollar amount up to the maximum allowed by the Internal Revenue Code. The contribution election percentage can be changed at the end of any calendar quarter and can be stopped at any time. Rollovers from other eligible plans are allowed.

Employer Matching Contributions – Each year, the employer may make a discretionary matching contribution to the Plan. Each participant who has satisfied the service requirements of the Plan, is entitled to receive an allocation of Employer matching contributions for each Plan year equal to 50% on the first 3% of gross wages. The employer may also make profit-sharing contributions at their discretion, which will be allocated among all eligible employees, whether they make contributions. Such contributions benefit only those eligible employees who are employed on the last day of the Plan year. No discretionary profit sharing contributions were made by the employer during 2024.

Vesting – Participants are immediately 100% vested in their voluntary contributions plus earnings thereon. Employer contributions are vested ratably on a five years of credited service basis.

Investments – All contributions to the Plan are directed by the participants to be invested into any of a variety of investment choices provided under the Plan, as determined from time to time by the trustees. Participants may change their investment choices at any time.

Notes Receivable from Participants – Participants may borrow funds against their vested account balance. Loans must be a minimum of \$1,000 and may not exceed less than one-half of the participant's vested account balance or \$50,000. The remaining vested account balance of the participant is used to secure the loan. All loans must be repaid within five (5) years except those for a primary residence. Interest is payable according to the loan agreement for each loan. Interest ranges from 4.25% to 9.50%.

Payment of Benefits – Withdrawals from the plan may occur in the event of retirement, disability, death, termination or service, or financial hardship. Hardship withdrawals may not be made from the employer's Safe Harbor March contributions. Upon retirement, disability, or death, the total value of a participant's account is payable to the participant or a named beneficiary. If an employee leaves the employment of the employer, the balance can be rolled into an IRA or another 401(k) plan, with no penalties or the participant will be issued a check equal to their balance, which is subject to a 10% federal tax penalty.

Under government rules hardship withdrawals include the following events: (1) certain medical expenses, (2) purchase of or prevention of foreclosure on a principal residence, (3) a dependent or participant's college education expenses, (4) funeral expenses, (5) and cost of qualifying repairs to principal residence. Hardship distributions are permitted only from participant's accounts that are 100% vested. In addition, distributions for certain qualifying expenses of a beneficiary are allowed.

Forfeitures – Employees are immediately fully-vested in their contributions and related earnings. Employer contributions, if any, are vested according to the aforementioned five-year vesting schedule, thus, forfeitures of employer contributions will occur if an employee is terminated prior to five (5) full years of service. For the year ended December 31, 2024, there was zero forfeited by terminated employees. Forfeitures are first used to pay Plan expenses, if any, then to reduce future employer contributions to participant accounts.

Corrective Distributions – Corrective distributions to participants are recorded as distributions.

#### **(1) Summary of Accounting Policies**

##### ***Basis of Accounting***

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). The significant accounting policies followed by Dependable Cleaners, Inc. are described below to enhance the usefulness of the financial statements to the reader.

***Use of Estimates***

The presentation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefits are recorded when paid.

**(2) Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no Plan assets requiring the use of Level 2 and Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024.

***Level 1 Fair Value Measurements***

The fair value of Pooled Separate Investments, which are mutual funds, is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact that price. The mutual funds held by the Plan are considered to be actively traded.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation or depreciation in fair value of investments.

**(3) Related Party Transactions and Party in Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Voya Retirement Insurance and Annuity Company ("Voya"). Voya is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**(4) Plan Termination**

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**(5) Tax Status**

The Internal Revenue Service has determined and informed the employer by a letter dated June 20, 2002, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Trustee and administrator believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**(6) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**(7) Subsequent Events**

Dependable Cleaners, Inc. has performed an evaluation of subsequent events through September 23, 2025, which is the date Dependable Cleaners, Inc.'s financial statements were available to be issued. No material subsequent events have occurred since December 31, 2024 that required recognition or disclosure in these financial statements.


