# Kanadevia Group 401(k) Plan

## *Notes to the Financial Statements*

*As of December 31, 2024 and 2023, and for the Year Ended December 31, 2024*

### **NOTE 1 – PLAN DESCRIPTION**

The following is a brief description of the Kanadevia Group 401(k) Plan (the “Plan”), formerly Hitachi Zosen Group 401(k) Plan (name changed effective October 1, 2024), which is provided for general information purposes only. Participants should refer to the Plan document, related adoption agreement and individual statements provided to each Plan participant for a more complete description of the Plan’s provisions.

#### **A. GENERAL**

The Plan is a qualified defined contribution and safe harbor 401(k) plan, covering eligible employees who are members of a controlled group which includes Kanadevia U.S.A. Ltd., Kanadevia Inova U.S.A. LLC, H&F Services U.S.A. Inc., Kompogas SLO LLC, NAC International Inc., VTEX America Inc., NAC LPT LLC, and NAC Philotechnics, Ltd. (collectively, the “Company”). The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan investments are administered and held in a trust by the Plan’s trustee, Empower Trust Company (“Empower”), which also serves as the custodian of the Plan. The Plan administrator is responsible for overseeing and ensuring compliance with the Plan document. The Plan’s Trustee and the Plan administrator are appointed by the Company.

Effective October 1, 2024, the Company’s name changed to Kanadevia U.S.A. Ltd. The Plan document was amended at that time to reflect this change.

#### **B. ELIGIBILITY**

The Plan covers all eligible employees of the Company who have completed three months of service and who have attained the age of 21. The Plan excludes those employees who are: (1) Independent contractors, (2) Employees covered by a collective bargaining agreement, (3) Leased employees (4) Nonresident aliens (5) Puerto Rico based Employees and (6) Interns. Entrance into the Plan upon meeting the eligibility requirements is the first day of each month.

#### **C. PARTICIPANT CONTRIBUTIONS**

Eligible employees are automatically enrolled in the Plan for a 5% pre-tax deferral contribution of their compensation unless they affirmatively elect to opt-out of the Plan or elect a different deferral percentage. The Plan document prescribes default investment selection options for those automatically enrolled employees that fail to select how their assets will be directed. Before-tax and Roth after-tax voluntary contributions are allowed up to the Internal Revenue Code (“IRC”) limits prescribed below, with a minimum of 1% eligible compensation.

Additionally, each participant may elect to separately defer up to 100% of any cash bonus to be paid by the Employer during the Plan year. Eligible compensation for all Plan purposes means wages, tips and other compensation on Form W-2 as adjusted to exclude reimbursements or other expense allowances, fringe benefits, moving expenses, deferred compensation, welfare benefits and military differential pay.

#### **D. EMPLOYER CONTRIBUTION**

Each plan year, the plan sponsor shall contribute a safe harbor matching contribution. The Company made a safe harbor matching contribution equal to 100% of the participants’ contributions up to a maximum of 5% of total eligible compensation for 2024. The compensation and deferrals are determined on a payroll period basis.

### **NOTE 1 – PLAN DESCRIPTION – (CONTINUED) –**

#### **D. EMPLOYER CONTRIBUTION – (CONTINUED) –**

The Company may also elect to make an additional discretionary matching contribution based on a uniform percentage of each eligible participants' contribution as determined annually by the Board of Directors. An additional discretionary matching contribution was not elected for 2024.

In addition, the Company, as determined by the Board of Directors, may also elect to make a discretionary profit-sharing contribution based on a percentage of each eligible participant's compensation. To be eligible for the discretionary profit-sharing contribution, the participant must be employed at the end of the Plan year. A profit-sharing contribution was not elected for 2024.

#### **E. PARTICIPANT ACCOUNTS**

Each participant account is credited with the participant's contribution and allocations of employer contributions, plan earnings, and distribution and loan fees (if applicable). Allocations are based on participant earnings or account balances, as defined.

#### **F. NOTES RECEIVABLE FROM PARTICIPANTS**

Each participant may borrow up to the lesser of 50% of the present value of the participant's vested interest in the account or \$50,000. The notes are secured by the vested balance in the participant's account. No note shall be less than \$1,000 and only one note at a time is allowed. The notes bear interest at the prime rate, plus 1%. Any such borrowings are to be repaid within five years unless the note is for the purchase of a principal residence for which the repayment period may not extend beyond thirty years. Principal and interest are to be repaid by payroll deductions.

#### **G. PAYMENTS OF BENEFITS**

Participants or their beneficiaries can request a distribution if they sever employment, retire, become disabled, die, have a hardship or have attained age 59 ½. The distributions are payable in a lump sum. Death benefits and required minimum distributions may be made over a period of time, if elected. Participant account balances less than \$5,000 will be automatically distributed as a lump sum distribution.

#### **H. VESTING**

Participants are 100% vested in their deferrals, rollover contributions and the Company's safe harbor matching contributions, plus earnings thereon. Participants vest in the Company's discretionary additional matching or profit-sharing contributions, if any, plus actual earnings as follows:

#### **I. TERMINATION PRIORITIES**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their employer contributions.

### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **A. FINANCIAL REPORTING FRAMEWORK**

The accompanying financial statements are prepared according to accounting principles generally accepted in the United States of America (“GAAP”), as promulgated by the Financial Accounting Standards Board (“FASB”) in the Accounting Standards Codification (“ASC”).

#### **B. BASIS OF ACCOUNTING**

The financial statements of the plan are prepared on the accrual basis of accounting.

#### **C. ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **D. CONTRIBUTIONS**

Contributions from Plan participants and employer contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation.

#### **E. VALUATION OF INVESTMENTS**

The Plan’s investments are reported at fair value, (except the unallocated insurance account which is valued at contract value, see Note 7). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the plan’s gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

#### **F. PLAN EXPENSES**

Administrative expenses may be paid out of the Plan or by the Company. Administrative expenses that are to be paid from the Plan are first paid from forfeitures, if any, and any remaining amounts are paid from the Plan’s trust funds and allocated to all participants on a pro rata basis. The Company incurred certain administrative expenses relating to the Plan without charge to the Plan during 2024.

#### **G. NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### **H. PAYMENT OF BENEFITS**

Benefits are recorded when paid.

#### **I. RISKS AND UNCERTAINTIES**

The Plan provides for various investment options. Investment securities are exposed to various risks including but not limited to, interest rate, market, and credit risks. Due to the level of risk, associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### **J. SUBSEQUENT EVENTS**

The Plan evaluated subsequent events through October 9, 2025, which is the financial statement issuance date. All items which are required for disclosure have been included in the accompanying financial statements and notes thereto.

### **NOTE 3 – FORFEITURES**

Upon termination of employment participants forfeit their non-vested balances. These accounts may be used to reduce future Company contributions or pay for administrative expenses of the Plan at the discretion of the Company. At December 31, 2024 and 2023, forfeited non-vested accounts were \$16,609 and \$15,601, respectively. Forfeited amounts used to reduce Company contributions or pay Plan expenses were \$31 during the year ended December 31, 2024.

### **NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The Plan's investments are held in a trust fund administered by Empower Trust Company ("Empower"). The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by the trustees.

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as December 31, 2024 and 2023.
- Investment income, interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### **NOTE 5 – TAX STATUS**

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **NOTE 5 – TAX STATUS – (CONTINUED) –**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Empower and Mass Mutual (owned by Empower), and therefore, these transactions qualify as party-in-interest transactions. As of December 31, 2024 and 2023, there were investments that qualify as party-in-interest transactions totaling \$30,493,463 and \$24,272,362, respectively. Certain payments to the Trustee are included within administrative expenses. Loans to Plan participants also qualify as party-in-interest transactions. The total of the notes receivable from participants were and \$541,378 and \$400,192 for the years ended December 31, 2024 and 2023.

#### **NOTE 7 – UNALLOCATED INVESTMENT CONTRACT WITH AN INSURANCE COMPANY**

The Plan has a fully benefit-responsive group annuity contract with the trustee, which is called Guaranteed Interest Fund. The trustee maintains the contributions in an unallocated fund within its general account which adds interest. The account is also charged for participant withdrawals and administrative expenses. Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The contract is included in the financial statements at contract value. Contract value represents the amount of contributions deposited, plus interest credited daily as determined by the contract, less any participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The account balance was \$8,057,367 and \$9,245,496 as of December 31, 2024 and 2023, respectively.

Certain events limit the Plan's ability to transact at contract value with the insurance company including plan termination and other events as specified in the group annuity contract. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value.

The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed by the Plan. The crediting interest rate is based on a formula agreed upon with the insurance company. Such interest rates are reviewed on a quarterly basis for resetting. The crediting interest rate is based on a formula established by the contract issues but may not be less than zero percent. The average interest for 2024 and 2023 was 3.00%.

#### **NOTE 8 – FAIR VALUE MEASUREMENTS**

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

In accordance with the framework, the Plan groups assets and liabilities measured at fair value into three levels based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value.

These levels are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used between December 31, 2024 and December 31, 2023.

- *Mutual Funds*: valued based on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
