NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the CSC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all employees of the Contemporary Services Corporation (the “Company”) who have attained 21 years of age. Employees are eligible to participate in the Plan after one year of service. A year of entry service for each service period is earned when 1,000 or more hours of services are provided. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each participant may contribute up to 90% of annual compensation, as defined by the Plan and subject to certain limitations. Catch-up contributions for certain eligible participants are also permitted. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The plan provides for Safe Harbor matching contributions, under which the Company contributes an amount equal to 100% of participant contributions for the first 4% of the participant’s eligible compensation. Discretionary profit-sharing contributions may be contributed to the Plan at the option of the Company’s Board of Directors. The Company’s allocation of discretionary contributions is based on each qualifying participant’s compensation for the Plan year. No discretionary profit-sharing contributions were approved for 2024 or 2023.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, individual account earnings or losses, and an allocation of the Company’s contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Forfeitures: Forfeited balances of terminated participants’ non-vested accounts are first used to pay any administrative expenses. Any remaining balance is used to reduce future employer contributions.

Vesting: Participants are immediately vested in their contributions and Safe-Harbor matching contributions plus actual earnings thereon. The Company’s discretionary contributions and related investment earnings vest as follows:

Upon retirement, death, or disability, participants are immediately vested in the Company’s discretionary contributions.

Payment of Benefits: Upon termination of service due to death, disability or retirement, a participant may elect to receive the value of the vested interest in his or her account in the following forms: lump-sum or installment payments. Upon meeting certain eligibility requirements, participants may also elect to receive an in-service withdrawal.

Upon termination of employment, a participant may have the vested benefits disbursed through a lump-sum cash distribution or transferred to another qualified plan. If the vested value of the participant's account exceeds \$5,000, the participant may elect to keep the account in the Plan and maintain his or her account in any of the Plan's investment options.

Notes Receivable from Participants: Participants may borrow from their fund accounts up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The notes are made on a uniform and non-discriminatory basis, are secured by the participant's account, bear a reasonable rate of interest, and have a defined repayment schedule. Principal and interest are paid through payroll deductions.

Administrative Expenses: Loan origination fees associated with notes receivable from participants and the Plan's recordkeeping fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in investment income reported by the Plan. All other expenses of the Plan are paid by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 5. Purchases and sales of securities are recorded on the trade date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefit payments are recorded when paid.

Use of Estimates: The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(Continued)

NOTE 3 - RIGHTS UPON PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer discretionary contributions and earnings thereon.

NOTE 4 - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan.

NOTE 5 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following describes the valuation methods and assumptions used by the Plan to estimate the fair values of investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

NOTE 5 - FAIR VALUE MEASUREMENTS (Continued)

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement. However, redemptions by plan participants to reinvest in options that compete with the stable value fund may be delayed up to 90 days. Currently the Plan does not provide for any competing stable value funds or benefit-responsive investment contracts.

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds units of pooled separate accounts managed by Principal Life Insurance Company and collective trusts managed by Principal Global Investors Trust Company. Principal Life Insurance Company and Principal Global Investors Trust Company are affiliates of Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, trustee to the Plan. Therefore, these transactions and the Plan's payment of fees to Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and its affiliates qualify as party-in-interest transactions. Notes receivable from participants held by the Plan are also considered party-in-interest transactions.

NOTE 7 - INCOME TAX STATUS

The Internal Revenue Service ("IRS") issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - SUBSEQUENT EVENTS
