Opinion

1. Description of Plan

The following description of the Engineering Consulting Services, Ltd. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a leveraged employee stock ownership plan (ESOP) established effective January 1, 2010, as restated January 1, 2017. The Plan covers substantially all employees, excluding employees covered by a collective bargaining agreement, leased employees, and nonresident aliens who do not receive any earned income from Engineering Consulting Services, Ltd. (the Company or Plan Sponsor), who have completed one year of service and are age 18 or older. To determine year of service and break of service for purposes of eligibility, the initial 12-consecutive-month period shall commence on the date an employee first performs one hour of service for the Company. Except in the case of death, disability or retirement, plan participants who have completed at least 1,000 hours of service during the plan year and are still employed by the Company on the last day of the plan year are eligible to share in the allocation of discretionary Company contributions and any plan forfeitures.

The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Sponsor appointed two officers of the Company as individual trustees responsible for oversight of the Plan. The Plan's plan committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the board of directors.

Contributions

The Company is obligated to make contributions in cash or shares of Company common stock to the Plan which, when aggregated with the Plan's dividends and interest earnings, are at least equal to the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest on its loan obligations and benefit payments to terminated participant. The Company may make additional elective contributions at the discretion of the Company's board of directors. Participants are not permitted to make any contributions to the Plan.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with an allocation of the Company's discretionary contributions and, on the last day of each plan year, an allocation of the Company's common stock shares released from the unallocated account, as well as forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated, as defined in the plan agreement, to each participant's account based on the ratio of the participant's Company common stock account as of the preceding year-end to the total cumulative number of shares of Company common stock allocated to all participants. Participants should consult the Plan Sponsor or refer to the plan document for other qualifications.

Vesting

If a participant's employment with the Company is terminated for any reason other than retirement, permanent disability, or death, vesting in their contributions is based on years of continuous service. An employee is credited with one year of service for each plan year during which they complete 1,000 hours of service or more. A participant is 20% vested after two years of credited service and continues to vest in increments of 20% until 100% vested after six years of credited service. Regardless of years of service, participant accounts are 100% vested when the participant reaches normal retirement age (as defined in the plan document), becomes permanently disabled or upon death.

Voting Rights

In general, all Company common stock held in the Plan shall be voted by the trustees in accordance with instructions from the plan committee; however, with respect to certain important corporate matters, each participant who has Company common stock allocated to his or her account shall have one vote per allocated share with respect to such issue. In accordance with instructions from the plan committee, the trustees shall vote any unallocated shares held by the plan trust as well as any allocated shares for which a participant has failed to give timely voting instructions. On all other matters, the plan committee need not solicit instructions from participants.

Important corporate matters include any matter involving a merger, consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business or a similar transaction involving the Plan Sponsor, as specified in IRC Section 409(e)(3) and the regulations thereunder.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant will receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. For death, disability or retirement, benefits will commence in the year following separation. If the vested account balance is \$20,000 or less, distributions will be made in a lump sum based upon the account valuation immediately preceding the distribution. If the vested account balance is greater than \$20,000, distributions will be made in substantially equal installments over a period of five years based upon the account value immediately preceding each installment distribution.

For separation of service for reasons other than death, disability, or retirement, if the vested account balance is \$20,000 or less, distributions will be made in a lump sum in the year following separation based on the account valuation immediately preceding the distribution. For vested accounts over \$20,000, distributions will commence in the sixth plan year following separation of service in substantially equal installments over a period of five years based upon the account value immediately preceding each installment distribution. Distributions may be made in cash or in the form of Company common stock plus cash for any fractional share of Company common stock.

Under the provisions of the Plan, the Plan Sponsor (or the ESOP Trust) is obligated to repurchase participant shares, which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations. During 2024, the ESOP Trust repurchased from participants 516.3015 shares at the December 31, 2023 share price of \$807.62 determined from an independent appraisal.

Unallocated Assets and Forfeitures

Plan forfeitures are allocated to each participant's account in the same manner in which the Company contributions are allocated. There were no forfeited nonvested accounts as of December 31, 2024 and 2023. Forfeitures are allocated annually to participant accounts of those employed on the last day of the plan year. During 2024, \$64,691 and 26.0311 shares of Company common stock were allocated to participant accounts from forfeited nonvested accounts, in accordance with plan provisions. From time to time, the Plan holds assets consisting of forfeitures and suspended excess contributions due to the IRS Section 415(c) annual contribution limitation that are not allocated to participants' accounts. There were no suspended excess contributions as of December 31, 2024 and 2023.

Put Option

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants who are at least 55 years old and have participated in the Plan for at least 10 years (a Qualified Participant) so that they may have the opportunity to move part of the value of their investment in Company common stock into other alternative investments made available by the Plan which are more diversified. During each of the first five years of eligible diversification, a Qualified Participant may withdraw up to 25% of the value of their investment in Company common stock, less any shares previously diversified, and transfer the amount as a rollover into another qualified plan or as a cash withdrawal. In the sixth and subsequent years, the percentage amount that can be withdrawn increases to 50%. The election to diversify is made subsequent to year-end based upon the shares of Company stock in the participant's account at year-end. For the year ended December 31, 2024, \$54,162 was transferred from the Plan to another qualified contribution plan sponsored by the Company.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's plan committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Forfeited Accounts

Forfeited non-vested accounts are to be deemed Company contributions to the Plan for the plan year in which the forfeiture occurs.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Recent Regulatory Updates

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of the SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Subsequent Events

Subsequent events were evaluated through October 9, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Company common stock: Valued at estimated fair value based on an independent third-party appraisal using the capitalization of cash flow method. The appraiser considered inputs such as historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities, along with a discount for lack of marketability where appropriate.

Changes in Fair Value of Level 3 Assets

There were no transfers into or out of Level 3 of the fair value hierarchy and no purchases or issues of Level 3 assets. During the year ended December 31, 2024, there were \$416,883 of repurchases of common stock from the Plan (see Note 1).

4. Investment in Common Stock

The Plan's investments in the Company's common shares at December 31, are presented in the following table:

The fair value per share as estimated by an independent business valuation analyst was \$966.06 and \$807.62 as of December 31, 2024 and 2023, respectively. The Plan owned approximately 23.3% and 21.8% of the Company's outstanding common stock as of December 31, 2024 and 2023, respectively. The investment in the Company's common stock represents 5% or more of the Plan's net assets.

5. Loans Payable

In April 2015, the Plan purchased 3,140 shares of the Company's common stock with a loan from the Company in the amount of \$658,929. In May 2016, the Plan purchased 4,000 shares of the Company's common stock with a loan from the Company in the amount of \$1,027,000. In May 2017, the Plan purchased 1,250 shares of the Company's common stock with a loan from the Company in the amount of \$373,062. The lender has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the Plan. The notes mature in April 2025, May 2026 and May 2027, respectively, and bear interest at a fixed rate of 3.5%. The borrowings are collateralized by the unallocated shares of common stock. Shares are released from collateral and allocated to participants as payments of principal are made. The number of shares released in any year is the number of shares held as collateral, multiplied by the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal payments. This resulted in 839 shares being released and allocated for both plan years ended December 31, 2024 and 2023.

6. Related-Party and Party in Interest Transactions

The Plan's assets, which consist primarily of shares of the Company's common stock at both December 31, 2024 and 2023, are held in safekeeping by the trustees of the Plan. Company contributions are held and managed by the trustees, who invest cash received, interest, dividend and other income and make distributions to participants. The trustees also administer the scheduled payment of principal and interest on the Plan's security acquisition loans based on the loan terms, which are reimbursed to the trustees through contributions as determined by the Company.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

The Plan invests in Company common stock. These are related party and party in interest transactions. As described in Note 2, the Company may pay plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

7. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the trustees direct the Plan to pay all liabilities and expenses of the Plan and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan agreement and the IRC. In the event of Plan termination, participants would become 100% vested.

8. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated September 21, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
