### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the 2024 financial statements of New Narrative 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The 2024 financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

## New Narrative 401(k) Plan Notes to Financial Statements

---

### 1. Plan Description

---

The following brief description of the New Narrative 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan was established January 1, 2009 and restated effective January 1, 2022. The Plan is a defined contribution plan covering employees of New Narrative (the Organization) who meet certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Organization's board of directors.

The custodian of the Plan is Reliance Trust Company (Reliance) and the record-keeper is Standard Insurance Company (Standard). All participant account balances are held by the custodian. The participant directs the investment of all contributions and earnings thereon, and may change their investment directive at any time.

**Eligibility** - The Plan is a defined contribution plan covering full-time employees of the Organization who have two months of service and are age eighteen or older. Entry dates are monthly. Eligible employees do not include non-resident aliens, residents of Puerto Rico, part-time employees, or on-call employees.

**Contributions** - Participants may elect to contribute up to 100 percent of their annual pretax compensation during the plan year, subject to the limits imposed by the Internal Revenue Code (IRC). The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants are allowed to transfer or roll over funds into the Plan from another qualified plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions.

The Organization makes safe harbor matching contributions to the Plan equal to 100 percent of participant contributions up to 3 percent of eligible compensation, plus a 50 percent match of all remaining contributions up to 5 percent of eligible compensation. To receive a matching contribution, participants must be making salary deferrals. Additional discretionary contributions may be made at the option of the Organization, including profit-sharing contributions. The Organization did not make any additional discretionary contributions during the year ending December 31, 2024.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and the Organization's safe harbor matching contributions, as well as allocations of the Organization's discretionary contributions and Plan earnings. Deducted from each participant's account are any distributions made to the participant and an allocation of administrative expenses that are paid by the Plan. Allocations of administrative expenses are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their voluntary contributions plus actual earnings thereon and in the Organization's contributions.

**Forfeitures** - Forfeitures from non-vested accounts are used to pay plan expenses or reduce amounts otherwise required to be contributed to the Plan. The balances in the forfeiture account as of December 31, 2024, and 2023 was \$12,012, and \$11,764 respectively. During the year ended December 31, 2024, no forfeitures were used to fund employer matching contributions or plan expenses.

**Notes Receivable from Participants** - Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loans are secured by the balance of the participant's account and bear a reasonable interest rate. Interest rates range from 5.25 percent to 10.5 percent, with maturities through October 2032. The term of the loan may not exceed 60 months unless the proceeds of such loan are to be used to acquire any dwelling unit, which within a reasonable time is to be used as the principal residence of the participant. Principal and interest installments are paid ratably through monthly payroll deductions.

**Payment of Benefits** - Upon attaining normal retirement age of 65, termination of service, death, or disability, a participant may elect to receive a lump-sum distribution of the entire vested account balance. Terminated participants whose account balance is \$5,000 or less will automatically receive a lump-sum distribution. Hardship distributions are available only for the purpose of meeting immediate and heavy financial needs.

---

#### 2. Summary of Significant Accounting Policies

---

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** - The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect reported amounts of net assets at the date of the financial statements, and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period, as well as disclosure of any contingent assets or liabilities. Actual results could differ from these estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian. Additional information about fair value measurements can be found in *Note 4*.

#### 2. Summary of Significant Accounting Policies - Continued

---

**Investment Valuation and Income Recognition - Continued** - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value approximates fair value for the fully benefit-responsive investment contracts. Investments in fully benefit-responsive investment contracts are reported at contract value as described in *Note 5*.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Benefits Paid to Participants** - Benefits are recorded when paid. At December 31, 2024, there were no benefits processed and approved for payment, but not paid.

**Plan Expenses** - The Plan's expenses are paid either by the Plan or the Organization, as provided by the Plan document. Expenses that are paid directly by the Organization are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefit.

#### 3. Certified Investments

---

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including cash and investments held at December 31, 2024, and net investment income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, whom management has determined is a qualified institution.

#### 4. Fair Value Measurements

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used during the year ended December 31, 2024.

Following is a description of the valuation methodology used for assets measured at fair value on a recurring basis:

*Shares of registered investment companies:* The fair value of investments in mutual funds from registered investment companies are determined by obtaining quoted prices on nationally recognized securities exchanges as determined by the custodian.

The preceding method may produce a fair value calculation that may be indicative of net realized value or reflective of future values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **5. Guaranteed Investment Contract (Unaudited)**

---

The Plan has a guaranteed investment contract account, the Standard Stable Asset Fund D (Stable Asset Fund). The Standard maintains contributions to this account in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Standard is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The Stable Asset Fund is carried at cost plus accrued interest.

The Standard has informed the Plan Administrator that they believe the Stable Asset Fund is comparable to a cash equivalent, as investments held in the contract are completely liquid, the value provided to the Plan is the redeemable value of the fund, and there are no deferred sales charges, load assessments, or interest rate adjustments that would affect the value as a result of the withdrawal request. The value of the Stable Asset Fund at December 31, 2024 and 2023 was \$554,671 and \$388,919, respectively. The Plan Administrator believes this investment is not subject to the fair value measurement requirements.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with The Standard. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; (4) a material amendment to the agreement without the consent of the issuer.

#### **6. Transactions with Parties-in-Interest**

---

The Organization is the Plan sponsor and administrator and pays certain administrative costs, including accounting, legal, and consulting fees, on behalf of the Plan.

Reliance, who serves as custodian of the Plan, manages certain Plan investments. These investments and investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments.

Participants in the Plan are permitted to borrow funds from their vested balances. These transactions qualify as party-in-interest transactions. Notes receivable from participants and the related interest earned are described in *Note 2*.

---

#### **7. Plan Termination**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

---

#### **8. Income Tax Status**

---

The Plan is utilizing a non-standardized pre-approved plan with an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2022. The letter states the Plan is designed in accordance with the applicable requirements of the IRC. Although the pre-approved plan document has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that would not likely be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 9. Risks and Uncertainties

---

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
