Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Adelante Development Center, Inc. 403(b) Retirement Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) Audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF PLAN

General

The Adelante Development Center, Inc. 403(b) Plan (the Plan) was established January 1, 2000 for the benefit of the employees of Adelante Development Center, Inc. (the Company). The Company acts as the Plan discretionary sponsor and administrator. Participants should refer to the Plan document for a more complete description of the Plan.

The Plan is a defined contribution plan covering substantially all employees of the Company. Employees may elect not to participate in the salary deferral program. Employees must have attained age eighteen to be eligible for contributions other than elective deferral contributions. The Plan entry dates for participant deferrals and employer matching contributions occurs immediately upon attaining eligibility.

The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974, as amended and is designed to comply with Section 403(b) and the regulations thereunder of the Internal Revenue Code (the Code), as amended.

Contributions and Vesting

Participants may defer up to 100% of compensation to the allowable limit as prescribed by law. To be eligible for employer match, participants must be 18 years or older. The employer matches 50% for every 1% of employee salary deferral up to 4%. Effective July 1, 2023, the employer changed the match formula to 100% of the first 2% of employee contributions and 75% of the next 2% of employee contributions. If an employee contributes 4% of their compensation, the Company will contribute 3.5% of the compensation as a matching contribution.

Employer profit sharing contributions are discretionary and are subject to ratable vesting over a five-year employment period. There were no discretionary employer contributions for 2024 and 2023, respectively.

Starting in July 2023, Participants fully vest in employer contributions immediately.

Administration

Administration costs incurred by the Plan are generally paid by the Plan sponsor for active employees.

Participant Accounts

Each participant's account is credited with the participant and sponsor contributions, account earnings, gains and/or losses and their portion of Plan expenses.

Employees can direct their accounts to be invested in any combination of available funds offered by Charles Schwab Bank. Participants may change their investment options each business day. There are some remaining accounts under a prior vendor, VALIC, as of December 31, 2024 and 2023, respectively.

NOTE 1 – DESCRIPTION OF PLAN – CONTINUED

Notes Receivable from Participants

Participants are allowed to obtain loans from the Plan for their vested interest in the Plan with a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of their vested account balances, whichever is less. Participants may have one loan outstanding at a time and may not initiate more than two loans in one calendar year. The loans are repaid over a term not to exceed five years unless the purpose of the loan is for the purchase of the principal residence of the Participant in which case the repayment period shall not exceed ten years. The rate of interest to be paid by the Participant must be commensurate with the rate of interest charged on similar commercial loans by persons or institutions in the business of lending money in the same geographic area as the Employer.

Benefits

Upon termination of service, participants may receive their account balance in the form of a lump sum distribution, an annuity payment or a rollover.

Forfeitures

Profit sharing forfeitures are available to reduce employer contributions. Forfeitures were \$1,666 and \$7,396 in 2024 and 2023, respectively. \$4,896 and \$4,945 were available to reduce future employer contributions as of December 31, 2024 and 2023, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on an accrual basis.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Fair Value Measurements

The fair value framework prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

These inputs may include quoted prices for the identical instrument in an inactive market, inputs other than observable quoted prices, or inputs derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy are based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments

Investments of the Plan are stated at fair market value. The fair market value of receivables is the face amount of such accounts. All other investments are valued at quoted market prices, and the participant loans are valued at their outstanding balance. Realized and unrealized gains and losses on investments are reflected in the statements of changes in net assets available for benefits. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded at the ex-dividend date.

Plan Tax Status

The Plan sponsor initially adopted a prototype Plan, effective January 1, 2000. The Plan was amended and restated on January 1, 2009. The Plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2009-71. The IRS does not currently have a determination letter program open to 403(b) plans. The Plan Administrators and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Plan administration has evaluated its tax positions taken for all open tax years. The Plan is not currently under audit nor has Plan administration been contacted by any tax jurisdictions. Plan administration believes there are no uncertain tax positions related to Plan activities.

Subsequent Events

The Plan has evaluated all events occurring subsequent to December 31, 2024 through September 30, 2025, which is the date that the financial statements were issued, and, if applicable, has disclosed or recognized all events occurring during this period that require either recognition or disclosure in the accompanying financial statements.

NOTE 4 – FAIR VALUE MEASUREMENT – CONTINUED

The classifications of different types of investments in the preceding tables are determined by evaluating each fund or investment within parameters established by Morningstar investment resource provider.

The following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Company Shares and Variable Annuity Contracts – Variable Funds: Valued at the net asset value (NAV) of the shares held by the Plan at the end of the year determined by quoted prices in active markets.

Stable Asset Fund and Unallocated General Accounts: Valued at contract value. See Notes 5 and 6.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – GUARANTEED INTEREST ACCOUNTS

In prior years, the Plan entered into benefit responsive investment contracts with its previous custodian VALIC. VALIC maintains a portion of the contributions in an unallocated general account. The account is credited with the earnings on the underlying investments less charges for participant withdrawals and administrative expenses. The account is carried at contract value. The contract value, as reported to the Plan by VALIC, is determined by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. The contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (such as divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event is probable.

NOTE 5 – GUARANTEED INTEREST ACCOUNTS – CONTINUED

The VALIC general account is guaranteed to receive a stated rate of interest that is periodically determined by VALIC. Withdrawals made after the first year of the contract are subject to a market value adjustment. All of the Plan's investments in VALIC's general accounts are dated more than one year beyond the contract date and will be subject to the market value adjustment applied to withdrawals.

NOTE 6 – STABLE ASSET FUND

Starting in 2019, the Plan invests in a fully benefit-responsive stable asset fund investment contract with Standard Insurance Company. The contract is included in the financial statements at contract value as reported to the Plan by Standard, which approximates fair value. Consistent with Accounting Standards Update (ASU) 2015-12 Part I, *Plan Accounting: Defined Benefit Pension Plans (Topic 965)*, fully benefit-responsive contracts are measured, presented and disclosed at contract value. Therefore, there is no adjustment to the net assets available for benefits for the difference between contract value and fair value in the accompanying financial statements. The contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. Daily liquidity at contract value is available for participant contributions and withdrawals.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Participants' stable asset fund balances are credited with interest daily, at a single annual effective net interest rate. The guaranteed crediting interest rate is declared by Standard in advance and locked in for the calendar quarter. The interest rate is contractually guaranteed never to be less than 1%. The average yield on the contract on an annualized basis was 3.04% and 2.78% in 2024 and 2023, respectively.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 9 – EXCESS AGGREGATE CONTRIBUTIONS

Excess aggregate contributions, resulting from the failure of the relevant nondiscrimination tests, were \$1,560 and \$2,543 in 2024 and 2023, respectively, including applicable earnings. The amounts were refunded timely to affected participants.

NOTE 10 – RISKS AND UNCERTAINTIES

The Plan provides various investment choices for participants to self-directed accounts. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 11 – PLAN TERMINATION

Although it has not expressed any intent to do so, the sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.


