## **INDEPENDENT AUDITOR'S REPORT**

To the Board of Directors

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Neighborhood Service Organization 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, as amended ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The Plan's management has obtained certifications from a qualified institution as of, and for the years ended, December 31, 2024 and 2023, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### **Basis for Opinion**

**NOTE A — DESCRIPTION OF THE PLAN**

**General**

The following brief description of the Neighborhood Service Organization 403(b) Retirement Plan (the “Plan”) is provided for general informational purposes only. Participants should refer to the Plan document and amendments for more details regarding the Plan.

The Plan, which was adopted on December 1, 2007 and restated on December 1, 2020, is a defined contribution pension plan established for the employees of Neighborhood Service Organization (“NSO”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

**Eligibility**

The Plan covers substantially all full-time and regular part-time employees who are employed by NSO.

**Contributions**

The Plan provides for participant salary deferral contributions, including pre-tax and Roth deferrals, up to a maximum of the lesser of 100 percent of eligible compensation or maximum-tax deferred limitations established by the Internal Revenue Code (“IRC”). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

NSO makes matching contributions to the Plan on behalf of the participants equal to 50 percent of participant elective deferrals, up to the first four percent of each participant’s compensation for the period, based on specific eligibility rules, as listed in the Plan document. In addition, NSO may make annual discretionary contributions to the Plan in an amount to be determined by the Plan’s management.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions, NSO’s contributions, and an allocation of Plan earnings. Allocations are based on participants’ compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**NOTE A — DESCRIPTION OF THE PLAN (CONTINUED)**

**Distributions**

On termination of service, death, disability, or attainment of normal retirement age, a participant may elect to receive a lump-sum amount, to receive installment payments equal to the vested portion of the participant's account, to leave the account in the Plan, or to rollover the vested balance to another qualified retirement plan or individual retirement account.

Immediate lump-sum distributions are made to terminated participants if the participant's vested account balance is \$5,000 or less. For terminated participants with vested balances greater than \$5,000, participants may elect to receive a full or partial distribution of the vested portion of their account at any time following their termination of employment. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan document. Participants may also withdraw an amount at age 59½ if certain criteria are met.

**Vesting**

Participants are immediately 100 percent vested in their voluntary contributions plus actual earnings thereon. Participants are 100 percent vested in employer contributions after three years of service plus actual earnings thereon.

**Investment Options**

Upon enrollment in the Plan, a participant may direct contributions in any of several investment options selected by NSO's Board of Directors.

**Notes Receivable from Participants**

Participants may borrow from the Plan a minimum of \$1,000. The maximum amount that may be borrowed from all outstanding loans is 50 percent of the vested account balance, up to \$50,000. Loans are secured by the participant's account and incur a reasonable interest rate, based on interest rates charged on similar loans. Repayment of any loan is made no less frequently than quarterly over a period of five years or less (the payment period can be up to 10 years for loans used to acquire a participant's principal residence).

**Forfeitures**

If a participant is not fully vested on that person's termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future employer contributions or to pay administrative expenses of the Plan.

**NOTE B — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investments**

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price).

Shares of registered investment companies are valued at quoted market prices that represent the asset value of the shares held by the Plan at the end of the year.

The fully benefit-responsive investment contract is stated at contract value, as described in Note E.

Purchases and sales of investments are reflected on a trade-date basis. Gains and losses on sales of securities are based on average costs. Dividend income of the investment accounts is recorded on the ex-dividend date. Income from investments is recorded as earned on an accrual basis. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes Receivable from Participants**

Notes receivable from participants are recorded at cost plus accrued interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant note receivable balance is reduced and a distribution is recorded. A valuation allowance for credit losses is not considered necessary as of December 31, 2024 or 2023.

**Fair Value Measurements**

The Plan uses fair value measurements in the preparation of its financial statements, which utilize various inputs, including those that can be readily observable, corroborated, or are generally unobservable. The Plan utilizes market-based data and valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Additionally, the Plan applies assumptions that market participants would use in pricing an asset or liability, including assumptions about risk.

**NOTE B — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Fair Value Measurements (continued)**

The measurement of fair value includes a hierarchy based on the quality of inputs used to measure fair value. Financial assets and liabilities are categorized into this three-level fair value hierarchy based on the inputs to the valuation technique. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets and liabilities and the lowest priority to unobservable inputs.

The various levels of the fair value hierarchy are described as follows:

- Level 1 — Financial assets and liabilities whose values are based on unadjusted quoted market prices for identical assets and liabilities in an active market that the Plan has the ability to access
- Level 2 — Financial assets and liabilities whose values are based on quoted prices in markets that are not active or model inputs that are observable for substantially the full term of the asset or liability
- Level 3 — Financial assets and liabilities whose values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement

The use of observable market data, when available, is required in making fair value measurements. When inputs used to measure fair value fall within different levels of the hierarchy, the level within which the fair value measurement is categorized is based on the lowest level input that is significant to the fair value measurement.

**Contributions**

Participant and employer contributions are recorded in the period that payroll deductions are made from participants. Participants' pre-tax and Roth contributions are paid to the Plan when amounts can be reasonably segregated.

**Payment of Distributions**

Distributions to Plan participants are recorded when paid.

**Administrative Expenses**

Expenses of administering the Plan are paid either out of forfeited assets or by NSO and are not charged to the participants' accounts.

**NOTE B — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, as well as disclosure of contingent assets and liabilities, at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in various investment securities, including registered investment companies and an investment contract. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**Subsequent Events**

The Plan's management has evaluated subsequent events through October 6, 2025, the date that the accompanying financial statements were available to be issued.

**NOTE C — PLAN TERMINATION**

Although it has expressed no intention to do so, NSO has the right to terminate the Plan, subject to the requirements of ERISA. In the event the Plan is terminated, the net assets available to provide benefits would be distributed to the participants in proportion to their respective account balances after payment of expenses properly charged against the Plan.

**NOTE D — INVESTMENTS AND FAIR VALUE**

The following is a summary of information regarding the Plan, included in the Plan's financial statements, that was obtained or derived from information provided to the Plan administrator, and was certified as complete and accurate, by Reliance Trust Company, the Plan's custodian. Information included in the supplemental schedule of assets (held at end of year) was also obtained from, and certified as complete and accurate by, the custodian.

**NOTE E — INVESTMENT CONTRACT**

The Plan has a benefit-responsive investment contract with The Standard, which serves as the Plan's recordkeeper. The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and interest at a specified credit rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a quarterly basis for resetting, but may not be less than two percent. When establishing interest crediting rates for this product, The Standard considers factors, including account interest rate forecasts provided by the investment contract issuer's asset advisory group.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, or (iii) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan. The Plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable.

**NOTE E — INVESTMENT CONTRACT (CONTINUED)**

Certain events allow The Standard to terminate the contract with 30 days written notice to the Plan. Such events include the following: (i) failure to abide by state or federal law, (ii) failure to perform and comply with the terms on the contract, (iii) failure to maintain assets of at least \$25,000, (iv) Plan disqualification, or (v) failure to adopt the Plan within a reasonable period. The Plan administrator believes that the occurrence of any such events, which would allow The Standard to terminate the contract, is not probable.

**NOTE F — INCOME TAX STATUS**

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (“IRS”). The volume submitter plan has received a favorable notification letter from the IRS dated March 31, 2017. The Plan has not individually sought its own determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. In addition, the Plan administrator is not aware of any uncertain tax positions or unrecognized tax benefits as of December 31, 2024 or 2023. Therefore, no provision for income taxes has been included in the Plan’s financial statements.
