Opinion

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The Health Professionals Staff Health and Welfare Trust Fund (the "Plan") is a welfare benefit plan established on August 1, 2020. The Plan provides health and welfare benefits to active and retiree participants on whose behalf contributions to the Plan were sent in accordance with its Collective Bargaining Agreement or Participation Agreement. Dependents of eligible active participants are also eligible for certain specified benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Contributions

Contributions are reported on the financial statements on the accrual basis. Employer contributions are contributions made by employers on behalf of eligible employees for months worked during the year. Participant contributions are payments by participants for months of coverage during the year. Contributions receivable is based on contributions received subsequent to the end of the year. Reimbursements are based on the cost of plan administrative expenses. No allowance is provided for estimated uncollectible accounts.

D. Benefits

Benefits reported are premiums for eligible participants paid during the year (premiums paid). Benefit obligations consists of premiums payable, which is an estimate of premiums for coverage during the year, unpaid at the end of the year. As of December 31, 2024 and 2023, the Plan has no benefit obligations.

E. Other Income and Expenses

Other income and expenses are reported on the accrual basis, except for nominal amounts of recurring monthly expenses.

F. Plan Termination

Although there is no intent to terminate the Plan, in the event of termination, the Agreement Declaration of Trust provides that any assets remaining in the Plan shall be used solely for the continuance of health and welfare benefits to participants, beneficiaries and employees and eligible members of their families in a fair, equitable basis until such assets have been exhausted.

NOTE 4 - TAX-EXEMPT STATUS

The Plan is tax-exempt under Internal Revenue Code Section 501(c)(9) and from the state of California under Revenue and Taxation Code Section 23701i; therefore, no provision is made for federal or state income taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - CONCENTRATION OF EMPLOYER CONTRIBUTIONS

One employer, subject to a collective bargaining agreement, provides the majority of employer contributions and reimbursements to the Plan. Employer contributions and reimbursements from the significant employer totaled \$2,804,190 or 92% and \$2,443,749 or 91% of total employer contributions and reimbursements for the years ended December 31, 2024 and 2023, respectively.

NOTE 6 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 6, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
