We have audited the financial statements of **Brown Parker & DeMarinis LLC**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”) for the year ended December 31, 2024, and we issued our report thereon dated October 2, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment by Empower Trust Company, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America (“U.S. GAAP”). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated July 14, 2025. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Findings

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note B to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements and are based on your knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. There were no particularly sensitive estimates noted during the audit.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the financial statements were:

Notes A, B, C and G

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor’s report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan’s financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no such misstatements identified during the audit.

Reportable Findings

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified the following reportable findings:

- Evidence of Fiduciary Oversight

Management should maintain procedures to document discussions and meetings held by the Plan's oversight committee, which should occur annually at a minimum. This provides evidence of addressing management's fiduciary responsibilities.

- Participant Deferral Rate Discrepancies (Significant Deficiency)

During our testing of participant contributions, we identified discrepancies involving several participants where the deferral rates elected by the individuals in the Provider website did not align with the actual rates withheld from their compensation and remitted to the Plan. These inconsistencies resulted in variances between the participants' intended annual contributions based on their elections and the amounts actually contributed to the Plan through payroll deductions.

This issue highlights the importance of maintaining accurate and up-to-date payroll and plan records. In accordance with ERISA Section 209, employers are required to retain records sufficient to determine the benefits due—or that may become due—to each employee. Consequently, Plan Sponsors should ensure that such records are preserved indefinitely, whether in original paper form or electronically, provided the electronic records meet applicable regulatory standards.

We recommend that management implement enhanced controls to ensure that participant deferral elections are accurately captured and consistently applied in payroll processing. Additionally, we advise periodic reconciliations between payroll records and plan deferral elections to detect and correct discrepancies in a timely manner. Maintaining robust documentation practices will support compliance with ERISA requirements and help safeguard participant benefits.

- Erroneous Employee Deferrals and Employer Matching contribution

Upon reviewing the Census report, we identified one employee who received employee deferral and employer matching contributions despite having no compensation during the Plan Year. Upon discussion with management, it was confirmed that these contributions were entered in error, and corrective action is currently underway. We recommend the Plan Sponsor to promptly reverse the erroneous contributions and adjust plan records accordingly, strengthen validation controls to prevent contributions for employees with zero compensation, and perform regular reconciliations between payroll and plan data to detect anomalies.

- Inconsistencies in Employer Match Contributions and Misallocation of Participant

During the contribution testing, it was observed that employer match contributions were not consistently aligned with the plan provision of 100% matching of participant deferrals up to 6% of compensation, calculated on a per-payroll basis. This inconsistency affected multiple participants and resulted in underfunded match contributions.

Furthermore, upon performing a match true-up recalculation, it was discovered that several employee deferral contributions and corresponding employer match amounts were erroneously allocated to other participants. These misallocations led to discrepancies in participant account balances, resulting in discrepancies such as overfunding, underfunding, and potential refunds or receivables across the plan.

These errors indicate a breakdown in the payroll-to-plan reconciliation process and raise concerns about the accuracy of remittances and the integrity of participant account records. Immediate corrective actions are necessary to ensure that all contributions are properly allocated and that participants receive the correct match amounts as stipulated by the plan.

We recommend management to conduct a full reconciliation of affected participant accounts, implement automated validation checks in payroll and contribution systems, establish a formal review process for remittances, and promptly communicate with impacted employees regarding the discrepancies and corrective actions.

- Incorrect Vesting Percentage used in Distribution

During distribution testing, we noted that one participant was erroneously approved for an 80% vesting percentage in the employer matching source, instead of the correct 60% under the Plan's 2–6 year graded vesting schedule. Management confirmed the error and is in the process of refunding the overpaid amount of \$545 to the Plan to ensure it remains whole. We recommend the Plan Sponsor to correct the overpayment promptly and ensure the Plan is reimbursed, review and strengthen controls around vesting calculations, including system logic and manual override procedures, and conduct periodic audits of vesting determinations to detect and prevent future errors.

- Forfeiture Allocations

We noted that the Plan had an outstanding forfeiture of approximately \$20,000 as of December 31, 2024. Employers should monitor forfeiture account balances before any employer contributions are deposited into the trust and before any plan expenses are paid by the employer. This will help to ensure that outstanding balances in the forfeiture accounts are being used timely. Many plan documents specify when the forfeitures must be used by. As noted above, some plans specify that forfeitures must be used in the plan year in which the funds are forfeited. Other plans specify that forfeitures may be used in the following year. However, the Code does not allow for forfeitures to be held in suspense accounts beyond the plan year in which they arise. This would make it so a plan could not carry over forfeitures into another year past the year in which they were forfeited. Additionally, Treasury Regulations Section 1.401-7(a) states that forfeitures must be used as soon as possible to reduce employer contributions. Revenue Ruling 84-156 also states that they may be used to pay plan expenses and/or to reduce employer contributions.

Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 2, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

The Plan has been amended to adopt the mandatory requirements of the SECURE 2.0 Act of 2022, and management continues monitor the remaining provisions that are required to be implemented over the next few years.

Other Matter - Change of Engagement Partner

We would like to inform you that the engagement letter you signed dated February 24, 2025 is amended to indicate that Maria Sanjurjo is the engagement partner. She is responsible for supervising the engagement and signing the report or authorizing another individual to sign it. All other terms and conditions of this engagement letter remain the same.

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

This information is intended solely for the use of those individuals charged with governance and, if appropriate, management of the Plan and is not intended to be, and should not be, used by anyone other than these specified parties.

Note A – Description of Plan

The following description of the Brown Parker & DeMarinis LLC (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions and the participants’ investment options.

General

The Plan is a defined contribution plan covering all employees of Brown Parker & DeMarinis LLC (collectively, the “Company” or “Employer”). The Plan was formed and adopted on September 1, 2008, and most recently restated December 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employees become eligible to participate in the Plan upon reaching 21 years of age and completing 1 month of service. Union employees are excluded from participation. Eligible employees may enter the Plan on the first day of the month coinciding with or following the date eligibility requirements are satisfied.

Administration

The Plan is administered by the Company. The Plan’s assets through December 31, 2024 were maintained and administered by Empower Trust Company (the “Custodian”). Contributions are held by Empower Trust Company, who invests cash received, interest and dividend income, as directed by the participant, and makes distributions to participants.

Contributions

The Plan allows eligible participants to make contributions up to 100% of their compensation, subject to Internal Revenue Code (“IRC”) limitations. The maximum participant deferral for the year ended December 31, 2024 was \$23,000. A participant who has attained the age of 50 may also make catch up contributions, subject to Internal Revenue Services (“IRS”) limitations of \$7,500 for the year ended December 31, 2024. Participants may also make Roth deferrals and contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Under the terms of the Plan, the Company is required to make a matching contribution in an amount equal to 100% of the participant’s salary deferrals that do not exceed 6% of compensation. The Company also has the option to make a discretionary non-elective contribution. A participant will become eligible to receive matching contribution and non-elective contribution upon completion of 1 Year of Eligibility Service or at least 1,000 Hours of Service. Participants must be employed on the last day of the year to receive a non-elective contribution or must have completed at least 500 hours of service during the Plan Year, except when the employee terminates employment due to death, disability or retirement. During the Plan year ended December 31, 2024, the Company did not make any nonelective contributions.

Participant Accounts

Each participant’s account is credited and/or reduced with the participant’s elective referral contributions and distributions, the Company’s contributions, and an allocation of the Plan’s investment earnings/losses, investment fees and any administrative expenses paid out of the Plan. Allocations are based on participant earnings or account balances, as defined in the Plan.

Vesting

Participants are immediately vested in their voluntary contributions and rollovers plus actual earnings thereon. Vesting in Company match and non-elective contributions are based on years of continuous service. A participant is 100% vested upon death, disability, retirement or after six years of credit service as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The \$50,000 is reduced by the highest outstanding loan balance during the past 12 months or any existing loan balances on the date a new loan is made, whichever is greater. Participants may only have two loan outstanding at a time, one general purpose loan and/or one principal residence loans are allowed at any one time. The notes are secured by the balance in the participant's account, or other acceptable collateral, and bear interest at a rate of 1% over the prime rate published in the Wall Street Journal on the first business day of the month the loan is originated. The maximum note repayment period is five years unless the note is for the purchase of a primary residence in which case the repayment schedule may be for a term in excess of five years. Principal and interest payments with respect to the notes are credited solely to the account of the borrowing participant from which the note was made.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. In the event of default, the unpaid portion of the participant's loan will be treated as a taxable distribution by the end of the calendar quarter following the calendar quarter in which payment is first delinquent.

Distribution of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial withdrawals or installments paid over a period of assumed life expectancy, as defined in the Plan agreement, less any applicable taxes. Participants may also request a hardship withdrawal for qualifying expenses from the portion of their accounts attributable to participant deferral balances.

Forfeitures

Forfeitures occur when a participant terminates employment and has not vested in a portion of the Company's contribution amount. Forfeitures may be applied to reduce Employer contributions and Plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$20,000 and \$7,000, respectively. For the year ended December 31, 2024, approximately \$200 of forfeitures were used to offset Employer matching contributions and pay Plan expenses.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, each participant's account will become fully vested and non-forfeitable. All appropriate accounting provisions of the Plan will continue to apply until the accounts of all participants have been distributed.

Note B – Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of changes in net assets during the reporting period. Such estimates include those regarding fair value. Actual results could differ from those estimates.

Valuation of Investments

The Plan's investments are stated at fair value. If available, quoted market prices are used to value investments. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Fair Value Measurements

The Financial Accounting Standards Board ("FASB") has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described in succeeding page.

<i>Level 1</i>	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
<i>Level 2</i>	Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
<i>Level 3</i>	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan as of December 31, 2024 were deemed to be actively traded.

Common/collective investment trust: Valued at NAV provided by the Custodian. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2024. Participant-directed redemptions had no restrictions and are recorded at the end of every business day.

Pooled separate accounts: Valued at the net asset value ("NAV") provided by the Custodian. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2023. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments measured using the NAV as a practical expedient are exempt from being presented in the fair value hierarchy. As all of the 2023 Plan's investments are exempt from the fair value hierarchy, the table has been excluded.

Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, a qualified institution. As of December 31, 2024 and 2023, and for the year ended December 31, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by Empower Trust Company, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note D – Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service dated June 30, 2020 stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation under Section 401 of the IRC. The Plan Administrator and its qualified tax counsel do not anticipate that changes in the Plan after the date of the amendments covered by the Internal Revenue Service determination letter will affect the qualified and tax-exempt status of the Plan.

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2021.

Note E – Risks and Uncertainties

The Plan provides for various investment options which are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to the changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note F – Party-In-Interest Transactions

Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. Certain Plan investments and the related transactions as of December 31, 2024, and for the year then ended, were in investment funds managed by the Custodian; therefore, these investments and transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$3,000 during the year ended December 31, 2024.

Note G – Fully Benefit-Responsive Investment Contracts

The Plan invests in a fixed annuity (General account, “the Fund”) provided through a group annuity contract. Under the Fund, a crediting rate is established and is credited with contributions and charged for participant withdrawals and administrative expenses charged by the Custodian of the Fund. The guaranteed interest contract issuers are contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Specific coverage provided by each contract may be different from each issuer and can be found in the contract of the Fund. Examples of such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investments options or deletion of equity wash provision, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with participants, is probable.
