Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about CSSS.NET 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedules of Schedules of Assets (Held at End of Year) and Nonexempt Transactions as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

For the Years Ended December 31, 2024 and 2023

NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation – The accompanying financial statements of CSSS.NET 401(k) Plan (the Plan) are prepared under the accrual method of accounting and in conformity with U.S. generally accepted accounting principles. The Plan Sponsor did change its corporate name to Constellation West (the Company), but the name of the plan remains the same.

General – The Plan originated in February 2011.

Administration of the Plan – The Plan, sponsored by the Company, is a defined contribution retirement plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Plan Sponsor believes it is in compliance with ERISA. Some administrative expenses related to the Plan are paid by the Company. The Company has no reversionary interest in the Plan.

Investment Valuation and Income Recognition – The Company entered into a Group Annuity Contract with the Trustee. The employees direct their contributions to be invested in investment options that consist of mutual funds offered by the Trustee. The Plan's investments are stated at fair value. The Plan's investment accounts are mutual funds offered by the Trustee. Each mutual fund investment is valued at fair value by the Trustee at the close of each business day.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE B – DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

Eligibility – Under the terms of the Plan, an employee will be eligible to participate in the plan immediately upon hire if they attained age eighteen and met all other eligibility requirements.

Contributions and Participant Accounts - 401(k) Provision – Each participant may elect to make salary reduction 401(k) contributions of not less than 1% up to 100% of their compensation, as defined, subject to federal deferral limits. Each participant may also elect to make Roth contributions of not less than 1% up to 100% of their compensation, as defined, subject to federal deferral limits. Employees over the age of 50, may make “catch-up” contributions subject to federal annual limits. The Company makes safe harbor matching 401(k) contributions equal to 100% of the participant's deferral up to 1% plus 50% of the participant's deferral from 1% up to 6% of compensation. Participant and Company 401(k) contributions are allocated within each participant's account to investment options based upon the participant's current investment allocation elections. Annual 401(k) contributions are subject to limitations set by the Internal Revenue Service.

The Plan also offers automatic enrollment as a feature of the plan and all eligible employees are automatically enrolled at 3% of salary. The percentage of salary for automatic deferrals gradually increases to 6% based on the plan year of application to the participant. Employees are given the option to elect out of participation if they choose to do so.

Each participant's account is credited with the participant's elective deferral 401(k) contributions, employer safe harbor matching 401(k) contributions, an allocation of the Plan earnings and forfeitures of terminated participant's non-vested accounts and charged with an allocation of administrative expenses. Allocations are based on participant account balances as defined.

Forfeitures – Forfeitures are amounts that come from terminated employees (participants) share of employer matching 401(k) contributions that are not vested. Forfeitures can be used to offset 401(k) plan expenses and employer matching contributions. The forfeiture balance was \$485 and \$477 as of December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, forfeited amounts total approximately \$1,010 and \$10,513, respectively.

Vesting – Active participating employees become 100% vested in employer safe harbor matching 401(k) contributions after two years of service. Participants are immediately vested in all employee 401(k) contributions.

NOTE B – DESCRIPTION OF PLAN – Continued

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

Benefits – Upon the participant's retirement or termination of service, the Company shall value and distribute the participant's account in accordance with the Plan document and the Internal Revenue Code. Separate provisions apply in the event of death or disability of the participant. Payments are to be made in a lump sum. Withdrawals prior to termination of employment or retirement are prohibited unless elected by the participant under the following conditions: attaining age 59 ½, establishing permanent and total disability, demonstrating financial hardship, or otherwise allowed by the applicable laws and regulations.

NOTE C – INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (the trustees of the Plan).

NOTE D – FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification No. 820 (ASC 820) *Fair Value Measurements and Disclosures* (formerly Statement No. 157, *Fair Value Measurement*), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

NOTE D – FAIR VALUE MEASUREMENTS – Continued

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques that are used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price reported in the active market in which the individual funds are traded.

Common/collective trusts: Common/collective trusts hold investments in domestic and foreign equity securities, debt securities, and units in other affiliated and unaffiliated comingling trusts. The underlying assets may be valued based on quoted market prices, independent pricing service or by dealers making a market for certain securities. The unit value of the common/collective trusts are determined by dividing the underlying net asset values (assets less liabilities) by the outstanding number of units (Level 2).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – RELATED PARTY TRANSACTIONS

A party-in-interest, as defined by Section 3(14) of ERISA, includes, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Accordingly, loans to participants are considered party-in-interest transactions. Fees incurred by the Plan to the trustee for investment and trust services amounted to \$44,467 and \$39,562 for the years ended December 31, 2024 and 2023, respectively. There were no fees payable at December 31, 2024 and 2023, respectively.

NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company retains the right under the Plan to discontinue its matching contributions at any time or to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts and the assets will be distributed as determined by the Plan.

NOTE G – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE I – SUBSEQUENT EVENTS

Subsequent events were evaluated through September 23, 2025, which is the date the financial statements were available to be issued.
