## **Note 1. Plan Description**

The following description of Saratoga Medical Center 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

### ***General***

The Plan, established on January 1, 2020 and amended and restated January 1, 2022, is a defined contribution plan covering eligible employees of Saratoga Medical Center, Inc. (the “Company”). There is no minimum age or service requirement for full-time employees to participate in the Plan. An employee’s entry date into the Plan is immediate upon date of hire. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA). Effective January 30, 2024, plan assets of \$2,556,943 were transferred from Voya Retirement Insurance and Annuity Company (“Voya”) to Principal Life Insurance Company (“Principal”).

### ***Participant Contributions***

Participants may contribute up to 100% of eligible compensation as pre-tax or Roth deferrals, subject to the annual limit of the Internal Revenue Code (IRC). Participants aged 50 and over may make additional pre-tax contributions. Participants may also contribute amounts representing eligible rollovers from other qualified plans.

### ***Employer Contributions***

The Company will make a contribution for each Participant’s Prevailing Wage Service based on the hourly contribution rate for the Participant’s employment classification. For the year ended December 31, 2024, the Company made prevailing wage contributions totaling \$690,665. Highly compensated employees and Private Health Care Facility Employees Under Commercial Contracts are not eligible to receive employer contributions.

### ***Vesting***

Participants are 100% vested in their salary deferred contributions, as well as any employer contributions, and related investment income and losses thereon.

### ***Participant Accounts***

Individual participant accounts are credited with applicable participant contributions, an allocation of the Company’s contributions, and investment earnings or losses, and are charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

### ***Investment Options***

Participants may direct contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis.

### ***Distributions***

Distributions from the Plan are permitted under the following circumstances: (i) attainment of age 59 ½, (ii) termination of employment, (iii) death or permanent disability, and (iv) a proven hardship. Distributions from a participant’s account are made in the form of a lump-sum payment or annual installment at least equal to the required minimum distribution amount. If a terminated participant’s account balance does not exceed \$1,000, the balance may be distributed to a terminated participant without consent.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value or contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. See Note 5 for discussion of contract value measurements. Dividends are recorded on the ex-dividend date. Interest is included in income when earned, based on the terms of the investments and the periods during which the investments are owned. Purchases and sales of securities are recorded on a trade-date basis.

Pooled separate accounts are valued at estimated fair value as provided by Principal.

The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments which consists of realized gains or losses, and unrealized appreciation or depreciation on those investments.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of Plan income and expenses during the reporting period. Actual results could differ from those estimates.

### ***Administrative Expenses***

Administrative expenses of the Plan are paid by either the Plan or the Company, as provided in the Plan document.

### ***Subsequent Events***

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

## **Note 3. Certification of Plan Trustees**

**Note 4. Disclosure About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises 3 levels of inputs that may be used to measure fair value.

**Level 1:** Quoted prices in active markets for identical assets or liabilities.

**Level 2:** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

**Level 3:** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan had no Level 1 or Level 3 investments at December 31, 2024 and 2023.

**Note 5. Investment Contract with Insurance Company**

The Plan had an investment contract with Voya whereby allocated contributions are maintained in a Guaranteed Interest Account (GIA) as of December 31, 2023. The GIA is credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses. The contract is fully benefit-responsible and is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with Voya. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption under Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. The investment contract does not permit Voya to terminate the agreement prior to the scheduled maturity date.

**Note 6. Related-Party and Party-In-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

All plan investments are managed by Voya, the trustee of the Plan, therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules as defined by ERISA. Fees paid by the Plan for recordkeeping and investment management services amounted to \$41,332 for the year ended December 31, 2024.

**Note 7. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype 401(k) profit sharing plan and trust sponsored by Alliant Insurance Services Inc. (Alliant). This prototype plan document has been filed with the appropriate agency and has obtained an opinion letter from the IRS stating the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan provides for various investment options in accounts which invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Note 9. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants will become fully vested in their accounts.

**Note 10. Excess Contributions Payable**

Excess contributions payable represents amounts owed to participants who made excess contributions based on compliance testing performed by the Plan’s recordkeeper. The excess contributions payable as of December 31, 2023, were remitted by the Plan to the participants in March 2024.

**Note 11. Reconciliation of Financial Statements to Form 5500**

The Form 5500 was prepared on the cash basis for the Plan year ended December 31, 2024 and the financial statements were prepared on the accrual basis.
