### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Alfred Conhagen, Inc. 401(K) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of Alfred Conhagen, Inc. 401(K) Profit Sharing Plan (The Plan) is provided for general information purposes only. Participants should refer to the plan specifications or the plan adoption agreement for more complete information:

- a. General - The Plan is a defined contribution plan 401(K) covering substantially all the employees of Alfred Conhagen, Inc., Alfred Conhagen, Inc. of Texas, Alfred Conhagen, Inc. of California, Alfred Conhagen, Inc. of Louisiana and Conhagen Industries, Inc. (The Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (ERISA), and the Internal Revenue Code of 1986 as amended.
- b. Contributions – Eligible participants are employees of the Company upon reaching the age of 21 and after completing one year of service. An employee will be deemed to have completed one year of service on the last day of the applicable eligibility computation period during which the employee is credited with 1,000 hours of service. Participants may elect to make deferred salary contributions up to a maximum allowed under Code Section 402.

The Employer may in its sole discretion make contributions to the Plan. These contributions may be either matching or non-elective. A matching contribution is made on behalf of a participant on account of a participant's elective deferral. Non-elective contributions are employer contributions other than matching contributions that participants cannot elect to receive in cash until such contributions are distributed from the Plan. No matching contributions were made by the Company in 2024 or 2023. Effective September 1, 2019, the Employer elected to make non-elective contributions equal to five-percent (5%) of active participants payroll for employees of Alfred Conhagen, Inc. of California and Alfred Conhagen, Inc. of Louisiana. Effective January 1, 2023, the Employer elected to make non-elective contributions equal to five-percent (5%) of active participants payroll for employees of Alfred Conhagen, Inc., Alfred Conhagen, Inc. of Texas and Conhagen Industries. Prior to 2023 non-elective contributions for employees of Alfred Conhagen, Inc., Alfred Conhagen, Inc. of Texas and Conhagen Industries were covered under the Alfred Conhagen, Inc. Pension Plan.

Participant elective deferrals, at the discretion of the Plan administrator, are allocated into participant-directed accounts. Participants at all times have a 100% vested interest in their elective deferral accounts. Plan participants vesting in employer matching and non-elective contributions are based upon the following schedule:

If a Plan Participant is terminated, any amounts that are not vested are deemed forfeited. The Plan Administrator may elect to use all or any portion of non-vested forfeited amounts to pay administrative costs of the Plan, reduce the amount of Matching and Non-Elective contributions, or any combination, thereof.

The Company provides or pays for certain administrative services for the Plan. The Company receives no fee or reimbursement for these costs.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

1. Basis of Accounting – The financial statements of the Plan are prepared using the accrual method of accounting.
2. Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that effect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
3. Investment Valuation – The Plan’s investment assets are reported at their market value in the statement of net assets available for benefits. The market values were determined from the last reported prices on the last day of the Plan’s year. Purchases and sales of investments are reported on a trade-date basis. In accordance with stating investments at fair value, net unrealized appreciation or depreciation for the year is reflected in the statement of changes in net assets available for benefits.
4. Payment of Benefits – Benefit payments to participants are recorded upon distribution.

NOTE 3 – PLAN MERGER

In March 2023, the Board of Directors of The Company approved a merger of The Plan into the Ovation Holdings, Inc. 401K Plan (Ovation Plan) effective January 1, 2024. As a result, all investments were transferred from The Plan into the Ovation Plan in January 2024. The year ended December 31, 2024 is the final year of The Plan.

NOTE 5 - RELIANCE ON CUSTODIAN'S REPORTS

All information relating to investments included in Statement of Net Assets Available for Benefits, Statements of Changes in Net Assets Available for Benefits and Schedule H, Form 5500 Financial Schedules was provided by Benefit Plan Administrative Services, Inc., the Custodian. The Custodian has certified to the Plan administrator that the information provided to the Plan administrator by the Custodian as December 31, 2024 and 2023 and for the plan years then ended is complete and accurate.

NOTE 6 – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated November 5, 2003, that the Plan, as then designed, amended and restated, is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan files a tax return in the federal jurisdiction and has no open tax years prior to 2021. The Plan will file a final tax return for the year ending December 31, 2024.

NOTE 7 – PLAN AMENDMENTS

The Plan Sponsor and/or Trustee reserve the right to amend the Plan at any time. These amendments must be in writing and are subject to certain limitations as prescribed by the Employee Retirement Income Security Act of 1974 as amended (ERISA), and the Internal Revenue Code of 1986 as amended.

NOTE 8 – PARTICIPANT LOANS

Participants may borrow from their fund accounts up to a maximum of the lesser of \$50,000 or 50% of the present value of the non-forfeitable portion of the Individual Account. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate, which is commensurate with the local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through periodic payroll deductions.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value (level 1) and (level 2) in the accompanying statement of net assets available for benefits.

Fair value accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used when Level 1 inputs were not available, and Level 3 inputs were only used when Level 1 or Level 2 were not available. The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Fair Value Measurements –

Inputs to the valuation methodology include quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 - Fair Value Measurements –

Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset and liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. The common collective trusts held by the Plan have net assets values that are deemed to be published.

If an asset or liability has a specified (contractual) term, level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Fair Value Measurements –

Inputs to the valuation methodology are unobservable and significant to their fair value measurement of the assets and liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan had no level 3 investments at December 31, 2024 and 2023 and there were no transfers between levels in 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 11 - NEW AUTHORITATIVE ACCOUNTING PRONOUNCEMENTS

The Plan does not anticipate the adoption of recently issued accounting pronouncements to have a significant impact on the Plan's results of operations and financial position.

NOTE 12 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 3, 2025, the date which the financial statements were available to be issued.

NOTE 13 - INVESTMENT MANAGEMENT AND RELATED PARTY TRANSACTIONS

Benefit Plan Administrative Services, Inc. (BPAS) provide investment management services to the Funds. Under the terms of the Declaration of Trust, each Fund pays a monthly fee to BPAS calculated at an annual percentage rate based on the value of the assets of the Fund on the last day of such month.

BPAS provides certain administrative and professional services to certain Funds. For these services, each Fund pays BPAS a fee calculated at an annual percentage based on the closing value of each respective Fund's assets.

The Sponsor pays certain administrative expenses (professional fees and the salaries of individuals who spend part of their time administering the plan) on behalf of the Plan. There is no obligation to the Plan to repay the Sponsor.
