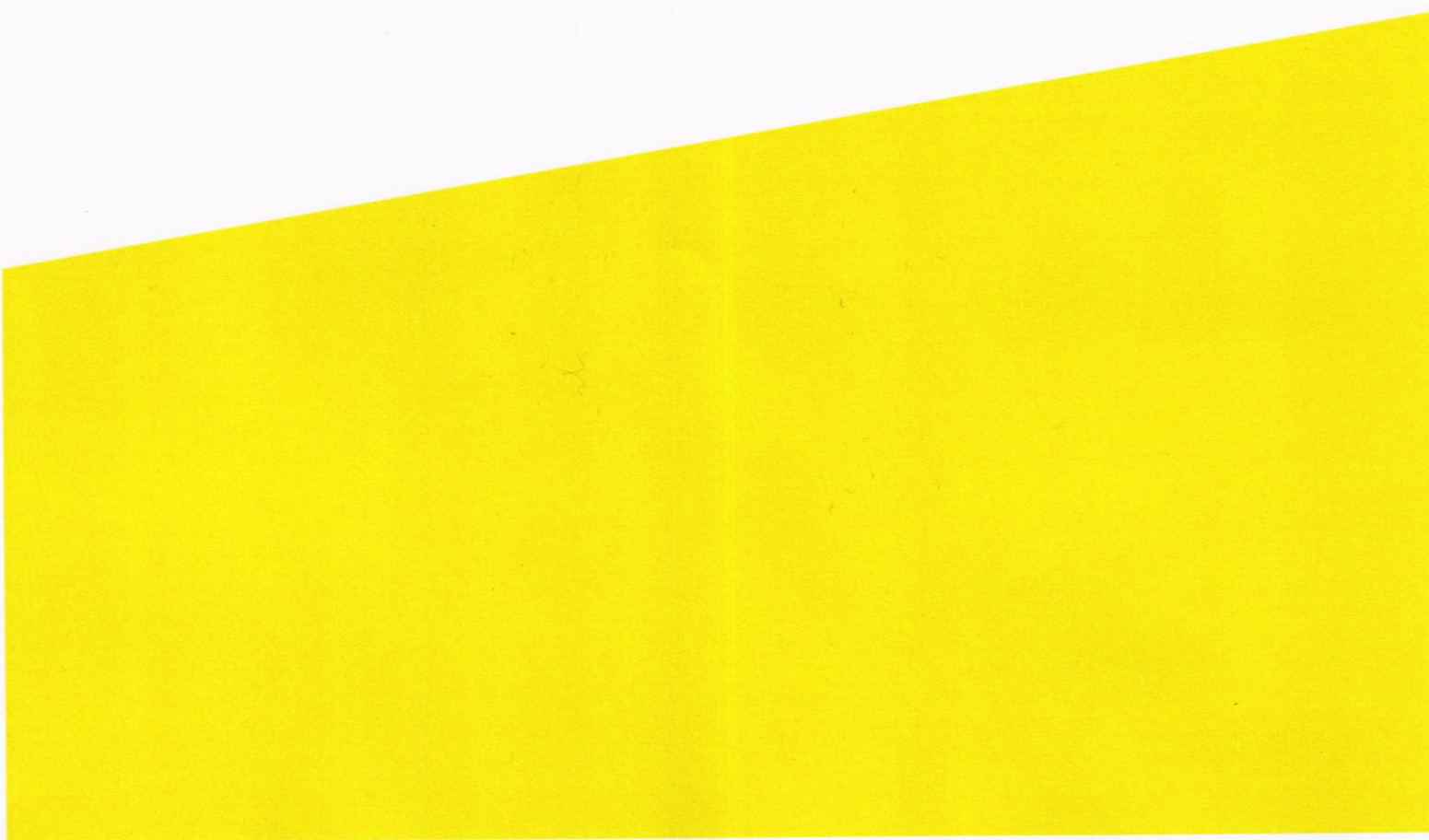

## Report of Independent Auditors

To the Participants and Plan Administrators of  
Calvo Enterprises, Inc. 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Calvo Enterprises, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

## Other Matter

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. **1. Description of the Plan**

The following description of the Calvo Enterprises, Inc. 401(k) Profit Sharing Plan (the Plan) provides general information about the Plan's provisions. Calvo Enterprises, Inc. is the Plan sponsor. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

**General**

The Plan is a defined contribution plan covering all eligible employees of the following entities: Calvo Enterprises, Inc.; Calvo's Insurance Underwriters, Inc.; Pepsi-Cola Bottling Company of Guam, Inc. (Pepsi); Pacific Trading Company, Ltd.; Title Guaranty of Guam, Inc.; Bank of Saipan; and Trans Pacific Insurance Brokers Corporation. All of the above entities are collectively referred to as "the Company."

Employees are eligible to participate in the Plan upon attaining age 18 and upon completion of six months of service. The Plan does not include those employees covered by a collective bargaining agreement, leased employees and independent contractors and employees who are nonresident aliens and who receive no earned income from the Company.

The Calvo Enterprises, Inc. Plan Committee (the Committee) is responsible for the general administration of the Plan. ASC Trust LLC (ASC) is the trustee and custodian of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

On July 11, 2022, the Company amended and restated its Plan documents. Effective January 1, 2021, the Plan excludes housing allowance, deferred compensation and pay under special or unexpected circumstance as an eligible compensation for all contributions.

**Participant Accounts**

Each participant's account is credited with the participant's and the Company's matching and discretionary contributions and allocations of plan earnings. Allocations are based on the participant's share of net earnings or losses of their respective elected investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. Description of the Plan, continued**

**Contributions**

Each year, participants may contribute a percentage of their annual compensation, as defined in the Plan. If automatically enrolled, a participant's deferral is set at 3% of eligible compensation and will be increased in 1% increments for each succeeding plan year of participation up to a maximum of 6% until changed by the participant. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. The Company contributes 100% of the participant's elective deferrals that do not exceed 6% of participant compensation. The Company may also elect to make discretionary matching contributions equal to a percentage of participants' deferrals. In addition, the Company may elect to make discretionary profit sharing contributions. Discretionary matching and discretionary profit sharing contribution amounts are determined by the Company at the end of each year. The Plan also permits rollover contributions from other qualified plans. All contributions are subject to certain limitations of the Internal Revenue Code (the Code).

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. Participants that are automatically enrolled have their contributions invested in the applicable lifecycle fund based on their age until they change their election. The Company's contributions are invested in the same manner as that of the participant's elective contributions.

**Vesting**

Participants are immediately vested in their salary deferrals and rollover contributions plus actual earnings thereon. Vesting in the Company's matching, discretionary matching and discretionary profit sharing contribution portions of a participant's account plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in matching and discretionary matching contributions after two full years of credited service. A participant is 100% vested in discretionary profit sharing contributions after 6 years of service.

**Forfeitures**

Any portion of a participant's account that is not vested upon the participant's termination from service shall constitute a forfeiture as of the earlier of the date of the complete distribution of the participant's vested balance or the last day of the Plan year in which the participant incurs five consecutive one-year breaks-in-service. The allocation of forfeitures shall first be used to fully restore the accounts of participants who are reemployed before incurring five consecutive one-year breaks-in-service. Any remaining amounts shall be added to the discretionary contributions. Unallocated forfeiture balances as of December 31, 2024 and 2023 amounted to \$16,010 and \$3,994, respectively.

**1. Description of the Plan, continued**

**Participant Loans**

Participants may borrow from their accounts in increments of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years or up to 30 years for the purchase of a primary residence. The \$50,000 limit is reduced by the participant's highest outstanding loan balance during the preceding 12-month period. A participant may not have more than one loan outstanding at any point in time. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the date of issuance as determined quarterly by the plan administrator. Principal and interest is paid ratably through monthly payroll deductions. If a participant terminates employment with the Company, they may continue to make loan payments through a pre-authorized check agreement. If the loan is not repaid, it will automatically be treated as a distribution to the participant after 3 months.

**Payment of Benefits**

Upon separation from service with the Company due to death, disability, retirement or termination, a participant whose vested account balance exceeds \$5,000 may elect to receive either a lump-sum or partial withdrawals or installments to comply with required minimum distribution under the Code. A participant whose vested account balance is \$5,000 or less will automatically receive an immediate lump-sum distribution equal to their vested account balance.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS) and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

**Administrative Expenses**

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. Expenses relating to purchases, sales or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by the Company.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

**Contributions**

Participant contributions and the matching employer contributions are recorded in the year in which the participant contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Loan maintenance fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

**Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Use of Estimates**

The preparation of financial statements in accordance with the accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

**Subsequent Events**

Effective June 21, 2025, Calvo's SelectCare Insurance, Inc. 401(k) Plan was merged into the Plan. Employees of Calvo's SelectCare Insurance, Inc. began participating in the Plan effective on the same date.

Management has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available to be issued.

**3. Investments**

All information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends on investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by ASC.

**4. Fair Value Measurements**

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 - Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.

Level 3 - Significant unobservable inputs for the asset or liability (i.e., supported by little or no market activity).

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan.

*Registered Investment Companies (RIC):* RIC consist primarily of mutual fund investments. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust Funds:* The common/collective trust fund investments are valued at their fair value that is readily determinable, published and is the basis for current transactions. These funds are classified within level 1 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Dynamic Retirement Trust (DRT) fund is a collective investment fund which consists of separate investments profiles that provide an appropriate mix of investments that has the potential to produce the desired return while reducing volatility in the overall value of the portfolio. The Profiles primarily invest in registered mutual funds, exchange-traded funds, collective trust funds and money market certificates. The participant directed redemption has no restrictions.

Stable value trust fund is a collective trust fund which invests all of its assets in investment contracts and security-backed contracts that are considered as indirect investment in fully benefit-responsive contracts. The fund seeks to provide investors with a moderate level of stable income without principal volatility. There are currently no redemption restrictions on these investments.

**5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**6. Income Tax Status**

The underlying non-standardized prototype plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying prototype document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator became aware of a potential operational issue, that if not corrected could be treated as a qualification failure, which in turn could affect the tax qualified status of the Plan and its related trust. The Plan administrator is reviewing the details of this potential operational issue and has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**7. Party-in-Interest Transactions**

The Plan holds units of common/collective trust funds managed by ASC. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.
