




#### 1. DESCRIPTION OF THE PLAN

The following description of the **Hagerstown Goodwill Industries, Inc.** (Company) **Employee 401(k) Retirement Plan** (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a volume submitter defined contribution profit sharing plan covering all employees, except clients, who are at least twenty-one and have completed one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan and the appropriateness of the Plan's offerings and monitoring investment performance.

**Contributions:** Each year, participants may contribute up to the maximum amount allowed under IRS Regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may elect to contribute 100 percent of any bonus provided by the Company. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of all amounts allocated to their separate accounts into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

The Company has elected an enhanced matching contributions under safe harbor provisions equal to the sum of 100% of the amount of the participant's elective deferral that does not exceed 4% of the participant's compensation.

Additional discretionary profit-sharing contributions may be contributed at the option of the Company's board of directors. The Company's board of directors did not approve a discretionary contribution for the year ended December 31, 2024.

During the year ended December 31, 2024, the Company made prevailing wage contributions in the amount of \$268,049. Contributions to the prevailing wage plan are participant directed.

All contributions are subject to certain IRS limitations.

**Participant accounts:** Each participant's account is credited with the participant's contribution and allocations of the Company's contributions, Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions and the Company's safe harbor matching contributions, plus actual earnings thereon. Vesting in the discretionary profit sharing contribution portion of their accounts, plus actual earnings thereon are based on years of continuous service. A participant is 100 percent vested after six years of credited service.

In addition, participants become automatically fully vested when they reach age 65 while employed, or terminate employment due to total disability or death.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested balance. The loans are secured by the balance of the participant's account and bear

interest at the prime rate, plus 1 percentage point. Principal and interest are paid ratably through payroll deductions, and outstanding loans are recognized as taxable distributions upon termination of the participant's employment.

**Payments of benefits:** On termination of service for any reason, a participant will receive a lump sum amount equal to the value of the participant's vested interest in their account or they may rollover all or a portion of the distribution to an Individual Retirement Account or another qualified employer plan.

**Forfeited accounts:** These amounts can be used to reduce the amount of future required matching contributions to be made by the Company or to pay Plan administrative expenses. For the year ended December 31, 2024, no forfeitures were used to reduce the employer matching contributions.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of accounting:** The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Significant estimates include fair value determinations provided by the trustee.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies utilized are provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of mutual funds are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment (deemed distributions of participant loans) is recorded.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distributions and participant loans are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments, as they are paid through revenue sharing, rather than direct payment.

#### 3. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

The investments use the net asset value per share as determined by investment managers under the so called “practical expedient”. The practical expedient allows net asset value per share to represent fair value for reporting purposes when the criteria for using this method are met. These investment funds are held as units or interest in institutional funds or limited partnerships, which are stated at net asset value (NAV) or its equivalent. The NAV is used as a practical expedient to estimate the fair value, unless it is probable that all or a portion of the investment will be sold for an amount different than NAV.

**Transfer between levels:** For the years ended December 31, 2024 and 2023, there were no significant transfers between levels 1 and 2 and no transfers in or out of level 3.

### 5. RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Empower Retirement, LLC. Empower Retirement, LLC is the Plan custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. As described in Note 2, the Plan paid administrative expenses to the custodian and third party administrator of \$10,052 for the year ended December 31, 2024, which were not covered by revenue sharing.

### 6. ROLLOVER CONTRIBUTIONS

The participants' account rollovers for the year ended December 31, 2024 are from employees who rolled their balances from previous employers into the Plan. There were no participants' account rollovers in the Plan for the year ended December 31, 2024.

### 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

### 8. TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2008, that the Plan and related trust was designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **9. CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained and derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America, the custodians of the Plan.

#### **10. SUBSEQUENT EVENTS**

The Plan has evaluated events and transactions subsequent to December 31, 2024 through October 8, 2025, the date these financial statements were available to be issued. Based on the definitions and requirements of accounting principles generally accepted in the United States of America, management has not identified any events that have occurred subsequent to December 31, 2024 through October 8, 2025, that require recognition or disclosure in the financial statements.
