As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, qualified institution, as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

Note A – Description of Plan

The following description of Ezra Medical Center 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The plan is a defined contribution retirement plan established under Section 403(b) of the Internal Revenue Code (the "IRC") covering all eligible employees of L'Refuah Medical & Rehabilitation Center, Inc. dba Ezra Medical Center (the "Company"). Employees become eligible to make salary deferral contributions to the plan immediately following their date of hire. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors is responsible for oversight of the plan. The Investment Committee determines the appropriateness of the plan's investment offerings, monitors investment performance and reports to the Board of Directors.

Contributions. Each year, participants may make salary deferral contributions to the plan up to 100% of their pre-tax annual compensation, as defined in the plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans. Roth contributions are also permitted. Participants direct the investment of their contributions into various investment options offered by the plan.

The company also makes matching contributions to the plan equal to 100% of employees' salary deferral contributions up to the first 4% of employees' eligible compensation, as defined. Only employees designated as highly compensated non-medical providers are eligible for the matching contributions. Eligible participants must have obtained 21 years of age and completed at least one year of service with the company to receive the matching contributions.

Participants direct the investment of company contributions. All contributions are subject to certain IRS limitations.

Participant Accounts. Each participant's account is credited with the participant's contributions and company matching contributions, as well as an allocation of plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the company's matching contributions portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Vesting in the company's discretionary profit-sharing contributions is based on credited years of service, as defined by the plan, according to the following schedule:

Notes Receivable from Participants. Effective June 1, 2023, participants may borrow a minimum of \$1,000 and the maximum of the lesser of one-half of the vested account balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior 12-month period. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate equal to the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits. On termination of service for any reason, participants will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from a participant's vested account balance may also be made upon reaching age 59½, in accordance with the provisions specified by the plan. Participants may request a distribution from the rollover contribution portion of their account at any time.

Forfeited Accounts. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,494 and \$3, respectively. Forfeited nonvested accounts may be used to reduce future company contributions or to pay plan administrative expenses.

Note B – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the plan are paid by the plan, unless otherwise paid by the company. Expenses that are paid by the company are excluded from these financial statements. Fees related to participant recordkeeping on an asset-based investment management fee are charged directly to the participant's account and are included in administrative expenses. Indirect investment-related expenses are included in the net depreciation in fair value of investments.

Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the trustee of the Plan).

Note D – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Insurance co. general accounts: The Principal Guaranteed Option is reported at contract value. Contract value represents the amount participants would receive if they were to initiate a transaction under the terms of the ongoing plan. Interest is credited daily at an interest rate not less than the guaranteed minimum interest rate, as shown on the contract. The interest crediting rate is declared on a semi-annual basis. The contract amount maintained in the account is guaranteed against loss of principal, minus all withdrawals, including charges and adjustments. The guarantee is based on Principal's ability to meet its financial obligations from general assets.

Mutual funds: Valued at quoted market prices in active markets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note E – Principal Guaranteed Option

The Plan invests in the Principal Guaranteed Option (“PGO”), a benefit-responsive group annuity contract issued by Principal Life Insurance Company (“PLIC”) and held in custody by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. The contract provides for stable, competitive interest rates based on current market conditions through investments in fixed income securities of short to intermediate duration held in PLIC’s general account.

The PGO provides fully benefit-responsive features and is recorded at contract value, which approximates fair value, as reported to the Plan by the custodian. Contract value represents contributions made under the contract, plus interest credited, less participant withdrawals and administrative expenses. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Plan participants may withdraw all or a portion of their balances without fees or restrictions for “benefit-responsive events,” including termination of employment, retirement, death, or disability. Participant-directed transactions not resulting from a benefit-responsive event may be subject to restrictions and/or discontinuation charges, as defined in the contract.

The methodology for calculating the interest crediting rate is defined in the contract under the term “Composite Crediting Rate.” Under the terms of the existing contract, the crediting rate is reset on a semiannual basis, subject to a minimum guaranteed interest rate. The net crediting rate is the rate actually credited to participants’ balances, after any applicable fees.

Because the PGO is a single group annuity contract with a fixed rate of interest, the average yield earned by the Plan is the yield earned (i.e., interest credited) on the contract itself, rather than being derived from a portfolio of underlying assets as would be the case with a stable value fund.

At December 31, 2024 (and 2023), the contract value approximated fair value.

The net composite crediting rate history for the contract is as follows:

By definition, the Principal Guaranteed Option (“PGO”) group annuity contract is an insurance contract. Accordingly, the Plan may transact according to the terms defined in the contract at any time. The provisions governing deposits, fees, benefits, payments, and limitations are specified in Article II (Deposits and Ownership – Vintages), Article III (Fees), Article IV (Benefits and Other Payments), and Article V (Limitations; Termination) of the contract.

Plan management should assess the probability of events occurring that could limit the Plan’s ability to transact with participants at contract value.

Article V of the contract defines the circumstances under which the Plan may terminate its interest in the contract, including any associated limitations or charges.

In addition, while PLIC may cease to accept new deposits under Article II, Section 4, any termination of the contract remains subject to the provisions of Article V.

Note F – Related Party and Party in Interest Transactions

Certain plan investments are managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the plan's trustee and custodian, and therefore, these transactions qualify as party-in-interest transactions. Direct expenses paid from plan assets to Principal amounted to \$39,082 for the year ended December 31, 2024. Indirect fees incurred by the plan for investment management services are included in the net appreciation (depreciation) in fair value of investments. The plan sponsor pays directly any other fees related to the plan's operations.

Note G – Plan Termination

Although it has not expressed any intent to do so, the company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note H – Plan Amendments

Effective January 1, 2023, the plan was restated to eliminate safe harbor contributions. The plan was also restated to exclude compensation earned before participation in the plan and bonus pay from eligible compensation for both elective deferrals and matching contribution. The company's matching contribution formula was also restated. Effective January 1, 2023, the Company's matching contribution formula is now discretionary and will be determined on an annual basis. In addition, as of June 1, 2023, Roth contributions are now permitted, as well as participant loans.

On August 2, 2023, the company made a decision to change the plan's service provider from PCS Retirement (AdvisorTrust, Inc.) to Principal. In connection with this change in service provider, assets of \$2,846,754 were transferred from AdvisorTrust, Inc. to Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company.

Note I – Tax Status

The Plan has been designed using a volume submitter 403(b) plan document that received an advisory letter dated March 31, 2017, in which the IRS stated that the volume submitter 403(b) plan document, as then designed, satisfied the applicable requirements of the IRC. The plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b).

Although it has been amended since receiving the determination letter and has never received a determination letter itself from the IRS, the plan administrator believes that the plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note J – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note K – ERISA Bond Requirement

The Employee Retirement Income Security Act of 1974 (ERISA) requires that every person who handles funds or other property of the Plan be bonded. The bond coverage is to be determined by the balance of the total plan assets and is required to be at least equal to the lesser of 10% of the plan's assets at the beginning of the plan year or \$500,000. At December 31, 2024, the Plan's sponsor maintained inadequate bond coverage in the amount of \$200,000. Subsequently, on July 11, 2025, the Plan Sponsor obtained adequate bond coverage by increasing their amount to \$500,000.

Note L – Subsequent Events

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.
