1. Description of the Plan

The following description of The Henry L. Stimson Center 403(b) DC Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Henry L. Stimson Center (the Organization) is the plan sponsor.

- A. General – The Plan is a defined contribution plan which is funded by tax sheltered annuity contracts and mutual funds and is intended to meet the requirements of Section 403(b)(1) of the Internal Revenue Code (IRC). The Plan was established effective April 1, 1991 to comply with the IRC and Employee Retirement Income Security Act of 1974 (ERISA). The Plan has established a group based plan with the Teachers Insurance and Annuity Association and College Retirement Equities Fund (TIAA and CREF) to hold plan assets. Employees who work 20 or more hours per week or who have completed 1,000 hours in any twelve-month period are eligible to participate in the Plan and receive employer matching contribution. The Plan is subject to the provisions of ERISA.
- B. Contributions – Each year, participants may contribute up to 100% of their eligible annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make contributions representing distributions from other qualified defined benefit or contribution plans. Participants direct their contributions and any employer contributions into various investment options offered by the Plan. The Plan currently offers a pooled separate account, fixed annuities and variable annuities. Participants may change their allocation of future contributions at any time. The Organization matches on 100% of eligible employees' first 5% of deferrals. Contributions are subject to certain limitations.
- C. Participant Accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contribution, (b) plan earnings (losses), and (c) charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. Vesting – Participants are vested immediately in their contributions and the Organization's contributions plus actual earnings thereon.

- E. Notes Receivables from Participants – Participants may borrow from their fund accounts based on their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates commensurate with the prevailing market rates. As of December 31, 2024, and 2023, there were no outstanding notes receivable from participants. See Note 7 for additional notes held by TIAA and CREF outside the plan.
- F. Payment of Benefits – Upon termination of employment, a participant may receive a single lump-sum payment, installments, or an annuity contract. Financial hardship distributions are not permitted. In-service withdrawals are also permitted for participants who have reached age 59 ½.

2. Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Organization determines the Plan's valuation policies utilizing information provided by the investment advisers and TIAA and CREF. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document. As of December 31, 2024 and 2023, there were no outstanding notes receivable from participants.

Excess Contributions Payable – As of December 31, 2024 and 2023, amounts payable to participants totaling \$254 and \$1,373, respectively, for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to contributions. The Plan sponsor is working with the trustee to make such distributions for the excess contributions.

Payment of Benefits – Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used when Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value, Level 3 inputs are only used if Level 1 or Level 2 inputs are not available.

Following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Fixed annuities: Valued at fair value by Plan management by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

Variable annuity contracts: The variable annuity contracts invest principally in equity securities, fixed income instruments, and short-term investments in accordance with each portfolio's investments objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments including matrix pricing. CREF Money Market Account holdings are generally valued at amortized cost. Each account determines its unit value each day. Account investments are primarily valued at the net asset value (NAV) per share based on quoted market prices of the underlying investments.

Pooled separate account. The Real Estate Account's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. These appraisals are then updated daily based on changes in factors such as occupancy levels, lease rates, overall market conditions, and capital improvements. Determination of estimated fair value involves subjective judgment because the actual fair value of real estate can be determined only by negotiation between the parties in a sales transaction.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 at the end of the reporting period. For the year ended December 31, 2024, there were no significant transfers between Level 1 and Level 2 and no transfers into or out of Level 3. Certain amounts in the fair value hierarchy table as of December 31, 2023 were reclassified to conform with the December 31, 2024 presentation.

5. Investments Contracts with TIAA and CREF

The Plan has a non-benefit-responsive guaranteed investment contract with TIAA and CREF. TIAA and CREF maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

6. Related Party and Party-In-Interest Transactions

Plan investments are managed by TIAA and CREF. TIAA and CREF are the trustees and recordkeeper as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. As described in Note 2, the Organization pays certain expenses related to plan operations. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA. All of these parties-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

7. Tax Status

The Plan adopted a pre-approved plan document that has received a favorable opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The Plan is subjected to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Nonexempt Transactions

During 2024, there were certain pay periods where employee withholdings totaling \$154,683 were not remitted timely to the Plan by the Company. The Company is planning to make a contribution representing lost earnings to the Plan associated with the untimely remittances.

10. Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.
