Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Vitria Technology, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Vitria Technology, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

A. General

The Plan is a defined contribution plan that was established in 1996 by Vitria Technology, Inc. (the “Company”) to provide benefits to eligible employees as defined in the Plan document. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

B. Administration and Expenses

An Administrative Committee (the “Committee”) manages the operation and administration of the Plan. The Committee designated Fidelity Management Trust Company (“Fidelity”) to serve as trustee and to provide record keeping and administrative services. Investment fund management fees and operating expenses are charged directly to the investment funds and are thereby factored into each investment fund as a reduction of investment return. Certain fees including withdrawal and participant loan administration fees are charged directly to participants. Other costs of administering the Plan may be paid by the Plan or the Company at the discretion of the Committee.

C. Eligibility

Substantially all regular employees of the Company who are age 21 or older are eligible to participate in the Plan. There is no service requirement. Eligible employees may enter the Plan immediately.

D. Contributions

Participants may elect to have the Company contribute their eligible pre-tax compensation up to the amount allowable under the Plan document and current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Newly hired participants who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled at a pre-tax deferral rate of 6% of compensation. The deferral rate of auto-enrolled participants will increase 1% annually, following the year of auto-enrollment to a maximum deferral percentage of 10% of eligible compensation. Participants age 50 or older are permitted to make catch-up contributions subject to applicable Code limits.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans and individual retirement accounts (IRAs). Such contributions are deposited in the appropriate investment funds in accordance with participant investment directions.

The Company is allowed to make discretionary matching contributions as defined in the Plan and as approved by the Board of Directors. No matching contributions were made for the Plan years ended December 31, 2024 and 2023, respectively.

E. Participant Accounts and Allocations of Earnings

Each participant's account is credited with the participant's contributions, rollover contributions, Company matching contributions, if any, and an allocation of Plan earnings or losses and expenses. Plan assets are invested based solely on instructions received from participants.

The accounts of participants who decline to make an investment election are invested in the Fidelity Advisors Freedom Fund appropriate for an individual's age and projected date of retirement.

F. Vesting and Forfeitures

Participants are immediately 100% vested in their contributions and related earnings. A participant is 33.3% vested in Company contributions after one year of service, 66.6% vested after two years of service, and fully vested after three years of service. Forfeitures of terminated participants' non-vested accounts will be applied to reduce future Company contributions or to pay Plan administrative expenses. The balance of unapplied forfeitures was immaterial at December 31, 2024 and 2023.

G. Payment of Benefits

Normal retirement age under the Plan is age 60 years old. Upon termination of service, death, disability, or retirement, a participant or beneficiary may maintain his or her account in the Plan or choose to receive benefits in a lump sum or partial withdrawal of his or her vested account balance. Hardship distributions are permitted under limited circumstances as provided in the Plan.

H. Note Receivable from Participant

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance bears interest at a fixed rate based on available market financing rates at loan inception and must be repaid to the Plan within a five-year period, unless a loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended up to ten years. Principal and interest are paid ratably through payroll deductions. The note receivable from a participant at December 31, 2024 carries an interest rate of 5.75% with a maturity date of March 2025. Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Investment Valuation and Income Recognition

Mutual fund investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

B. Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

C. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

D. Risks and Uncertainties

Plan investments are exposed to various investment risks such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and the amounts reported in the financial statements.

NOTE 3 - TAX STATUS

The Company adopted a volume submitter plan that has received an opinion letter from the Internal Revenue Service stating that the form of the plan qualifies under applicable provisions of the Code. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by affiliates of the trustee. Purchases and sales of these funds and payment of direct and indirect investment management and administrative expenses by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest, and dividends for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee.

NOTE 7 - FAIR VALUE MEASUREMENTS

Accounting guidance on measuring fair value establishes a hierarchy which prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued based upon closing market prices for the shares held by the Plan at year end. Although the plan administrator believes this valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date.

NOTE 8 - COMMON/COLLECTIVE TRUST

The Fidelity Advisors Stable Value III Fund is a common/collective trust that seeks to offer a higher yield than money market instruments while providing safety of principal and invests primarily in guaranteed investment contracts issued by insurance companies and banks. Fidelity is contractually obligated to repay principal and a specified interest rate to the Plan. Because the fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to this fund.

Premature cancellation of the contract by the Plan is subject to restrictions and may result in market value adjustments and/or redemption charges. The plan administrator does not believe that any events limiting the Plan’s ability to transact at contract value are probable of occurring. The crediting interest rate of the fund is based on a formula. The average yield of the fund was 2.15% and 1.83% for the 2024 and 2023 plan years, respectively.

Certain fees including withdrawal and participant loan administration fees are charged directly to participants. Other costs of administering the Plan may be paid by the Plan or the Company at the discretion of the Committee.

C. Eligibility

Substantially all regular employees of the Company who are age 21 or older are eligible to participate in the Plan. There is no service requirement. Eligible employees may enter the Plan immediately.

D. Contributions

Participants may elect to have the Company contribute their eligible pre-tax compensation up to the amount allowable under the Plan document and current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Newly hired participants who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled at a pre-tax deferral rate of 6% of compensation. The deferral rate of auto-enrolled participants will increase 1% annually, following the year of auto-enrollment to a maximum deferral percentage of 10% of eligible compensation. Participants age 50 or older are permitted to make catch-up contributions subject to applicable Code limits.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans and individual retirement accounts (IRAs). Such contributions are deposited in the appropriate investment funds in accordance with participant investment directions.

The Company is allowed to make discretionary matching contributions as defined in the Plan and as approved by the Board of Directors. No matching contributions were made for the Plan years ended December 31, 2024 and 2023, respectively.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

E. Participant Accounts and Allocations of Earnings

Each participant's account is credited with the participant's contributions, rollover contributions, Company matching contributions, if any, and an allocation of Plan earnings or losses and expenses. Plan assets are invested based solely on instructions received from participants.

The accounts of participants who decline to make an investment election are invested in the Fidelity Advisors Freedom Fund appropriate for an individual's age and projected date of retirement.

F. Vesting and Forfeitures

Participants are immediately 100% vested in their contributions and related earnings. A participant is 33.3% vested in Company contributions after one year of service, 66.6% vested after two years of service, and fully vested after three years of service. Forfeitures of terminated participants' non-vested accounts will be applied to reduce future Company contributions or to pay Plan administrative expenses. The balance of unapplied forfeitures was immaterial at December 31, 2024 and 2023.

G. Payment of Benefits

Normal retirement age under the Plan is age 60 years old. Upon termination of service, death, disability, or retirement, a participant or beneficiary may maintain his or her account in the Plan or choose to receive benefits in a lump sum or partial withdrawal of his or her vested account balance. Hardship distributions are permitted under limited circumstances as provided in the Plan.

H. Note Receivable from Participant

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance bears interest at a fixed rate based on available market financing rates at loan inception and must be repaid to the Plan within a five-year period, unless a loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended up to ten years. Principal and interest are paid ratably through payroll deductions. The note receivable from a participant at December 31, 2024 carries an interest rate of 5.75% with a maturity date of March 2025. Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Investment Valuation and Income Recognition

Mutual fund investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

B. Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

C. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

D. Risks and Uncertainties

Plan investments are exposed to various investment risks such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and the amounts reported in the financial statements.

NOTE 3 - TAX STATUS

The Company adopted a volume submitter plan that has received an opinion letter from the Internal Revenue Service stating that the form of the plan qualifies under applicable provisions of the Code. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by affiliates of the trustee. Purchases and sales of these funds and payment of direct and indirect investment management and administrative expenses by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest, and dividends for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee.

NOTE 7 - FAIR VALUE MEASUREMENTS

Accounting guidance on measuring fair value establishes a hierarchy which prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued based upon closing market prices for the shares held by the Plan at year end. Although the plan administrator believes this valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date.

NOTE 8 - COMMON/COLLECTIVE TRUST

The Fidelity Advisors Stable Value III Fund is a common/collective trust that seeks to offer a higher yield than money market instruments while providing safety of principal and invests primarily in guaranteed investment contracts issued by insurance companies and banks. Fidelity is contractually obligated to repay principal and a specified interest rate to the Plan. Because the fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to this fund.

Premature cancellation of the contract by the Plan is subject to restrictions and may result in market value adjustments and/or redemption charges. The plan administrator does not believe that any events limiting the Plan’s ability to transact at contract value are probable of occurring. The crediting interest rate of the fund is based on a formula. The average yield of the fund was 2.15% and 1.83% for the 2024 and 2023 plan years, respectively.
