Note 1. Description of the Plan

The following description of the Wiley Metal Fabricating, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description*, which are available from the Plan Administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan sponsored by Wiley Metal Fabricating, Inc. (Company) for the benefit of its employees who have six months of service and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). ADP Retirement Services performs recordkeeping services and Reliance Trust Company is the Plan's trustee. The Plan Document was restated effective January 1, 2022 to comply with the IRS required Cycle 3 restatement.

Contributions

The Plan permits eligible employees through a salary deferral election to make annual contributions of 1% to 25% of eligible compensation up to the maximum allowed by law. Employee rollover contributions are also permitted. Company matching contributions and profit-sharing contributions are discretionary as determined by the Company's Board of Directors. During 2024 and 2023, the Board of Directors approved a discretionary matching contribution of 50% of employee deferrals, inclusive of catch-contributions, up to 4% of compensation. Effective July 1, 2024, this matching contribution was amended to 100% of the first 3% of compensation, inclusive of catch-up contributions. The Company made no profit-sharing contributions during 2023 or 2024. Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 4% of eligible compensation unless the participant made an affirmative election otherwise.

Participant Accounts

Each participant's account is credited with the participant's contribution, and allocation of the Company's contribution, Plan earnings and forfeitures of terminated participant's nonvested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and their rollovers plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of credited service. A participant is fully vested after six years of credited service. The nonvested balance is forfeited upon termination of service.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum amount, installments equal to the value of his account or to defer his balance if it is greater than \$5,000. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan.

Forfeited Accounts

Forfeitures can be used to pay administrative expenses of the Plan and are then to be allocated among active participants based upon compensation. At December 31, 2024 and 2023, the combined balance of forfeited accounts was \$12,447 and \$10,274, respectively. During 2024 and 2023, there were no forfeitures used to pay administrative expenses of the Plan and no forfeitures were allocated among active participants.

Notes Receivable From Participants

The Plan agreement includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant and only one loan can be outstanding at any given time. The minimum amount of a loan is \$500. The maximum amount of a loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the voluntary savings and vested portion of Company contributions. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a primary residence) through payroll withholdings or periodic payments. Interest on the loan is based on the prime rate plus 1%.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in the net assets available for benefits at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

The Plan's interest in the collective investment trust is valued at the net asset value per share utilizing the practical expedient.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan Document.

Plan Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust custodial document sponsored by ADP, LLC. This prototype plan document has been filed with the appropriate agency. The Plan had not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the prototype document had a favorable opinion letter from the IRS. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the trustee and pays administrative fees to the recordkeeper. Fees paid by the Plan for recordkeeping services amounted to \$2,773 and \$3,177 for the years ended December 31, 2024 and 2023, respectively. The Company paid \$16,523 and \$14,828 for investment advisory fees for the years ended December 31, 2024 and 2023, respectively.

The Plan maintains an ERISA Budget account separate from the Plan. Credits to this account of \$16,523 and \$14,828 were used to pay investment advisory fees during the years ended December 31, 2024 and 2023, respectively. There were no unused credits as of December 31, 2024 or 2023.

The Company also pays certain administrative costs on behalf of the Plan and provides certain administrative functions at no cost to the Plan.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 7. Reconciliation of Financial Statements to Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan (Form 5500) filed with the IRS and the accompanying financial statements include reporting excess contributions payable as a liability and a reduction to contributions in the financial statements.

Note 8. Subsequent Events

Subsequent events have been evaluated through September 19, 2025, which is the date the financial statements were available to be issued.
